

## HOUSE AMENDMENTS TO HOUSE BILL 2276

- 1 On page 1 of the printed bill, line 3, after “411.105,” insert “411.111.”
- 2 On page 2, line 1, delete “bodily” and insert “physical or mental”.
- 3 In line 5, delete “bodily” and insert “physical or mental”.
- 4 In line 6, delete “bodily” and insert “physical or mental”.
- 5 In line 22, after “Program” delete the rest of the line and line 23 and insert “shall.”
- 6 In line 27, delete “department” and insert “program”.
- 7 In line 30, delete the first “department” and insert “program” and after the second  
8 “department” insert “of Human Services”.
- 9 In line 42, before the semicolon insert “granted under ORS 418.035 to 418.125”.
- 10 In line 43, before the semicolon insert “granted under ORS 411.710 to 411.730”.
- 11 In line 45, delete “and”.
- 12 After line 45, insert:
- 13 “(e) General assistance other than general assistance granted under ORS 411.710 to 411.730;  
14 and”.
- 15 On page 3, line 1, delete “(e)” and insert “(f)”.
- 16 In line 21, delete “paid under” and insert “granted for” and after “assistance” insert “under ORS  
17 411.710 to 411.730”.
- 18 In line 35, after “(1)” insert “General”.
- 19 In line 40, after “families” insert “granted under ORS 418.035 to 418.125”.
- 20 After line 45, insert:
- 21 “(4) General assistance granted under ORS 411.710 to 411.730.”
- 22 On page 4, line 4, delete “(4)” and insert “(5)”.
- 23 In line 5, delete “(5)” and insert “(6)”.
- 24 In line 8, delete “(6)” and insert “(7)”.
- 25 In line 10, delete “(7)” and insert “(8)”.
- 26 On page 5, line 33, after “families” insert “granted under ORS 418.035 to 418.125”.
- 27 On page 14, line 43, delete “poor” and insert “needy”.
- 28 On page 17, after line 35, insert:
- 29 “**SECTION 29.** ORS 411.111 is amended to read:
- 30 “411.111. (1) *[For the purpose of eliminating from the public assistance rolls all persons for any*  
31 *reason not entitled to the benefits being granted, any application for or grant of public assistance is*  
32 *subject to investigation, certification, review and reconsideration from time to time and as frequently*  
33 *as is required by the rules and regulations of the Department of Human Services, and is subject to*  
34 *change or cancellation when the circumstances are not verified or have changed sufficiently to warrant*  
35 *such action; and for this purpose the department may employ and fix the compensation of such persons*

1 *as it finds necessary and advisable.]* **The Department of Human Services may reconsider a grant**  
2 **of general assistance or a grant of public assistance only for the following purposes:**

3 **“(a) To correct an inadvertent clerical or mathematical error made when determining a**  
4 **grant of general assistance or a grant of public assistance;**

5 **“(b) To correct misinformation provided to an applicant or recipient by the department;**

6 **“(c) To consider facts not previously known to the department;**

7 **“(d) To correct errors caused by a misapplication of the law by the department;**

8 **“(e) To consider substantive changes in the applicable law; or**

9 **“(f) To consider a change in circumstances that directly affects the eligibility of a recip-**  
10 **ient of general assistance or public assistance.**

11 **“(2) A recipient of general assistance or public assistance may request reconsideration**  
12 **of a grant of general assistance or a grant of public assistance for the purposes described in**  
13 **subsection (1) of this section.**

14 **“(3) If the department reduces, suspends or terminates a grant of general assistance or**  
15 **a grant of public assistance after reconsideration under subsection (1) of this section, the**  
16 **department shall provide an opportunity for a hearing under ORS chapter 183.**

17 **“(4) Notwithstanding subsection (1) of this section, the department may conduct periodic**  
18 **redeterminations of eligibility of recipients of grants of general assistance or grants of public**  
19 **assistance and participate in audits and other review activities as required by state or federal**  
20 **law.”.**

21 In line 36, delete “29” and insert “30”.
