

HOUSE AMENDMENTS TO HOUSE BILL 3184

1 On page 1 of the printed bill, line 2, after the first semicolon delete the rest of the line and line
2 3 and insert “amending ORS 334.185; and declaring an emergency.”.

3 Delete lines 5 through 30 and delete pages 2 through 5 and insert:

4 “**SECTION 1.** ORS 334.185 is amended to read:

5 “334.185. (1) [*Facilities and services authorized under ORS 334.175 (1) may be provided to com-*
6 *ponent school districts which are not a part of the education service district or districts by agreement*
7 *on a reimbursable basis. However, the pupils residing in such districts shall not be included in the*
8 *computation of the percentage required by ORS 334.175 (2)(a). The facilities and services may also be*
9 *provided to other public or private entities by agreement or on a reimbursable basis.] **An education***

10 **service district may provide entrepreneurial services and facilities to public and private en-**
11 **tities and to school districts that are not component school districts of the education service**
12 **district if the services and facilities are approved each year through the resolution process**
13 **described in ORS 334.175.**

14 “(2) **The primary purpose of the entrepreneurial services and facilities is to address the**
15 **needs of component school districts. An education service district must submit**
16 **entrepreneurial services and facilities to component school districts for approval to ensure**
17 **that school districts receive information about the costs and benefits of providing services**
18 **and facilities, including identification of the funding source for the services and facilities and**
19 **an explanation of whether any moneys received from the State School Fund or local revenues**
20 **of the education service district, as defined in ORS 327.019, may be required to finance the**
21 **services or facilities.**

22 “(3) **Pupils residing in school districts that are not component school districts of an ed-**
23 **ucation service district but that receive entrepreneurial services or use facilities under this**
24 **section may not be included in the computation of the percentage required by ORS 334.175**
25 **(2)(a).**

26 “[2] (4) **Entrepreneurial services and facilities may be provided under contract or on a**
27 **reimbursable basis.** Expenditures by the education service district board for [*special*]
28 **entrepreneurial** services and facilities provided on a reimbursable basis under this section shall be
29 limited to the moneys received for the purpose specified and are not subject to the Local Budget
30 Law (ORS 294.305 to 294.565).

31 “[3] (5) Budget estimates of expenditures for [*special*] **entrepreneurial** services and facilities
32 provided under this section must show the estimates of moneys receivable and must be shown as
33 offsetting revenue items.

34 “**SECTION 2. This 2005 Act being necessary for the immediate preservation of the public**
35 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**

1 **July 1, 2005.”**
