SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Increases maximum amount of civil penalty for violation of law prohibiting conversion of excess political campaign funds to personal use to [*\$750*] **\$1,000** plus amount converted to personal use. Requires that civil penalty be paid from personal funds of person against whom penalty is assessed.

Requires political committee to establish exclusive campaign account in financial institution. Directs committee to make all expenditures, with specified exceptions, through account. Directs treasurer to deposit all contributions in account. Prohibits deposit of other moneys in account. Requires committee to maintain account in name of committee. Requires committee to specify location and name of account in statement of organization.

Directs existing political committee to establish account and amend statement of organization not later than [*September 30, 2005*] **January 1, 2006**.

Directs Secretary of State to conduct reviews of contribution and expenditure statements filed with secretary.

[*Requires candidates and political committees to file copies of financial institution account statements with political contribution and expenditure statements. Sets operative date for filing requirement.*]

[*Requires candidates and political committees to report business name and location of payees of expenditures made by candidate or committee.*]

Increases amount of political contribution for which details about contributor must be reported from \$50 to \$100.

Increases amount of political expenditure for which details about expenditure must be reported to \$100. Requires reporting of business name and location of certain payees.

Prohibits candidate or candidate's principal campaign committee from making payment to candidate from campaign funds in consideration for professional services performed by candidate.

[*Prohibits member of Legislative Assembly from using contributions for payment of certain expenses for which member is reimbursed by legislative compensation.*]

Directs all candidates and political committees to file electronic statements of contributions received and expenditures made with Secretary of State [*not later than seven calendar days after contribution is received or expenditure made*]. **Specifies reporting periods. Provides exemptions.** Directs secretary to make contribution and expenditure data available to public on Internet according to schedule adopted by secretary by rule.

Sets January 1, 2007, operative date for electronic filing provisions.

Modifies definition of "independent expenditure."

Authorizes cities and counties to adopt additional provisions regarding filing of political contribution and expenditure statements.

Directs Secretary of State to conduct testing or establish pilot project for electronic filing system.

Directs secretary to consider issues arising from transition to electronic filing system as mitigating circumstance in imposing civil penalties.

Declares emergency, effective on passage.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 260.995 is amended to read:

6 260.995. (1) Except as provided in subsection (2) of this section, following an investigation under
7 ORS 260.345, the Secretary of State or Attorney General may impose a civil penalty not to exceed
8 \$250 for each violation of any provision of Oregon Revised Statutes relating to the conduct of any
9 election, any rule adopted by the secretary [*of State*] under ORS chapters 246 to 260 or any other
10 matter preliminary to or relating to an election, for which no penalty is otherwise provided.

11 (2) The secretary [*of State*] or the Attorney General may impose a civil penalty not to exceed:

12 (a) \$1,000 for each violation of ORS 251.049 (3) or 251.405 (3); **or**

13 **(b) \$1,000 plus the amount converted to personal use for each violation of ORS 260.407.**

14 (3) Except as otherwise provided by this section, civil penalties under this section shall be im-
15 posed as provided in ORS 183.745. In addition to the requirements of ORS 183.745, the notice shall
16 include:

17 (a) A statement of the authority and jurisdiction under which the hearing is to be held; and

18 (b) If the person is an agency, corporation or an unincorporated association, a statement that
19 such person must be represented by an attorney licensed in Oregon, unless the person is a political
20 committee which may be represented by any officer identified in the most recent statement of or-
21 ganization filed with the filing officer.

22 (4) A hearing on whether to impose a civil penalty and to consider circumstances in mitigation
23 shall be held by the secretary [*of State*] or Attorney General:

24 (a) Upon request of the person against whom the penalty may be assessed, if the request is made
25 not later than the 20th day after the date the person received notice sent under subsection (3) of
26 this section; or

27 (b) Upon the [*Secretary of State's*] **secretary's** or Attorney General's own motion.

28 (5) The person against whom a penalty may be assessed need not appear in person at a hearing
29 held under this section, but instead may submit written testimony [*and*] **or** other evidence, sworn
30 to before a notary public, to the secretary [*of State*] or Attorney General for entry in the hearing
31 record. [*Such documents*] **The testimony or other evidence** must be received by the secretary [*of*
32 *State*] or Attorney General not later than three business days before the day of the hearing.

33 (6) All hearings under this section shall be held not later than 30 days after the deadline for the
34 person against whom the penalty may be assessed to request a hearing. However, if requested by
35 the person against whom the penalty may be assessed, a hearing under subsection (4) of this section
36 shall be held not later than 45 days after the deadline for the person against whom the penalty may
37 be assessed to request a hearing.

38 (7) The secretary [*of State*] or Attorney General shall issue an order not later than 90 days after
39 a hearing or after the deadline for requesting a hearing if no hearing is held.

40 (8) Except as provided in this subsection, all penalties recovered under this section shall be paid
41 into the State Treasury and credited to the General Fund. A penalty that is recovered from a person
42 who violated ORS 260.432 (1) or from a public employee who violated ORS 260.432 (2) shall be
43 remitted as follows:

44 (a) If the public employee involved is an employee of the state or any of its agencies or insti-
45 tutions, the penalty shall be paid into the State Treasury and credited to the General Fund.

1 (b) If the public employee involved is an employee of a city, county or other political subdivision,
2 the penalty shall be paid to the city, county or other political subdivision.

3 **(9) In the case of a civil penalty imposed under this section for a violation of ORS 260.407,
4 the person against whom the penalty is assessed:**

5 **(a) Is personally responsible for the payment of the civil penalty;**

6 **(b) Shall pay the civil penalty from personal funds of the person; and**

7 **(c) May not pay the civil penalty from contributions received by a candidate or the
8 principal campaign committee of a candidate.**

9 **SECTION 2.** Section 3 of this 2005 Act is added to and made a part of ORS 260.035 to
10 **260.156.**

11 **SECTION 3.** (1) Each political committee shall establish a single exclusive campaign ac-
12 count in a financial institution, as defined in ORS 706.008. The financial institution must be
13 located in this state and must ordinarily conduct business with the general public in this
14 state.

15 **(2) A political committee shall maintain the campaign account in the financial institution
16 in the name of the political committee. For purposes of this subsection, acronyms may not
17 be used in the name of the political committee.**

18 **(3) Except as provided in subsection (4) of this section, all expenditures made by the
19 political committee shall be drawn from the campaign account and:**

20 **(a) Issued on a check signed by the candidate on whose behalf the account is established
21 or by the treasurer of the political committee; or**

22 **(b) Paid using a debit card or other form of electronic transaction.**

23 **(4) Subsection (3) of this section does not prohibit a person from making a cash or other
24 expenditure on behalf of the political committee and receiving reimbursement from the
25 campaign account.**

26 **(5) A contribution received by a candidate or the treasurer of a political committee, di-
27 rectly or indirectly, shall be deposited into the campaign account not later than seven cal-
28 endar days after the date the contribution is received. This subsection does not apply to
29 in-kind contributions received by a candidate or political committee.**

30 **(6) This section does not prohibit the transfer of any amount deposited in the campaign
31 account into a certificate of deposit, stock fund or other investment instrument.**

32 **(7) The campaign account may not include any private moneys, other than contributions
33 received by the political committee.**

34 **(8) A political committee shall retain a copy of each financial institution account state-
35 ment from the campaign account described in this section for not less than two years after
36 the date the statement is issued by the financial institution.**

37 **(9) Subsections (1) to (8) of this section do not apply to candidates described in ORS
38 260.043.**

39 **SECTION 4.** ORS 260.039 is amended to read:

40 260.039. (1) Except as provided in ORS 260.043, a candidate who serves as the candidate's own
41 treasurer, or the treasurer of the principal campaign committee, shall file a statement of organiza-
42 tion with the [appropriate] filing officer. The statement shall include:

43 **(a) The name, address, occupation, office sought and party affiliation of the candidate. The ad-
44 dress shall be the address of a residence, office, headquarters or similar location where the candi-
45 date may be conveniently located. However, a different address may be used if the candidate first**

1 files with the filing officer the candidate's residence address and the address proposed to be used;

2 (b) A statement of how the candidate or principal campaign committee intends to solicit funds;
3 [and]

4 (c) In the case of a principal campaign committee:

5 (A) The name and address of the committee. The address shall be the address of a residence,
6 office, headquarters or similar location where the political committee or a responsible officer of the
7 political committee may be conveniently located. However, a different address may be used if the
8 officer first files with the filing officer the officer's residence address and the address proposed to
9 be used.

10 (B) The name, address and occupation of the committee director or directors, if any.

11 (C) The name and address of the committee treasurer.

12 (D) The name and address of any other political committee of which two or more committee
13 directors are also directors of the committee filing the statement.

14 (E) A statement of whether the committee presently intends to remain in existence for more
15 than one year; and

16 **(d) The name of the financial institution in which the campaign account required under**
17 **section 3 of this 2005 Act is established, the name and number of the account, the name of**
18 **the account holder and the names of all persons who have signature authority for the ac-**
19 **count. The Secretary of State may not disclose information received by the secretary under**
20 **this paragraph except as necessary for purposes of enforcing the provisions of ORS chapters**
21 **246 to 260.**

22 (2) Except as provided in ORS 260.043, a candidate who serves as the candidate's own treasurer
23 shall file the statement of organization not later than the third business day after the candidate first
24 receives a contribution or makes an expenditure. The treasurer of a principal campaign committee
25 shall file the statement of organization not later than the date specified in ORS 260.035.

26 (3) Any change in information submitted in a statement of organization under subsection (1) of
27 this section shall be indicated in an amended statement of organization filed not later than the 10th
28 day after the change in information.

29 (4) Except as provided in ORS 260.043, a candidate who serves as the candidate's own treasurer
30 or the treasurer of the principal campaign committee of the candidate shall file a statement of or-
31 ganization under this section not later than the deadline for the candidate to file a nominating pe-
32 tition or declaration of candidacy under ORS 249.037 or a certificate of nomination under ORS
33 249.722.

34 (5) Except as provided in ORS 260.043, a candidate [for state office] who serves as the candidate's
35 own treasurer or the treasurer of the principal campaign committee of a candidate [for state office]
36 shall file a new or amended statement of organization not later than the date that the candidate files
37 a nominating petition, declaration of candidacy or certificate of nomination.

38 **SECTION 5.** ORS 260.042 is amended to read:

39 260.042. (1) The treasurer of a political committee shall file a statement of organization with the
40 [appropriate] filing officer. The statement shall include:

41 (a) The name, address and nature of the committee. The address shall be the address of a resi-
42 dence, office, headquarters or similar location where the political committee or a responsible officer
43 of the political committee may be conveniently located. However, a different address may be used
44 if the officer first files with the filing officer the officer's residence address and the address proposed
45 to be used.

1 (b) The name, address and occupation of the committee director or directors.

2 (c) The name and address of the committee treasurer.

3 (d) The name and address of any other political committee of which two or more committee di-
4 rectors are also directors of the committee filing the statement.

5 (e) A statement of whether the committee presently intends to remain in existence for more than
6 one year.

7 (f) The name, office sought, and party affiliation of each candidate whom the committee is sup-
8 porting or specifically opposing or intends to support or specifically oppose, when known, or, if the
9 committee is supporting or specifically opposing all the candidates of a given party, the name of that
10 party.

11 (g) A designation of any measure [*which*] **that** the committee is opposing or supporting, or in-
12 tends to support or oppose.

13 (h) A statement of how the committee intends to solicit funds.

14 (i) **The name of the financial institution in which the campaign account required under**
15 **section 3 of this 2005 Act is established, the name and number of the account, the name of**
16 **the account holder and the names of all persons who have signature authority for the ac-**
17 **count. The Secretary of State may not disclose information received by the secretary under**
18 **this paragraph except as necessary for purposes of enforcing the provisions of ORS chapters**
19 **246 to 260.**

20 (j) **A statement of whether the committee is a controlled committee.**

21 (2) The statement of organization shall be filed not later than the date specified in ORS 260.035.

22 (3) Any change in information submitted in a statement of organization under subsection (1) of
23 this section shall be indicated in an amended statement of organization filed not later than the 10th
24 day after the change in information.

25 (4) This section does not apply to a political committee that is a principal campaign committee
26 or to a political committee exclusively supporting or opposing one or more candidates for federal
27 or political party office.

28 **SECTION 6.** ORS 260.043 is amended to read:

29 260.043. (1) A candidate[, *other than a candidate for federal office,*] who serves as the candidate's
30 own treasurer and who expects neither the aggregate contributions to be received nor the aggregate
31 expenditures to be made by or on behalf of the candidate to exceed \$300 in total amount during the
32 total period described in ORS 260.058 (1) or 260.068 (1) is not required to:

33 (a) File a statement of organization under ORS 260.039; **or**

34 (b) **Establish a single exclusive campaign account under section 3 of this 2005 Act.**

35 (2) A candidate described in subsection (1) of this section must keep contribution and expendi-
36 ture records during the applicable total period described in ORS 260.058 or 260.068.

37 (3) If at any time following the filing of a nominating petition, declaration of candidacy or cer-
38 tificate of nomination and during the total period described in ORS 260.058 (1) or 260.068 (1) either
39 the aggregate contributions or aggregate expenditures exceed \$300, the candidate[, *other than a*
40 *candidate for federal office,*] shall **do all of the following:**

42 (b) **Establish a single exclusive campaign account as required under section 3 of this 2005**
43 **Act.**

44 (4) **This section does not apply to candidates for federal office.**

1 260.200. The Secretary of State **by rule** shall:

2 (1) Prescribe a uniform system for accounts required by ORS 260.055.

3 (2) Prescribe forms for statements and other information required under this chapter to be filed
4 with filing officers, and furnish those forms to persons required to file those statements and other
5 information.

6 (3) **Prescribe materials, including financial institution account statements and copies of**
7 **checks, that a candidate or political committee must retain or provide to the secretary for**
8 **purposes of administering or enforcing the provisions of this chapter. The secretary shall**
9 **prescribe personal or confidential information that is not required to be disclosed under this**
10 **subsection.**

11 **SECTION 8.** ORS 260.083, as amended by section 14, chapter 542, Oregon Laws 2003, is
12 amended to read:

13 260.083. (1) A statement filed under ORS 260.058, 260.063, 260.068, 260.073, 260.076 or 260.118 or
14 section 6, chapter 542, Oregon Laws 2003, shall list:

15 (a) Under contributions, all contributions received. Except as provided in ORS 260.085, the
16 statement shall list:

17 (A) The name, occupation and address of each person, and the name and address of each poli-
18 tical committee, that contributed an aggregate amount of more than [~~\$50~~] **\$100** on behalf of a candi-
19 date or to a political committee and the total amount contributed by that person or political
20 committee[. *The statement may list as a single item*]; **and**

21 (B) The total amount of other contributions **as a single item**, but shall specify how those con-
22 tributions were obtained.

23 (b) Under expenditures, all expenditures made[, *showing the name of the payee and the amount*
24 *and purpose of each*]. **The statement shall list:**

25 (A) **The amount and purpose of each expenditure made in an aggregate amount of more**
26 **than \$100 to a payee, the name or, if applicable, the business name of the payee of the ex-**
27 **penditure, and the city, or county if the payee is not located in a city, and state in which the**
28 **payee is located; and**

29 (B) **The total amount of other expenditures as a single item.**

30 [*c Separately, all contributions made by the candidate or political committee.*]

31 [*d*] (c) All loans, whether repaid or not, made **by or** to the candidate or political committee.
32 The statement shall list:

33 (A) The name and address of each person shown as a cosigner or guarantor on a loan and the
34 amount of the obligation undertaken by each cosigner or guarantor[. *The statement also shall list*];

35 (B) The name of the lender holding the loan; **and**

36 (C) **The terms of the loan, including the interest rate and repayment schedule.**

37 (2) If an expenditure in an amount exceeding [~~\$50~~] **\$100** is a prepayment or a deposit made in
38 consideration for any services, supplies, equipment or other thing of value to be performed or fur-
39 nished at a future date, that portion of the deposit that has been expended during the reporting
40 period shall be listed as an expenditure and the unexpended portion of the deposit shall be listed
41 as an account receivable.

42 (3) Anything of value paid for or contributed by any person shall be listed as both an in-kind
43 contribution and an expenditure by the candidate or committee for whose benefit the payment or
44 contribution was made.

45 (4) If a candidate, political committee or chief petitioner under ORS 260.118 makes an expendi-

1 ture that must be reported as an in-kind contribution and an expenditure as provided in subsection
2 (3) of this section, the candidate, [or] political committee **or chief petitioner** making the original
3 expenditure shall, in any statement filed under ORS 260.058, 260.063, 260.068, 260.073 or 260.118 or
4 section 6, chapter 542, Oregon Laws 2003, identify the expenditure as an in-kind contribution and
5 identify the candidate or political committee for whose benefit the expenditure was made.

6 (5) [Except as provided in subsection (8) of this section,] Expenditures made by an agent of a
7 candidate or political committee on behalf of the candidate or committee shall be reported in the
8 same manner as if the expenditures had been made by the candidate or political committee.

9 (6) If a political committee makes an expenditure that qualifies as an independent expenditure
10 under ORS 260.005 [(8)] (9), the listing of the expenditure under this section shall identify [the can-
11 didate or] **any** candidates [who] **or measures that** are the subject of the independent expenditure
12 and state whether the independent expenditure was used to advocate the election, **passage** or defeat
13 of the [candidate or] candidates **or measures**.

14 (7) If a candidate, political committee, chief petitioner under ORS 260.118 or an agent of a can-
15 didate, political committee or chief petitioner makes an expenditure for the purpose of paying any
16 person money or other valuable consideration for obtaining signatures on an initiative, referendum
17 or recall petition, the statement described in this section shall list the total amount paid by the
18 candidate, political committee, chief petitioner or agent for the purpose of obtaining signatures. The
19 statement is not required to list the name or address of any person as payee or the amount paid to
20 any person.

21 (8)(a) A vendor who enters into a contract with a candidate or political committee to prepare
22 or produce brochures, mailings, polls, other opinion research or television, radio or newspaper ad-
23 vertising, or to provide mail handling and postage, is not considered an agent of the candidate or
24 political committee for purposes of subsection (5) of this section. The Secretary of State by rule may
25 designate other specific products or services that would qualify a vendor for an exemption from re-
26 porting under this subsection.

27 (b) Nothing in this section [shall require] **requires** a vendor described in this subsection to dis-
28 close the vendor's internal or subcontracting costs for providing the specific product or service un-
29 der paragraph (a) of this subsection.

30 (9) As used in this section, "address" [shall have] **has** the meaning given that term in rules
31 adopted by the Secretary of State.

35 **SECTION 12.** A candidate or principal campaign committee of a candidate may not use
36 amounts received as contributions by the candidate or committee to make an expenditure
37 to or on behalf of the candidate in consideration for the rendering of professional services
38 by the candidate.

39 **SECTION 13.** Section 14 of this 2005 Act is added to and made a part of ORS 260.035 to
40 260.156.

41 **SECTION 14.** (1) The Secretary of State by rule shall adopt an electronic filing system
42 to be used by all candidates and political committees to file with the secretary statements
43 of contributions received and expenditures made by the candidates and political committees,
44 as described in ORS 260.083.

45 (2)(a) A candidate for nomination or election at any primary or general election or a

1 **political committee supporting or opposing a candidate or measure at any primary or general**
2 **election shall file a statement described in subsection (1) of this section not later than seven**
3 **calendar days after a contribution is received or an expenditure is made. This paragraph**
4 **applies to contributions received and expenditures made during the period beginning on the**
5 **69th day before the date of any primary election and ending on December 31 of that calendar**
6 **year.**

7 **(b) A candidate for nomination or election at any regular district election or a political**
8 **committee supporting or opposing a candidate or measure at any regular district election**
9 **shall file a statement described in subsection (1) of this section not later than seven calendar**
10 **days after a contribution is received or an expenditure is made. This paragraph applies to**
11 **contributions received and expenditures made during the period beginning on the 60th day**
12 **before the date of any regular district election and ending on the seventh day after the date**
13 **of any regular district election.**

14 **(c) For any special election, the secretary by rule may establish a period during which a**
15 **candidate for nomination or election at the special election or a political committee sup-**
16 **porting or opposing a candidate or measure at the special election must file a statement**
17 **described in subsection (1) of this section not later than seven calendar days after a contri-**
18 **bution is received or an expenditure is made.**

19 **(3) Except as provided in subsection (4) of this section, during a period not described in**
20 **subsection (2) of this section, a candidate or political committee shall file a statement de-**
21 **scribed in subsection (1) of this section not later than 90 calendar days after a contribution**
22 **is received or an expenditure is made.**

23 **(4)(a) If a candidate for nomination or election at any primary or general election or a**
24 **political committee supporting or opposing a candidate or measure at any primary or general**
25 **election receives a contribution or makes an expenditure prior to the 69th day before the**
26 **date of the primary election and has not filed a statement of the contribution or expenditure**
27 **under subsection (3) of this section by the 70th day before the date of the primary election,**
28 **the candidate or political committee shall file a statement described in subsection (1) of this**
29 **section not later than the 62nd day before the date of the primary election.**

30 **(b) If a candidate for nomination or election at any regular district election or a political**
31 **committee supporting or opposing a candidate or measure at any regular district election**
32 **receives a contribution or makes an expenditure prior to the 60th day before the date of the**
33 **regular district election and has not filed a statement of the contribution or expenditure**
34 **under subsection (3) of this section by the 61st day before the date of the regular district**
35 **election, the candidate or political committee shall file a statement described in subsection**
36 **(1) of this section not later than the 53rd day before the date of the regular district election.**

37 **(5) The electronic filing system shall be provided free of charge by the secretary and:**

38 **(a) Accept electronic files that conform to the format prescribed by the secretary by**
39 **rule; or**

40 **(b) Be compatible with any other electronic filing application provided or approved by the**
41 **secretary.**

42 **(6) The secretary shall make all data filed electronically under this section and all infor-**
43 **mation filed with the secretary under ORS 260.044, 260.045, 260.049, 260.085, 260.102 or 260.118**
44 **available on the Internet to the public free of charge according to a schedule adopted by the**
45 **secretary by rule. The secretary shall make the data available in a searchable database that**

1 is easily accessible by the public.

2 (7) Each statement required by this section shall be signed and certified as true by the
3 candidate or treasurer required to file it. Signatures shall be supplied in the manner specified
4 by the secretary by rule.

5 (8)(a) A candidate for federal office shall file statements required by the federal election
6 laws in lieu of the statements required by ORS 260.035 to 260.156. At any time, the secretary
7 by rule may make a determination that the standards and requirements of the federal
8 election laws relating to candidates for federal office are not substantially similar to those
9 contained in ORS 260.035 to 260.156. If the secretary makes this determination, candidates
10 for federal office are subject to the requirements of ORS 260.035 to 260.156.

11 (b) Subsections (1) to (7) of this section do not apply to candidates who are not required
12 to file a statement of organization under ORS 260.043 or to candidates or political committees
13 who file certificates under ORS 260.112.

14 **SECTION 15.** ORS 260.402 is amended to read:

15 260.402. [*No person shall make a contribution to any other person, relating to a nomination or*

20 *itical committee, it shall be sufficient to enter it as received from the treasurer.*]

21 (1) A person may not make a contribution in any name other than that of the person
22 who in truth provides the contribution to:

23 (a) Any other person, relating to a nomination or election of any candidate or the support
24 of or opposition to any measure;

25 (b) Any political committee; or

26 (c) A chief petitioner or treasurer required to file a statement under ORS 260.118.

27 (2) Except as provided in subsection (3) of this section, a person, political committee or
28 chief petitioner may not knowingly receive a contribution prohibited under subsection (1) of
29 this section or enter or cause the contribution to be entered in accounts or records in an-
30 other name than that of the person by whom it was actually provided.

31 (3) If a person receives a contribution from a political committee, the person may enter
32 the contribution into accounts or records as received from the political committee.

45 (B) A photograph or drawing of the candidate appears; or

1 (C) The identity of the candidate is apparent by unambiguous reference.

2 (d) “Clearly identified” means, with respect to measures:

3 (A) The ballot number of the measure appears;

4 (B) A description of the measure’s subject or effect appears; or

5 (C) The identity of the measure is apparent by unambiguous reference.

6 (e) “Made with the cooperation or with the prior consent of, or in consultation with, or at the
7 request or suggestion of, a candidate or any agent or authorized committee of the candidate, or any
8 political committee or agent of a political committee supporting or opposing a measure”:

9 (A) Means any arrangement, coordination or direction by the candidate or the candidate’s agent,
10 or by any political committee or agent of a political committee supporting or opposing a measure,
11 prior to the publication, distribution, display or broadcast of the communication. An expenditure
12 shall be presumed to be so made when it is:

13 (i) Based on information about the plans, projects or needs of the candidate, or of the political
14 committee supporting or opposing a measure, and provided to the expending person by the candidate
15 or by the candidate’s agent, or by any political committee or agent of a political committee sup-
16 porting or opposing a measure, with a view toward having an expenditure made; or

17 (ii) Made by or through any person who is or has been authorized to raise or expend funds, who
18 is or has been an officer of a political committee authorized by the candidate or by a political
19 committee or agent of a political committee supporting or opposing a measure, or who is or has been
20 receiving any form of compensation or reimbursement from the candidate, the candidate’s principal
21 campaign committee or agent or from any political committee or agent of a political committee
22 supporting or opposing a measure; and

23 (B) Does not include providing to the expending person upon request a copy of this chapter or
24 any rules adopted by the Secretary of State relating to independent expenditures.

25 (10) “Initiative petition” means a petition to initiate a measure for which a prospective petition
26 has been filed but that is not yet a measure.

27 (11) “Judge” means judge of the Supreme Court, Court of Appeals, circuit court or the Oregon

29 (12) “Mass mailing” means more than 200 substantially similar pieces of mail, but does not in-
30 clude a form letter or other mail that is sent in response to an unsolicited request, letter or other
31 inquiry.

34 (a) A proposed law.

35 (b) An Act or part of an Act of the Legislative Assembly.

22 [(20)] **(21)** "Slate mailer" means a mass mailing that supports or opposes a total of three or more
23 candidates or measures.

24 [(21)(a)] **(22)(a)** "Slate mailer organization" means, except as provided in paragraph (b) of this

26 (A) Is involved in the production of one or more slate mailers and exercises control over the
27 selection of the candidates and measures to be supported or opposed in the slate mailers; and

11 260.232, 260.241, 260.245, 260.255 and 260.315 by sections 29a to 34, 35a, 36 to 38a, 40 to 43 and
12 44a to 46 of this 2005 Act and the repeal of ORS 260.058, 260.063, 260.068, 260.073, 260.159 and
13 260.161 and section 6, chapter 542, Oregon Laws 2003, by section 56 of this 2005 Act:

14 (1) Become operative on January 1, 2007;

15 (2) Do not relieve a person of any obligation with respect to a fee, fine or other charge,
16 interest, civil penalty or other liability, duty or obligation accruing under a law amended or
17 repealed by this 2005 Act; and

18 (3) Do not affect an act done or proceeding begun, a liability incurred or a right accruing,
19 accrued or acquired before the operative date specified in this section, under the law then
20 in effect. A proceeding begun before the operative date specified in this section in accordance
21 with the law then in effect may be completed after the operative date specified in this section
22 as if this 2005 Act had not been enacted.

23 **SECTION 58.** (1) Except as provided in subsections (2) and (3) of this section, a candidate
24 or political committee shall file a first statement under section 14 of this 2005 Act for con-
25 tributions received and expenditures made on or after January 1, 2007.

26 (2) The first statement filed by a candidate or political committee under section 14 of this
27 2005 Act on or after January 1, 2007, shall include any contributions received or expenditures
28 made by the candidate or political committee prior to January 1, 2007, that were not included
29 on a statement filed with a filing officer prior to January 1, 2007.

30 (3) If the last statement of contributions and expenditures filed by a candidate or political
31 committee prior to January 1, 2007, for a previous election shows an unexpended balance of
32 contributions or an expenditure deficit, the first statement required by section 14 of this 2005
33 Act shall list a beginning balance in an amount equal to the amount of the unexpended bal-
34 ance of contributions or the amount of the expenditure deficit.

35 **SECTION 59.** The Secretary of State, a county clerk or a chief city elections officer may
36 take any action before January 1, 2007, that is necessary to enable the secretary, clerk or
37 elections officer to exercise, on and after January 1, 2007, all the duties, functions and pow-
38 ers conferred upon the secretary, clerk or elections officer by sections 13 and 14 of this 2005
39 Act, the amendments to section 51 of this 2005 Act by section 52 of this 2005 Act, the
40 amendments to ORS 246.021, 260.005, 260.043, 260.044, 260.045, 260.049, 260.052, 260.055, 260.076,
41 260.078, 260.083, 260.085, 260.102, 260.112, 260.118, 260.205, 260.215, 260.225, 260.232, 260.241,
42 260.245, 260.255, 260.315 and 260.737 by sections 16, 21, 24, 27, 28a, 29a to 34, 35a, 36 to 38a, 39a,
43 40 to 43, 44a to 46 and 48 of this 2005 Act and the repeal of ORS 260.058, 260.063, 260.068,
44 260.073, 260.159 and 260.161 and section 6, chapter 542, Oregon Laws 2003, by section 56 of this
45 2005 Act.

1 **SECTION 60.** (1) Section 3 of this 2005 Act and the amendments to ORS 260.039 and
2 260.042 by sections 4 and 5 of this 2005 Act apply to political committees for which a state-
3 ment of organization is filed prior to, on or after the effective date of this 2005 Act.

4 (2) A political committee for which a statement of organization was filed prior to the
5 effective date of this 2005 Act, and whose filing remains active on the effective date of this
6 2005 Act, shall:

7 (a) Comply with the requirements of section 3 of this 2005 Act not later than January 1,
8 2006; and

9 (b) Amend the statement of organization filed by the political committee under ORS
10 260.039 or 260.042 to contain any information required under ORS 260.039 or 260.042, as
11 amended by sections 4 and 5 of this 2005 Act, not later than January 1, 2006.

12 **SECTION 61.** (1) The amendments to ORS 260.083 by section 8 of this 2005 Act apply to
13 statements of contributions received and expenditures made filed on or after January 1, 2006.

14 (2) The amendments to ORS 260.005 and 260.044 by sections 20 and 26 of this 2005 Act
15 apply to independent expenditures made prior to, on or after the effective date of this 2005
16 Act and required to be reported on statements filed on or after the effective date of this 2005
17 Act.

18 (3) The amendments to ORS 260.118 by section 37 of this 2005 Act apply to statewide ini-
19 tiative and referendum petitions and any recall petitions for which a prospective petition is
20 filed prior to, on or after the operative date specified in section 57 of this 2005 Act.

21 (4) The amendments to ORS 260.402 by section 15 of this 2005 Act apply to contributions
22 made or received on or after the effective date of this 2005 Act.

23 (5) The amendments to ORS 260.995 by section 1 of this 2005 Act apply to violations of
24 ORS 260.407 occurring on or after the effective date of this 2005 Act.

25 (6) Section 12 of this 2005 Act applies to expenditures made on or after the effective date
26 of this 2005 Act.

27 **SECTION 62.** This 2005 Act being necessary for the immediate preservation of the public
28 peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect
29 on its passage.
