SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Repeals authority to establish electronic lottery games based on results of sporting events.
Transfers one percent of moneys transferred to Administrative Services Economic Development Fund to Sports Lottery Account for purpose of funding sports programs at state institutions of higher education.
Takes effect July 1, [2006] **2007**.

A BILL FOR AN ACT

1
2 Relating to Oregon State Lottery funding of sports programs at institutions of higher education;
3 amending ORS 461.535 and 461.543; repealing ORS 461.213; and prescribing an effective date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 461.535 is amended to read:

6 461.535. The Intercollegiate Athletic Fund is created separate and distinct from the General
7 Fund. The fund shall consist of revenues credited to the Sports Lottery Account under ORS [461.213
8 and] 461.543 (4) [and (5)] and any other revenues available to the fund.

9 **SECTION 2.** ORS 461.543 is amended to read:

10 461.543. (1) Except as otherwise specified in subsection (5) of this section, the Sports Lottery
11 Account is continuously appropriated to and shall be used by the State Board of Higher Education
12 to fund sports programs at state institutions of higher education. Seventy percent of the revenues
13 in the fund shall be used to fund nonrevenue producing sports and 30 percent shall be used for re-
14 venue producing sports. Of the total amount available in the fund, at least 50 percent shall be made
15 available for women's athletics.

16 (2) The State Board of Higher Education shall allocate moneys in the Sports Lottery Account
17 among the institutions of higher education under its jurisdiction giving due consideration to:

18 (a) The athletic conference to which the institution belongs and the relative costs of competing
19 in that conference.

20 (b) The level of effort being made by the institution to generate funds and support from private
21 sources.

22 (3) As used in subsections (1) to (3) of this section, "revenue producing sport" is a sport that
23 produces net revenue over expenditures during a calendar year or if its season extends into two
24 calendar years, produces net revenue over expenditures during the season.

25 (4) An amount equal to [the net proceeds of games provided for in ORS 461.213 (1)] **one percent**
26 **of the moneys transferred to the Administrative Services Economic Development Fund from**

1 **the State Lottery Fund** shall be allocated from the Administrative Services Economic Development
2 Fund to the Sports Lottery Account.

3 (5) The amounts received by the Sports Lottery Account shall be allocated as follows:

4 (a) Eighty-eight percent for the purposes specified in subsections (1) to (3) of this section, but
5 not to exceed \$8 million annually, adjusted annually pursuant to the Consumer Price Index, as de-
6 fined in ORS 327.006.

7 (b) Twelve percent for the purpose of scholarships, to be distributed equally between scholar-
8 ships based on academic merit and scholarships based on need, as determined by rule of the State
9 Board of Higher Education, but not to exceed \$1,090,909 annually.

10 (c) All additional money to the Oregon Student Assistance Commission for the Oregon Oppor-
11 tunity Grant program under ORS 348.260.

12 **SECTION 3. ORS 461.213 is repealed.**

13 **SECTION 4. This 2005 Act takes effect on July 1, 2007.**
