**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Abolishes Oregon State Fair and Exposition Center, Oregon State Fair Commission and position of Director of Oregon State Fair and Exposition Center. Transfers duties to State Parks and Recreation Department. Directs appointment of State Fair Advisory Committee. Establishes duties.

Continuously appropriates moneys from Oregon State Fair Account to State Parks and Recreation Department.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

2 Relating to the state fair; creating new provisions; amending ORS 244.050, 279A.025, 291.055, 307.110,  
3 390.134, 390.555, 462.073, 462.125, 462.140, 565.010, 565.030, 565.040, 565.050, 565.060, 565.080,  
4 565.090, 565.095, 565.103, 565.107, 565.109, 565.114, 565.116, 565.120, 565.130, 565.140, 565.150,  
5 565.160, 565.170, 565.610, 565.620, 565.630 and 565.640; repealing ORS 565.015, 565.020, 565.070,  
6 565.112 and 565.423; appropriating money; and declaring an emergency.

7 Whereas the Oregon State Fair is a gathering place for Oregonians, providing unique and val-  
8 uable resources for Oregonians; and

9 Whereas the Oregon State Fair promotes valuable youth activities; and

10 Whereas the Oregon State Fair benefits Oregon's rich natural resources, highlights scientific,  
11 cultural and historic achievements and promotes the products, industries, commerce and economic  
12 and social life of the state; and

13 Whereas the policy of the state toward outdoor recreation resources is to encourage, through  
14 the State Parks and Recreation Department, outdoor activities such as festivals, fairs and events  
15 relating to music, dance, drama, art and sports; now, therefore,

16 **Be It Enacted by the People of the State of Oregon:**

17 **SECTION 1. (1) The Oregon State Fair and Exposition Center, the Oregon State Fair**  
18 **Commission and the position of Director of the Oregon State Fair and Exposition Center are**  
19 **abolished. On the operative date of this section, the tenure of office of the members of the**  
20 **Oregon State Fair Commission and of the Director of the Oregon State Fair and Exposition**  
21 **Center ceases.**

22 **(2) All the duties, functions and powers of the Oregon State Fair and Exposition Center,**  
23 **the Oregon State Fair Commission, the Director of the Oregon State Fair and Exposition**  
24 **Center and the Oregon State Fair are imposed upon, transferred to and vested in the State**  
25 **Parks and Recreation Department.**

26 **SECTION 2. (1) The Director of the Oregon State Fair and Exposition Center shall:**

1 (a) Deliver to the State Parks and Recreation Department all records and property within  
2 the jurisdiction of the director that relate to the duties, functions and powers transferred  
3 by section 1 of this 2005 Act; and

4 (b) Transfer to the State Parks and Recreation Department those employees engaged  
5 primarily in the exercise of the duties, functions and powers transferred by section 1 of this  
6 2005 Act.

7 (2) The State Parks and Recreation Director shall take possession of the records and  
8 property, and shall take charge of the employees and employ them in the exercise of the  
9 duties, functions and powers transferred by section 1 of this 2005 Act, without reduction of  
10 compensation but subject to change or termination of employment or compensation as pro-  
11 vided by law.

12 (3) The Governor shall resolve any dispute between the Oregon State Fair and Exposition  
13 Center and the State Parks and Recreation Department relating to transfers of records,  
14 property and employees under this section, and the Governor's decision is final.

15 **SECTION 3.** (1) The unexpended balances of amounts authorized to be expended by the  
16 Oregon State Fair and Exposition Center for the biennium beginning July 1, 2005, from re-  
17 venues dedicated, continuously appropriated, appropriated or otherwise made available for  
18 the purpose of administering and enforcing the duties, functions and powers transferred by  
19 section 1 of this 2005 Act are appropriated and transferred to and are available for expendi-  
20 ture by the State Parks and Recreation Department for the biennium beginning July 1, 2005,  
21 for the purpose of administering and enforcing the duties, functions and powers transferred  
22 by section 1 of this 2005 Act.

23 (2) The expenditure classifications, if any, established by Acts authorizing or limiting  
24 expenditures by the Oregon State Fair and Exposition Center remain applicable to expendi-  
25 tures by the State Parks and Recreation Department under this section.

26 **SECTION 4.** The transfer of duties, functions and powers to the State Parks and Recre-  
27 ation Department by section 1 of this 2005 Act does not affect any action, proceeding or  
28 prosecution involving or with respect to such duties, functions and powers begun before and  
29 pending at the time of the transfer, except that the State Parks and Recreation Department  
30 is substituted for the Oregon State Fair and Exposition Center in the action, proceeding or  
31 prosecution.

32 **SECTION 5.** (1) Nothing in sections 1 to 10 of this 2005 Act relieves a person of a liability,  
33 duty or obligation accruing under or with respect to the duties, functions and powers  
34 transferred by section 1 of this 2005 Act. The State Parks and Recreation Department may  
35 undertake the collection or enforcement of any such liability, duty or obligation.

36 (2) The rights and obligations of the Oregon State Fair and Exposition Center legally in-  
37 curred under contracts, leases and business transactions executed, entered into or begun  
38 before the operative date of section 1 of this 2005 Act are transferred to the State Parks and  
39 Recreation Department. For the purpose of succession to these rights and obligations, the  
40 State Parks and Recreation Department is a continuation of the Oregon State Fair and Ex-  
41 position Center and not a new authority.

42 **SECTION 6.** Notwithstanding the transfer of duties, functions and powers by section 1  
43 of this 2005 Act, the rules of the Oregon State Fair and Exposition Center in effect on the  
44 operative date of section 1 of this 2005 Act continue in effect until superseded or repealed  
45 by rules of the State Parks and Recreation Department. References in rules of the Oregon

1 State Fair and Exposition Center to the Oregon State Fair and Exposition Center or an of-  
2 ficer or employee of the Oregon State Fair and Exposition Center are considered to be ref-  
3 erences to the State Parks and Recreation Department or an officer or employee of the State  
4 Parks and Recreation Department.

5 **SECTION 7.** Whenever, in any uncodified law or resolution of the Legislative Assembly  
6 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-  
7 erence is made to the Oregon State Fair and Exposition Center or an officer or employee of  
8 the Oregon State Fair and Exposition Center, the reference is considered to be a reference  
9 to the State Parks and Recreation Department or an officer or employee of the State Parks  
10 and Recreation Department.

11 **SECTION 8.** The State Parks and Recreation Director may take any action before the  
12 operative date of section 1 of this 2005 Act that is necessary to enable the director to exer-  
13 cise, on and after the operative date of section 1 of this 2005 Act, the duties, functions and  
14 powers of the director pursuant to section 1 of this 2005 Act.

15 **SECTION 9.** For the purpose of harmonizing and clarifying statute sections published in  
16 Oregon Revised Statutes, the Legislative Counsel may substitute for words designating the  
17 "Oregon State Fair and Exposition Center" or its officers, wherever they occur in Oregon  
18 Revised Statutes, words designating the "State Parks and Recreation Department" or its  
19 officers.

20 **SECTION 10.** For the purpose of harmonizing and clarifying statute sections published  
21 in Oregon Revised Statutes, the Legislative Counsel may substitute for words designating the  
22 "Oregon State Fair and Exposition Center Account," wherever they occur in Oregon Revised  
23 Statutes, words designating the "Oregon State Fair Account."

24 **SECTION 11.** Except as otherwise specifically provided in section 8 of this 2005 Act,  
25 sections 1 to 10 of this 2005 Act and the amendments to ORS 565.107, 565.109 and 565.114 by  
26 sections 31 to 33 of this 2005 Act become operative on January 1, 2006.

27 **SECTION 12.** (1) The State Parks and Recreation Director shall appoint a State Fair  
28 Advisory Committee to provide advice and assistance to the director on matters regarding  
29 the operation of the Oregon State Fair.

30 (2) The advisory committee shall consist of seven members appointed by the director for  
31 four-year terms. The director shall appoint:

32 (a) A resident from each congressional district of Oregon. The director shall seek to  
33 ensure that those persons reflect a broad-based representation of the industrial, educational  
34 and cultural interests active in state fair activities, such as agricultural, stock raising,  
35 horticultural, mining, mechanical, artistic and industrial pursuits.

36 (b) Two persons to represent county fair interests. The director may give consideration  
37 to nominations suggested by the County Fair Commission established under ORS 565.410.

38 (3) The members of the advisory committee serve at the pleasure of the director. The  
39 director may fill a vacancy on the advisory committee by appointing a person to fill the un-  
40 expired term.

41 (4) Each member of the advisory committee is entitled to compensation and reimburse-  
42 ment of expenses, as provided in ORS 292.495, from moneys appropriated to the State Parks  
43 and Recreation Department for that purpose.

44 (5) The advisory committee shall select one of its members as chairperson and another  
45 as vice chairperson, for such terms and with such duties and powers necessary for the per-

1 **formance of the functions of those offices as the advisory committee determines appropriate.**

2 **(6) The advisory committee shall meet at the call of the director.**

3 **SECTION 13. Notwithstanding the terms of office for members of the State Fair Advisory**  
4 **Committee specified in section 12 of this 2005 Act, the State Parks and Recreation Director**  
5 **may stagger the terms of office of the members of the advisory committee to ensure that**  
6 **the terms of office do not expire at the same time.**

7 **SECTION 14.** ORS 244.050 is amended to read:

8 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon  
9 Government Standards and Practices Commission a verified statement of economic interest as re-  
10 quired under this chapter:

11 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the  
12 Bureau of Labor and Industries, Superintendent of Public Instruction, district attorneys and mem-  
13 bers of the Legislative Assembly.

14 (b) Any judicial officer, including justices of the peace and municipal judges, except municipal  
15 judges in those cities where a majority of the votes cast in the subject city in the 1974 general  
16 election was in opposition to the ballot measure provided for in section 10, chapter 68, Oregon Laws  
17 1974 (special session), and except any pro tem judicial officer who does not otherwise serve as a  
18 judicial officer.

19 (c) Any candidate for an office designated in paragraph (a) or (b) of this subsection.

20 (d) The Deputy Attorney General.

21 (e) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the  
22 Secretary of the Senate and the Chief Clerk of the House of Representatives.

23 (f) The Chancellor and Vice Chancellors of the Oregon University System and the president and  
24 vice presidents, or their administrative equivalents, in each institution under the jurisdiction of the  
25 State Board of Higher Education.

26 (g) The following state officers:

27 (A) Adjutant General.

28 (B) Director of Agriculture.

29 (C) Manager of State Accident Insurance Fund Corporation.

30 (D) Water Resources Director.

31 (E) Director of Department of Environmental Quality.

32 (F) Director of Oregon Department of Administrative Services.

33 [*G*] *Director of the Oregon State Fair and Exposition Center.*]

- 17 majority of votes cast in the subject city or county in an election on the issue of filing statements
- 18 of economic interest under this chapter was in opposition.
- 19       (L) Members of local government boundary commissions formed under ORS 199.410 to 199.519.
- 20       (m) Every member of a governing body of a metropolitan service district and the executive of-
- 21 ficer thereof.
- 22       (n) Each member of the board of directors of the State Accident Insurance Fund Corporation.
- 23       (o) The chief administrative officer and the financial officer of each common and union high
- 24 school district, education service district and community college district.
- 25       (p) Every member of the following state boards and commissions:
- 26       (A) Capitol Planning Commission.
- 27       (B) Board of Geologic and Mineral Industries.
- 28       (C) Oregon Economic and Community Development Commission.
- 29       (D) State Board of Education.

- 23 (4) Within 30 days after the filing date for the general election, each candidate for elective
- 24 public office described in subsection (1) of this section who was not a candidate in the preceding
- 25 primary election shall file with the commission a statement of economic interest as required under
- 26 ORS 244.060, 244.070 and 244.090.
- 27 (5) The Legislative Assembly shall maintain a continuing review of the operation of this chapter
- 28 and from time to time may add to or delete from the list of boards and commissions in subsections
- 29 (1) to (3) of this section as in the judgment of the Legislative Assembly is consistent with the pur-
- 30 poses of this chapter.
- 31 (6) Subsections (1) to (5) of this section apply only to persons who are incumbent, elected or
- 32 appointed officials as of April 15 and to persons who are candidates for office on April 15. Those
- 33 sections also apply to persons who do not become candidates until 30 days after the filing date for
- 34 the statewide general election.
- 35 (7)(a) Failure to file the statement required by this section subjects a person to a civil penalty
- 36 that may be imposed as specified in ORS 183.745, but the enforcement of this subsection does not
- 37 require the Oregon Government Standards and Practices Commission to follow the procedures in
- 38 ORS 244.260 before finding that a violation of this section has occurred.
- 39 (b) Failure to file the required statement in timely fashion shall be prima facie evidence of a
- 40 violation of this section.
- 41 (c) If within five days after the date on which the statement is to be filed under this section the
- 42 statement has not been received by the commission, the commission shall notify the public official
- 43 and give the public official not less than 15 days to comply with the requirements of this section.
- 44 If the public official fails to comply by the date set by the commission, the commission may impose
- 45 a civil penalty of \$5 for each day the statement is late beyond the date fixed by the commission.

1 The maximum penalty that may be accrued under this section is \$1,000.

2 (d) A civil penalty imposed under this subsection is in addition to and not in lieu of sanctions  
3 that may be imposed under ORS 244.380.

4 **SECTION 15.** ORS 279A.025 is amended to read:

5 279A.025. (1) Except as provided in subsections (2) to (4) of this section, the Public Contracting  
6 Code applies to all public contracting.

7 (2) The Public Contracting Code does not apply to:

8 (a) Contracts between contracting agencies or between contracting agencies and the federal  
9 government;

10 (b) Insurance and service contracts as provided for under ORS 414.115, 414.125, 414.135 and  
11 414.145 for purposes of source selection;

12 (c) Grants;

13 (d) Contracts for professional or expert witnesses or consultants to provide services or testi-  
14 mony relating to existing or potential litigation or legal matters in which a public body is or may  
15 become interested;

16 (e) Acquisitions or disposals of real property or interest in real property;

17 (f) Sole-source expenditures when rates are set by law or ordinance for purposes of source se-  
18 lection;

19 (g) Contracts for the procurement or distribution of textbooks;

20 (h) Procurements by a contracting agency from an Oregon Corrections Enterprises program;

21 (i) The procurement, transportation or distribution of distilled liquor, as defined in ORS 471.001,  
22 or the appointment of agents under ORS 471.750 by the Oregon Liquor Control Commission;

23 (j) Contracts entered into under ORS chapter 180 between the Attorney General and private  
24 counsel or special legal assistants;

25 (k) Contracts for the sale of forest products, as defined in ORS 321.005, from lands owned or  
26 managed by the State Board of Forestry and the State Forestry Department;

27 (L) Contracts for forest protection or forest related activities, as described in ORS 477.406, by  
28 the State Forester or the State Board of Forestry;

29 (m) Sponsorship agreements entered into by the **State Parks and Recreation** Director [*of the*  
30 *Oregon State Fair and Exposition Center*] in accordance with ORS 565.080 (4);

31 (n) Contracts entered into by the Housing and Community Services Department in exercising the  
32 department's duties prescribed in ORS chapters 456 and 458, except that the department's public  
33 contracting for goods and services, as defined in ORS 279B.005, is subject to ORS chapter 279B;

34 (o) Contracts entered into by the State Treasurer in exercising the powers of that office pre-  
35 scribed in ORS chapters 178, 286, 287, 288, 289, 293, 294 and 295, including but not limited to in-  
36 vestment contracts and agreements, banking services, clearing house services and collateralization  
37 agreements, bond documents, certificates of participation and other debt repayment agreements, and  
38 any associated contracts, agreements and documents, regardless of whether the obligations that the  
39 contracts, agreements or documents establish are general, special or limited, except that the State  
40 Treasurer's public contracting for goods and services, as defined in ORS 279B.005, is subject to ORS  
41 chapter 279B;

42 (p) Energy savings performance contracts;

43 (q) Contracts, agreements or other documents entered into, issued or established in connection  
44 with:

45 (A) The incurring of debt by a public body, including but not limited to the issuance of bonds,

1 certificates of participation and other debt repayment obligations, and any associated contracts,  
2 agreements or other documents, regardless of whether the obligations that the contracts, agreements  
3 or other documents establish are general, special or limited;

4 (B) The making of program loans and similar extensions or advances of funds, aid or assistance  
5 by a public body to a public or private body for the purpose of carrying out, promoting or sustaining  
6 activities or programs authorized by law; or

7 (C) The investment of funds by a public body as authorized by law, and other financial trans-  
8 actions of a public body that by their character cannot practically be established under the com-  
9 petitive contractor selection procedures of ORS 279B.050 to 279B.085;

10 (r) Contracts for employee benefit plans as provided in ORS 243.105 (1), 243.125 (4), 243.221,  
11 243.275, 243.291, 243.303 and 243.565; or

12 (s) Any other public contracting of a public body specifically exempted from the code by another  
13 provision of law.

14 (3) The Public Contracting Code does not apply to the public contracting activities of:

15 (a) The Oregon State Lottery Commission;

16 (b) The Oregon University System and member institutions, except as provided in ORS 351.086;

17 (c) The legislative department;

18 (d) The judicial department;

19 (e) Semi-independent state agencies listed in ORS 182.451, 182.452 and 182.454, except as pro-  
20 vided in ORS 279.835 to 279.855 and 279A.250 to 279A.290;

21 (f) Oregon Corrections Enterprises;

22 (g) The Oregon Film and Video Office, except as provided in ORS 279A.100 and 279A.250 to  
23 279A.290;

24 (h) The Travel Information Council, except as provided in ORS 279A.250 to 279A.290;

25 (i) The Appraiser Certification and Licensure Board, except as provided in ORS 279.835 to  
26 279.855 and 279A.250 to 279A.290; or

27 (j) Any other public body specifically exempted from the code by another provision of law.

28 (4) ORS 279A.200 to 279A.225 and 279B.050 to 279B.085 do not apply to contracts made with  
29 qualified nonprofit agencies providing employment opportunities for disabled individuals under ORS  
30 279.835 to 279.855.

31 **SECTION 16.** ORS 291.055 is amended to read:

32 291.055. (1) Notwithstanding any other law that grants to a state agency the authority to es-  
33 tablish fees, all new state agency fees or fee increases adopted after July 1 of any odd-numbered  
34 year:

35 (a) Are not effective for agencies in the executive department of government unless approved  
36 in writing by the Director of the Oregon Department of Administrative Services;

37 (b) Are not effective for agencies in the judicial department of government unless approved in  
38 writing by the Chief Justice of the Supreme Court;

39 (c) Are not effective for agencies in the legislative department of government unless approved  
40 in writing by the President of the Senate and the Speaker of the House of Representatives;

41 (d) Shall be reported by the state agency to the Oregon Department of Administrative Services  
42 within 10 days of their adoption; and

43 (e) Are rescinded on July 1 of the next following odd-numbered year, or on adjournment sine  
44 die of the regular session of the Legislative Assembly meeting in that year, whichever is later, un-  
45 less otherwise authorized by enabling legislation setting forth the approved fees.

1 (2) This section does not apply to:

2 (a) Any tuition or fees charged by the State Board of Higher Education and state institutions  
3 of higher education.

4 (b) Taxes or other payments made or collected from employers for unemployment insurance re-  
5 quired by ORS chapter 657 or premium assessments required by ORS 656.612 and 656.614 or contri-  
6 butions and assessments calculated by cents per hour for workers' compensation coverage required  
7 by ORS 656.506.

8 (c) Fees or payments required for:

9 (A) Health care services provided by the Oregon Health and Science University, by the Oregon  
10 Veterans' Homes and by other state agencies and institutions pursuant to ORS 179.610 to 179.770.

11 (B) Assessments and premiums paid to the Oregon Medical Insurance Pool established by ORS  
12 735.614 and 735.625.

13 (C) Copayments and premiums paid to the Oregon medical assistance program.

14 (d) Fees created or authorized by statute that have no established rate or amount but are cal-  
15 culated for each separate instance for each fee payer and the fee assessed is based on actual cost  
16 of services provided.

1 to provide funds for the fire protection districts as provided in ORS 390.290.

2 (8) On or before January 15 of each odd-numbered year, the State Parks and Recreation Director  
3 shall report to the Joint Legislative Committee on Ways and Means created by ORS 171.555 on the  
4 use of moneys deposited pursuant to ORS 805.256 in the fund. The director shall make the report  
5 in a form and manner as the committee may prescribe.

6 **SECTION 48.** ORS 390.555 is amended to read:

7 390.555. (1) The All-Terrain Vehicle Account is established as a separate [account] **subaccount**  
8 in the State Parks and Recreation Department Fund, to be accounted for separately. Interest earned  
9 by the All-Terrain Vehicle Account shall be credited to the [account] **subaccount**.

10 (2) After deduction of expenses of collection, transfer and administration, including the expenses  
11 of establishment and operation of Class I all-terrain vehicle safety education courses under ORS  
12 390.570 and Class III all-terrain vehicle safety education courses under ORS 390.575, the following  
13 moneys shall be transferred to the [account] **subaccount**:

14 [(1)] (a) Fees collected by the State Parks and Recreation Department for issuance of operating  
15 permits for all-terrain vehicles under ORS 390.580 and 390.590.

16 [(2)] (b) Fees collected by the department from participants in the Class I and Class III all-  
17 terrain vehicle safety education courses under ORS 390.570 and 390.575.

18 [(3)] (c) The moneys transferred from the Department of Transportation under ORS 802.125 that  
19 represent unrefunded fuel tax.

20 (3) **The State Parks and Recreation Department shall transfer 35 percent of the moneys**  
21 **received from fees and transfers under subsection (2) of this section into a separate subac-**  
22 **count in the State Parks and Recreation Department Fund to be used for carrying out the**  
23 **provisions of ORS 390.140 to 390.150, including for the maintenance and operation of the**  
24 **Oregon State Fair.**

25 **SECTION 49.** ORS 565.015, 565.020, 565.070, 565.112 and 565.423 are repealed.

26 **SECTION 50.** This 2005 Act being necessary for the immediate preservation of the public  
27 peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect  
28 on its passage.

29
