

House Bill 5022

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Department of Justice for biennial expenses of district attorneys, deputy district attorneys and certain administrative costs.

Declares emergency, effective July 1, 2005.

A BILL FOR AN ACT

2 Relating to the financial administration of the Department of Justice; appropriating money; and de-
3 claring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the Department of Justice, for the biennium be-**
6 **ginning July 1, 2005, out of the General Fund, the amount of \$9,609,157 to be expended for:**

7 (1) **Paying the expenses of district attorneys, as provided in section 2 of this 2005 Act;**

8 (2) **Special payments to counties for deputy district attorneys, as provided in section 3**
9 **of this 2005 Act; and**

10 (3) **Paying the expenses incurred in administering this 2005 Act, as provided in section 4**
11 **of this 2005 Act.**

12 **SECTION 2. The Department of Justice, for the biennium beginning July 1, 2005, may**
13 **allocate from the appropriation made by section 1 of this 2005 Act moneys for the payment**
14 **of expenses of district attorneys.**

15 **SECTION 3. (1) The Department of Justice, for the biennium beginning July 1, 2005, may**
16 **allocate from the appropriation made by section 1 of this 2005 Act moneys for special pay-**
17 **ments to counties for deputy district attorneys actually employed by the county whose sal-**
18 **aries are not paid entirely from federal funds.**

19 (2) **Each county shall certify to the Department of Justice, not later than the fifth day**
20 **of each quarter, the number of eligible deputy district attorneys for whom compensation is**
21 **requested for the quarter. Eligible deputy district attorney positions for which counties may**
22 **claim compensation are those filled by incumbents on the first day of the quarter whose**
23 **salaries are not paid entirely from federal funds. A quarterly installment payment requested**
24 **by a county under this subsection for an eligible deputy district attorney must be reduced**
25 **by the amount of the salary of that deputy district attorney that is paid in the quarter from**
26 **federal funds.**

27 (3) **Commencing July 1, 2005, from the allocation made by subsection (1) of this section,**
28 **each county shall receive quarterly the amount of \$1,375 per deputy district attorney for up**
29 **to the first three deputy district attorneys certified by the county under subsection (2) of**
30 **this section. The remainder of the allocation made by subsection (1) of this section shall be**

1 **paid, in quarterly installments throughout the biennium, to the various counties, in amounts**
2 **that evenly divide each quarterly installment in direct proportion to the number of deputy**
3 **district attorneys certified under subsection (2) of this section, reduced by the number of**
4 **deputy district attorneys compensated by the minimum quarterly payment under this sub-**
5 **section.**

6 **SECTION 4. The Department of Justice, for the biennium beginning July 1, 2005, may**
7 **allocate from the appropriation made by section 1 of this 2005 Act moneys for the payment**
8 **of expenses incurred in administering this 2005 Act.**

9 **SECTION 5. This 2005 Act being necessary for the immediate preservation of the public**
10 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**
11 **July 1, 2005.**
