

# A-Engrossed House Bill 5113

Ordered by the House June 10  
Including House Amendments dated June 10

Sponsored by COMMITTEE ON ELECTIONS AND RULES

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to [\_\_\_\_\_] **Oregon Student Assistance Commission** for **certain** biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding [*lottery funds and*] federal funds **and specified lottery moneys**, collected or received by [\_\_\_\_\_] **commission**.

Limits biennial expenditures by [\_\_\_\_\_] **commission** from federal funds.

**Limits biennial expenditures by commission from lottery moneys allocated from Education Stability Fund for Oregon Opportunity Grants.**

**Authorizes specified nonlimited expenditures.**

Declares emergency, effective July 1, 2005.

## A BILL FOR AN ACT

1  
2 Relating to state financial administration; appropriating money; limiting expenditures; and declaring  
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Oregon Student Assistance Commission, for**  
6 **the biennium beginning July 1, 2005, out of the General Fund, the following amounts for the**  
7 **following purposes:**

8 (1) **Financial aid payments to**  
9 **individuals and institutions..... \$ 64,607,781**

10 (2) **Operations..... \$ 1,664,352**

11 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**  
12 **\$3,584,419 is established for the biennium beginning July 1, 2005, as the maximum limit for**  
13 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**  
14 **but excluding federal funds, lottery moneys allocated from the Education Stability Fund for**  
15 **Oregon Opportunity Grants and those funds described in section 5 of this 2005 Act, collected**  
16 **or received by the Oregon Student Assistance Commission.**

17 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**  
18 **\$1,051,930 is established for the biennium beginning July 1, 2005, as the maximum limit for**  
19 **payment of expenses from federal funds collected or received by the Oregon Student Assist-**  
20 **ance Commission.**

21 **SECTION 4. Notwithstanding any other law limiting expenditures, the amount of**  
22 **\$1,527,619 is established for the biennium beginning July 1, 2005, as the maximum limit for**  
23 **payment of expenses from lottery moneys allocated from the Education Stability Fund to the**

1 **Oregon Student Assistance Commission for Oregon Opportunity Grants.**

2 **SECTION 5. For the biennium beginning July 1, 2005, expenditures by the Oregon Student**  
3 **Assistance Commission for the following activities are not limited:**

4 (1) **Making disbursements of grants from private and special scholarship accounts as es-**  
5 **tablished by the Legislative Assembly; and**

6 (2) **Making disbursements of educational benefits to individuals through the JOBS Plus**  
7 **Program.**

8 **SECTION 6. This 2005 Act being necessary for the immediate preservation of the public**  
9 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**  
10 **July 1, 2005.**
