3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the**
5 **following new or increased fees, adopted by the State Department of Agriculture and ap-**
6 **proved by the Oregon Department of Administrative Services, are approved:**

- 7 (1) **Fertilizer, agricultural**
- 8 **amendment and agricultural**
- 9 **mineral inspection \$ 0.35/ton**
- 10 (2) **Virus fruit tree**
- 11 **certification..... \$ 7 per test**
- 12 **per plant**
- 13 (3) **Annual nursery**
- 14 **participation fee..... \$ 200**

15 **SECTION 2. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the**
16 **following new or increased fees, adopted by the State Department of Agriculture and ap-**
17 **proved by the Oregon Department of Administrative Services, are approved:**

- 18 (1) **Livestock brand renewal**
- 19 **(no change in expiration)**
- 20 **- Nonsheep \$ 100/4 years**
- 21 (2) **Livestock brand renewal**
- 22 **(no change in expiration)**
- 23 **- Sheep \$ 40/4 years**
- 24 (3) **Livestock brand renewal**
- 25 **- Nonsheep \$ 25 per year**
- 26 (4) **Livestock brand renewal**

21 **SECTION 5.** This 2005 Act being necessary for the immediate preservation of the public
22 peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect
23 July 1, 2005.
