16 “**SECTION 2.** Notwithstanding any other provision of law, the expenditure limitation for
17 the biennium beginning July 1, 2005, for operating expenses of the Information Resources
18 Management Division authorized by section 2 (1), chapter 601, Oregon Laws 2005 (Enrolled
19 House Bill 5130), is reduced by \$35,665,294 to reflect the transfer of operations to the State
20 Data Center.

21 “**SECTION 3.** This 2005 Act being necessary for the immediate preservation of the public
22 peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect
