

**A-Engrossed**  
**House Concurrent Resolution 4**

Ordered by the House February 16  
Including House Amendments dated February 16

Sponsored by Representative BROWN; Senator VERGER

**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Commemorates centennial of City of Toledo.

**CONCURRENT RESOLUTION**

2       Whereas in 1866, portions of the central Oregon coast were opened for settlement by the federal  
3 government; and

4       Whereas John Graham and William Mackey, seeking a more temperate climate and more fertile  
5 land, traveled with their families by horse and by boat to Oregon, settling at the confluence of Depot  
6 Slough and the Yaquina River, each filing donation land claims on the acreage surrounding this site;  
7 and

8       Whereas the settlement's first post office was established on July 14, 1868, at the home of  
9 William Mackey; and

10       Whereas the Grahams named the new settlement for their former home in Toledo, Ohio; and

11       Whereas abundant natural resources promised prosperity for those willing to work a land claim,  
12 helping the young community to grow and prosper; and

13       Whereas many small sawmills processed the easily accessible timber while the many waterways  
14 provided easy transport; and

15       Whereas Lincoln County was formed in 1893, stretching from the western portions of Benton  
16 and Polk Counties to the Pacific Ocean, and Toledo became the seat of the new county; and

17       Whereas World War I brought the U.S. Army Signal Corps to Toledo to build the biggest spruce  
18 sawmill in the world and brought logging railroads into the woods, giving the small town the  
19 infrastructure to harvest stands of spruce and fir; and

20       Whereas timber has historically provided the economic base for Toledo and continues to do so  
21 today, as Georgia-Pacific Toledo Pulp and Paper Operations employs one of the largest workforces  
22 in Lincoln County, and the Plum Creek Timber Company continues to manage the timberlands to  
23 ensure that timber will remain an abundant resource in Toledo's future; and

24       Whereas Oregon's rural communities provide cherished homes and valuable support to families;  
25 now, therefore,

26 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

27       That we, the members of the Seventy-third Legislative Assembly, commemorate the 100th anni-  
28 versary of the City of Toledo, celebrated on February 18, 2005, and convey our warmest regards to  
29 its residents.
