

## A-Engrossed House Joint Memorial 2

Ordered by the House April 19  
Including House Amendments dated April 19

Sponsored by Representative NELSON; Representative BARNHART

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Urges Congress to introduce and pass legislation to allow veterans in Oregon to receive health care from health care facilities [*other than*] **in addition to** Department of Veterans' Affairs health care facilities.

### JOINT MEMORIAL

2 To the Senate and the House of Representatives of the United States of America, in Congress as-  
3 sembled:

4 We, your memorialists, the Seventy-third Legislative Assembly of the State of Oregon, in legis-  
5 lative session assembled, respectfully represent as follows:

6 Whereas Oregon has one of the nation's highest number of veterans per capita; and

7 Whereas approximately 370,000 veterans reside in Oregon; and

8 Whereas approximately 1,300 members of the Oregon National Guard are currently serving in  
9 Iraq; and

10 Whereas there are only two Department of Veterans' Affairs hospitals, one Department of Vet-  
11 erans' Affairs domiciliary and two Department of Veterans' Affairs outpatient clinics in Oregon; and

12 Whereas many veterans in Oregon reside a great distance from the nearest Department of Vet-  
13 erans' Affairs health care facility and face the burdensome problem of having to travel long hours  
14 to receive health care at a Department of Veterans' Affairs health care facility; and

15 Whereas those veterans in Oregon who reside in close proximity to a Department of Veterans'  
16 Affairs health care facility often encounter long wait times and other barriers to receiving health  
17 care; and

18 Whereas there are many other health care facilities located throughout Oregon; and

19 Whereas the ability of veterans in Oregon to receive health care at other health care facilities  
20 closer to their homes will increase access to health care for veterans; and

21 Whereas the ability of veterans in Oregon to receive health care at other health care facilities  
22 will reduce the wait times and other barriers to receiving health care at Department of Veterans'  
23 Affairs health care facilities and will increase access to health care for veterans; and

24 Whereas access is a part of quality health care and veterans in Oregon deserve quality health  
25 care; now, therefore,

26 **Be It Resolved by the Legislative Assembly of the State of Oregon:**

27 (1) The Congress of the United States is respectfully urged to introduce and pass legislation to  
28 allow veterans in Oregon to receive health care from health care facilities in addition to Department
