

## CONFERENCE COMMITTEE AMENDMENTS TO A-ENGROSSED SENATE BILL 31

August 4

### Amended Summary

Exempts tangible or intangible property, property rights or property interests in or related to Pacific Northwest AC Intertie and referenced in certain agreements from property taxation. Applies to tax years beginning on or after date of execution of agreement and tax years beginning on or after July 1, 2005.

Provides that for purposes of business income apportionment, sale of goods shipped from public warehouse is not considered to take place in this state if taxpayer's only activity in Oregon is storage of goods in public warehouse prior to shipment or taxpayer's only activities in Oregon are storage of goods in public warehouse prior to shipment and presence of employees in this state is solely for purposes of soliciting sales of taxpayer's products. Applies to tax years beginning on or after January 1, 2006.

Allows residential energy income tax credit for construction or installation of solar electric system. Establishes maximum amount of credit that may be claimed in single tax year. Allows unused credit amounts to be carried forward to tax year that is not more than five tax years following first tax year for which any credit was allowed. Applies to solar electric systems certified for credit on or after January 1, 2006, and before January 1, 2016.

**Establishes connection date to federal tax law. Disconnects from federal tax deduction for qualified production activities income, for 2005 and later tax years, and from federal tax exclusion for certain prescription drug plan subsidies, for 2008 and later tax years.**

**Temporarily makes earned income tax credit refundable. For 2008 and later tax years, increases percentage of federal earned income tax credit allowed for state earned income tax credit purposes.**

**Creates income tax credit for rural emergency medical technicians, if certified by Office of Rural Health.**

Takes effect on 91st day following adjournment sine die.

President Courtney:

Your Conference Committee to whom was referred A-engrossed Senate Bill 31, having had the same under consideration, respectfully reports it back with the recommendation that the Senate concur in the House amendments dated July 5 and that the bill be amended as follows and repassed.

1       On page 1 of the printed A-engrossed bill, line 2, after "ORS" delete the rest of the line and  
2 delete line 3 and insert "305.230, 305.494, 305.690, 307.090, 307.130, 307.147, 310.140, 310.630, 310.800,  
3 311.689, 314.011, 314.650, 314.665, 315.004, 315.262, 315.266, 316.012, 316.099, 316.116, 316.502, 317.010,  
4 317.152, 317.154, 317.267, 469.160, 469.165, 469.170, 469.172, 469.176 and 469.180; repealing sections 2  
5 and 6, chapter 739, Oregon Laws 2003; and prescribing an effective date."

6       Delete lines 5 through 16 and pages 2 through 12 and insert:

7       "**SECTION 1.** ORS 307.090 is amended to read:

8       "307.090. (1) Except as provided by law, all property of the state and all public or corporate  
9 property used or intended for corporate purposes of the several counties, cities, towns, school dis-  
10 tricts, irrigation districts, drainage districts, ports, water districts, housing authorities and all other  
11 public or municipal corporations in this state, is exempt from taxation.

12       "(2) Any city may agree with any school district to make payments in lieu of taxes on all  
13 property of the city located in any such school district, and which is exempt from taxation under  
14 subsection (1) of this section when such property is outside the boundaries of the city and owned,

1 used or operated for the production, transmission, distribution or furnishing of electric power or  
2 energy or electric service for or to the public.

3 **“(3)(a) Notwithstanding ORS 308.505 to 308.665, the property described in paragraph (b)**  
4 **of this subsection is exempt from taxation if the owner of the property described in para-**  
5 **graph (b) of this subsection is a city or public entity of a state other than Oregon and the**  
6 **city or public entity does not own a fee title interest in any real property in Oregon.**

7 **“(b) The property that is subject to exemption under paragraph (a) of this subsection is**  
8 **tangible or intangible property, property rights or property interests in or related to the**  
9 **Pacific Northwest AC Intertie, as referenced in a written capacity ownership agreement ex-**  
10 **ecuted before the effective date of this 2005 Act between the United States Department of**  
11 **Energy and the city or public entity described in paragraph (a) of this subsection.**

12 **“SECTION 2. (1) The amendments to ORS 307.090 by section 1 of this 2005 Act apply to:**

13 **“(a) Any tax year beginning on or after the date a written capacity ownership agreement**  
14 **described in ORS 307.090 (3) is executed; and**

15 **“(b) Any tax year beginning on or after July 1, 2005.**

16 **“(2) Notwithstanding subsection (1) of this section, nothing in this section or the**  
17 **amendments to ORS 307.090 by section 1 of this 2005 Act shall be construed as entitling a**  
18 **person to a refund of taxes paid prior to the effective date of this 2005 Act on any tangible**  
19 **or intangible property, property rights or property interests.**

20 **“SECTION 3. ORS 314.665 is amended to read:**

21 **“314.665. (1) As used in ORS 314.650, the sales factor is a fraction, the numerator of which is**  
22 **the total sales of the taxpayer in this state during the tax period, and the denominator of which is**  
23 **the total sales of the taxpayer everywhere during the tax period.**

24 **“(2) Sales of tangible personal property are in this state if:**

25 **“(a) The property is delivered or shipped to a purchaser, other than the United States Govern-**  
26 **ment, within this state regardless of the f.o.b. point or other conditions of the sale; or**

27 **“(b) The property is shipped from an office, store, warehouse, factory, or other place of storage**  
28 **in this state and [(A)] the purchaser is the United States Government or [(B)] the taxpayer is not**  
29 **taxable in the state of the purchaser. For purposes of this paragraph:**

30 **“(A) The sale of goods shipped from a public warehouse is not considered to take place**  
31 **in this state if:**

32 **“(i) The taxpayer’s only activity in Oregon is the storage of the goods in the public**  
33 **warehouse prior to shipment; or**

34 **“(ii) The taxpayer’s only activities in Oregon are the storage of the goods in the public**  
35 **warehouse prior to shipment and the presence of employees within this state solely for pur-**  
36 **poses of soliciting sales of the taxpayer’s products; and**

37 **“(B) ‘Taxpayer’ means a taxpayer as defined in section 7701 of the Internal Revenue Code,**  
38 **an affiliate of the person storing goods in a public warehouse or a person that is related**  
39 **under section 267 of the Internal Revenue Code to the person storing goods in a public**  
40 **warehouse.**

41 **“(3) Subsection (2)(b) of this section shall not apply to sales of tangible personal property if:**

42 **“(a) The sales are included in the numerator of a formula used to apportion business income to**  
43 **another state of the United States, a foreign country or the District of Columbia; and**

44 **“(b) The other state, a foreign country or the District of Columbia has imposed a tax on or**  
45 **measured by the apportioned business income.**

1 “(4) Sales, other than sales of tangible personal property, are in this state if (a) the income-  
2 producing activity is performed in this state; or (b) the income-producing activity is performed both  
3 in and outside this state and a greater proportion of the income-producing activity is performed in  
4 this state than in any other state, based on costs of performance.

5 “(5) Where the sales apportionment factor is determined by administrative rule pursuant to ORS  
6 314.682, 314.684, 317.660 or other law, the Department of Revenue shall adopt rules that are con-  
7 sistent with the determination of the sales factor under this section.

8 “(6) For purposes of this section, ‘sales’:

9 “(a) Excludes gross receipts arising from the sale, exchange, redemption or holding of intangible  
10 assets, including but not limited to securities, unless those receipts are derived from the taxpayer’s  
11 primary business activity.

12 “(b) Includes net gain from the sale, exchange or redemption of intangible assets not derived  
13 from the primary business activity of the taxpayer but included in the taxpayer’s business income.

14 “(c) Excludes gross receipts arising from an incidental or occasional sale of a fixed asset or  
15 assets used in the regular course of the taxpayer’s trade or business if a substantial amount of the  
16 gross receipts of the taxpayer arise from an incidental or occasional sale or sales of fixed assets  
17 used in the regular course of the taxpayer’s trade or business. Insubstantial amounts of gross re-  
18 cepts arising from incidental or occasional transactions or activities may be excluded from the sales  
19 factor unless the exclusion would materially affect the amount of income apportioned to this state.

20 “(7) **The department may determine that a warehouse that meets the definition of ‘public**  
21 **warehouse’ under this section may not be treated as a public warehouse if the warehouse is**  
22 **being used primarily for tax avoidance purposes or if transactions related to the use of the**  
23 **warehouse are primarily for tax avoidance purposes.**

24 “(8) As used in this section, ‘public warehouse’:

25 “(a) **Means a warehouse owned or operated by a person that does not own the goods**  
26 **stored in the warehouse; and**

27 “(b) **Does not include a warehouse that is owned by a person that is related to the person**  
28 **that owns goods that are stored in the warehouse, as determined under section 267 of the**  
29 **Internal Revenue Code, or an affiliate of the person that owns goods that are stored in the**  
30 **warehouse.**

31 “**SECTION 4. The amendments to ORS 314.665 by section 3 of this 2005 Act apply to tax**  
32 **years beginning on or after January 1, 2006.**

33 “**SECTION 5.** ORS 316.116 is amended to read:

34 “316.116. (1)(a) A resident individual shall be allowed a credit against the taxes otherwise due  
35 under this chapter for costs paid or incurred for construction or installation of an alternative energy  
36 device in a dwelling.

37 “(b) A resident individual shall be allowed a credit against the taxes otherwise due under this  
38 chapter for costs paid or incurred to modify or purchase an alternative fuel vehicle or related  
39 equipment.

40 “(c) **A resident individual shall be allowed a credit against the taxes otherwise due under**  
41 **this chapter for costs paid or incurred for construction or installation of a solar electric**  
42 **system in a dwelling.**

43 “(2)(a) Except in the case of an alternative fuel device **or a solar electric system**, the credit  
44 shall be based upon the first year energy yield of the alternative energy device that qualifies under  
45 ORS 469.160 to 469.180. The amount of the credit shall be the same whether for collective or non-

1 collective investment.

2 “(b) The credit allowed under this section for each dwelling shall not exceed the lesser of:

3 “(A) \$1,500 or the first year energy yield in kilowatt hours per year multiplied by 60 cents per  
4 dwelling utilizing the alternative energy device used for space heating, cooling, electrical energy or  
5 domestic water heating for tax years beginning on or after January 1, 1990, and before January 1,  
6 1996.

7 “(B) \$1,200 or the first year energy yield in kilowatt hours per year multiplied by 48 cents per  
8 dwelling utilizing the alternative energy device used for space heating, cooling, electrical energy or  
9 domestic water heating for tax years beginning on or after January 1, 1996, and before January 1,  
10 1998.

11 “(C) \$1,500 or the first year energy yield in kilowatt hours per year multiplied by 60 cents per  
12 dwelling utilizing the alternative energy device used for space heating, cooling, electrical energy or  
13 domestic water heating for tax years beginning on or after January 1, 1998.

14 “(c) For an alternative energy device used for swimming pool, spa or hot tub heating, the credit  
15 allowed under this section shall be based upon 50 percent of the cost of the device or the first year’s  
16 energy yield in kilowatt hours per year multiplied by 15 cents, whichever is lower, up to:

17 “(A) \$1,500 for tax years beginning on or after January 1, 1990, and before January 1, 1996.

18 “(B) \$1,200 for tax years beginning on or after January 1, 1996, and before January 1, 1998.

19 “(C) \$1,500 for tax years beginning on or after January 1, 1998.

20 “(d) For an alternative fuel device, the credit allowed under this section is 25 percent of the cost  
21 of the alternative fuel device but the total credit shall not exceed \$750 if the device is placed in  
22 service on or after January 1, 1998.

23 “(e)(A) **For a solar electric system, the credit allowed under this section shall equal \$3**  
24 **per watt of installed output, but the installed output that is used to determine the amount**  
25 **of credit under this paragraph may not exceed 2,000 watts.**

26 “(B) **Notwithstanding subparagraph (A) of this paragraph, the amount of the credit al-**  
27 **lowed in any one tax year may not exceed the tax liability of the taxpayer or \$1,500, which-**  
28 **ever is less. Unused credit amounts may be carried forward as provided in subsection (7) of**  
29 **this section, but may not be carried forward to a tax year that is more than five tax years**  
30 **following the first tax year for which any credit was allowed with respect to the solar electric**  
31 **system that is the basis for the credit.**

32 “(C) **Notwithstanding subparagraph (A) of this paragraph, the total amount of the credit**  
33 **allowed under this paragraph may not exceed 50 percent of the total installed cost of the**  
34 **solar electric system.**

35 “(3)(a) In the case of a credit for an alternative energy device that is an energy efficient appli-  
36 ance, the credit allowed to a resident individual under this section shall equal:

37 “(A) 48 cents per first year kilowatt hour saved, or the equivalent for other fuel saved, not to  
38 exceed \$1,200 for each tax year beginning on or after January 1, 1998, and before January 1, 1999;  
39 and

40 “(B) 40 cents per kilowatt hour saved, or the equivalent for other fuel saved, not to exceed  
41 \$1,000 for each tax year beginning on or after January 1, 1999.

42 “(b) Notwithstanding paragraph (a) of this subsection, the credit allowed for an energy efficient  
43 appliance shall not exceed 25 percent of the cost of the appliance.

44 “(4) To qualify for a credit under this section, all of the following are required:

45 “(a) The alternative energy device **or solar electric system** must be purchased, constructed,

1 installed and operated in accordance with ORS 469.160 to 469.180 and a certificate issued there-  
2 under.

3 “(b) Except for credits claimed for alternative fuel devices, the taxpayer who is allowed the  
4 credit must be the owner or contract purchaser of the dwelling or dwellings served by the alterna-  
5 tive energy device **or solar electric system** or the tenant of the owner or of the contract purchaser  
6 and must:

7 “(A) Use the dwelling or dwellings served by the alternative energy device **or solar electric**  
8 **system** as a principal or secondary residence; or

9 “(B) Rent or lease, under a residential rental agreement, the dwelling or dwellings to a tenant  
10 who uses the dwelling or dwellings as a principal or secondary residence, unless the basis for the  
11 credit is the installation of an energy efficient appliance. If the basis for the credit is the installation  
12 of an energy efficient appliance, the credit shall be allowed only to the taxpayer who actually oc-  
13 cupies the dwelling as a principal or secondary residence.

14 “(c) In the case of an alternative fuel device, if the device is a fueling station necessary to op-  
15 erate an alternative fuel vehicle, unless the verification form and certificate are transferred as au-  
16 thorized under ORS 469.170 (8), the taxpayer who is allowed the credit must be the contractor who  
17 constructs the dwelling that incorporates the fueling station into the dwelling or installs the fueling  
18 station in the dwelling. If the alternative energy device is an alternative fuel vehicle, the credit must  
19 be claimed by the owner as defined under ORS 801.375 or contract purchaser. If the alternative  
20 energy device is related equipment, the credit may be claimed by the owner or contract purchaser.

21 “(d) The credit must be claimed for the tax year in which the alternative energy device **or solar**  
22 **electric system** was purchased if the **device or** system is operational by April 1 of the next fol-  
23 lowing tax year.

24 “(5) The credit provided by this section [*shall*] **does** not affect the computation of basis under  
25 this chapter.

26 “(6) The credit allowed under this section in any one year [*shall*] **may** not exceed the tax li-  
27 ability of the taxpayer.

28 “(7) Any tax credit otherwise allowable under this section [*which*] **that** is not used by the tax-  
29 payer in a particular year may be carried forward and offset against the taxpayer’s tax liability for  
30 the next succeeding tax year. Any credit remaining unused in [*such*] **the** next succeeding tax year  
31 may be carried forward and used in the second succeeding tax year, and likewise any credit not used  
32 in that second succeeding tax year may be carried forward and used in the third succeeding tax  
33 year, and any credit not used in that third succeeding tax year may be carried forward and used in  
34 the fourth succeeding tax year, and any credit not used in that fourth succeeding tax year may be  
35 carried forward and used in the fifth succeeding tax year, but may not be carried forward for any  
36 tax year thereafter.

37 “(8) A nonresident shall be allowed the credit under this section in the proportion provided in  
38 ORS 316.117.

39 “(9) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or if the  
40 Department of Revenue terminates the taxpayer’s taxable year under ORS 314.440, the credit al-  
41 lowed by this section shall be prorated or computed in a manner consistent with ORS 314.085.

42 “(10) If a change in the status of a taxpayer from resident to nonresident or from nonresident  
43 to resident occurs, the credit allowed by this section shall be determined in a manner consistent  
44 with ORS 316.117.

45 “(11) A husband and wife who file separate returns for a taxable year may each claim a share

1 of the tax credit that would have been allowed on a joint return in proportion to the contribution  
2 of each. However, a husband or wife living in a separate principal residence may claim the tax  
3 credit in the same amount as permitted a single person.

4 “(12) As used in this section, unless the context requires otherwise:

5 “(a) ‘Collective investment’ means an investment by two or more taxpayers for the acquisition,  
6 construction and installation of an alternative energy device for one or more dwellings.

7 “(b) ‘First year energy yield’ has the meaning given in ORS 469.160.

8 “(c) ‘Noncollective investment’ means an investment by an individual taxpayer for the acqui-  
9 sition, construction and installation of an alternative energy device for one or more dwellings.

10 “(13) As used in this section, ‘taxpayer’ includes a transferee of a verification form under ORS  
11 469.170 (8).

12 “(14) Notwithstanding any provision of subsection (1) or (2) of this section, the sum of the credit  
13 allowed under subsection (1) of this section plus any similar credit allowed for federal income tax  
14 purposes shall not exceed the cost to the taxpayer for the acquisition, construction and installation  
15 of the alternative energy device **or solar electric system.**

16 “**SECTION 5a. A taxpayer may not be allowed a credit under ORS 316.116 if the first tax**  
17 **year for which the credit would otherwise be allowed with respect to an alternative energy**  
18 **device, solar electric system or alternative fuel vehicle or related equipment is on or after**  
19 **January 1, 2016.**

20 “**SECTION 6.** ORS 469.160 is amended to read:

21 “469.160. As used in ORS 316.116, 317.115 and 469.160 to 469.180:

22 “(1) ‘Alternative energy device’ means:

23 “(a) Any system, mechanism or series of mechanisms, including photovoltaic systems, that uses  
24 solar radiation or wind for space heating, cooling or electrical energy for one or more dwellings;

25 “(b) Any system that uses solar radiation for:

26 “(A) Domestic water heating; or

27 “(B) Swimming pool, spa or hot tub heating and that meets the requirements set forth in ORS  
28 316.116;

29 “(c) A ground water heat pump and ground loop system;

30 “(d) A wind powered turbine that generates electricity;

31 “(e) Any wind powered device used to offset or supplement the use of electricity by performing  
32 a specific task such as pumping water;

33 “(f) Equipment used in the production of alternative fuels;

34 “(g) A generator powered by alternative fuels and used to produce electricity;

35 “(h) A fuel cell;

36 “(i) An energy efficient appliance; or

37 “(j) An alternative fuel device.

38 “(2) ‘Alternative fuel device’ means any of the following:

39 “(a) An alternative fuel vehicle;

40 “(b) Related equipment; or

41 “(c) A fueling station necessary to operate an alternative fuel vehicle.

42 “(3) ‘Alternative fuel vehicle’ means a motor vehicle as defined in ORS 801.360 that is:

43 “(a) Registered in this state; and

44 “(b) Manufactured or modified to use an alternative fuel, including but not limited to electricity,  
45 natural gas, ethanol, methanol, propane and any other fuel approved in rules adopted by the Direc-

1 tor of the State Department of Energy that produces less exhaust emissions than vehicles fueled by  
2 gasoline or diesel. Determination that a vehicle is an alternative fuel vehicle shall be made without  
3 regard to energy consumption savings.

4 “(4) ‘Coefficient of performance’ means the ratio calculated by dividing the usable output energy  
5 by the electrical input energy. Both energy values must be expressed in equivalent units.

6 “(5) ‘Contractor’ means a person whose trade or business consists of offering for sale an alter-  
7 native energy device, construction service, installation service or design service.

8 “(6)(a) ‘Cost’ means the actual cost of the acquisition, construction and installation of the al-  
9 ternative energy device **or solar electric system** paid by the taxpayer for the alternative energy  
10 device **or solar electric system**.

11 “(b) For an alternative fuel vehicle, ‘cost’ means the difference between the cost of the alter-  
12 native fuel vehicle and the same vehicle or functionally similar vehicle manufactured to use con-  
13 ventional gasoline or diesel fuel or, in the case of modification of an existing vehicle, the cost of the  
14 modification. ‘Cost’ does not include any amounts paid for remodification of the same vehicle.

15 “(c) For a fueling station necessary to operate an alternative fuel vehicle, ‘cost’ means the cost  
16 to the contractor of constructing or installing the fueling station in a dwelling and of making the  
17 fuel station operational in accordance with the specifications issued under ORS 469.160 to 469.180  
18 and any rules adopted by the Director of the State Department of Energy.

19 “(d) For related equipment, ‘cost’ means the cost of the related equipment and any modifications  
20 or additions to the related equipment necessary to prepare the related equipment for use in con-  
21 verting a vehicle to alternative fuel use.

22 “(7) ‘Domestic water heating’ means the heating of water used in a dwelling for bathing, clothes  
23 washing, dishwashing and other related functions.

24 “(8) ‘Dwelling’ means real or personal property ordinarily inhabited as a principal or secondary  
25 residence and located within this state. ‘Dwelling’ includes, but is not limited to, an individual unit  
26 within multiple unit residential housing.

27 “(9) ‘Energy efficient appliance’ means a clothes washer, clothes dryer, water heater,  
28 refrigerator, freezer, dishwasher, appliance designed to heat or cool a dwelling or other major  
29 household appliance that has been certified by the State Department of Energy to have premium  
30 energy efficiency characteristics.

31 “(10) ‘First year energy yield’ of an alternative energy device is the usable energy produced  
32 under average environmental conditions in one year.

33 “(11) ‘Fueling station’ includes but is not limited to a compressed natural gas compressor fueling  
34 system or an electric charging system for vehicle power battery charging.

35 “(12) ‘Placed in service’ means:

36 “(a) The date an alternative energy device **or solar electric system** is ready and available to  
37 produce usable energy or save energy.

38 “(b) For an alternative fuel vehicle:

39 “(A) In the case of purchase, the date that the alternative fuel vehicle is first purchased as an  
40 alternative fuel vehicle ready and available for use.

41 “(B) In the case of modification, the date that the modification is completed and the vehicle is  
42 ready and available for use as an alternative fuel vehicle.

43 “(c) For a fueling station necessary to operate an alternative fuel vehicle, the date that the fu-  
44 eling station is first operational.

45 “(d) For related equipment, the date that the equipment is first operational.

1 “(13) ‘Related equipment’ means equipment necessary to convert a vehicle to use an alternative  
2 fuel.

3 “(14) ‘Solar electric system’ means any system, mechanism or series of mechanisms, in-  
4 cluding photovoltaic systems, that uses solar radiation to generate electrical energy for a  
5 dwelling.

6 “**SECTION 7.** ORS 469.165 is amended to read:

7 “469.165. (1) For the purposes of carrying out ORS 469.160 to 469.180, the State Department of  
8 Energy may adopt rules prescribing minimum performance criteria for alternative energy devices for  
9 dwellings **and solar electric systems.**

10 “(2) The department, in adopting rules under this section for solar heating and cooling systems,  
11 shall take into consideration applicable standards of federal performance criteria prescribed pursu-  
12 ant to the provisions of section 5506, title 42, United States Code (Solar Heating and Cooling Act  
13 of 1974).

14 “(3) The Director of the State Department of Energy shall adopt rules governing the determi-  
15 nation of eligibility, verification and certification of an alternative fuel device for purposes of the  
16 tax credits granted under ORS 316.116 and 317.115, including but not limited to rules that further  
17 define an alternative fuel vehicle, related equipment or fueling station necessary to operate an al-  
18 ternative fuel vehicle, that govern the computation of costs eligible for credit and that require eq-  
19 uitable allocation of the tax credit benefits between the lessor and the lessee of an alternative fuel  
20 vehicle as a condition of tax credit eligibility.

21 “**SECTION 8.** ORS 469.170 is amended to read:

22 “469.170. (1) Any person may claim a tax credit under ORS 316.116 (or ORS 317.115, if the per-  
23 son is a corporation) if the person:

24 “(a) Meets the requirements of ORS 316.116 (or ORS 317.115, if applicable);

25 “(b) Meets the requirements of ORS 469.160 to 469.180; and

26 “(c) Pays, subject to subsection (9) of this section, all or a portion of the costs of an alternative  
27 energy device **or a solar electric system.**

28 “(2) A credit under ORS 317.115 may be claimed only if the alternative energy device is a fueling  
29 station necessary to operate an alternative fuel vehicle.

30 “(3)(a) In order to be eligible for a tax credit under ORS 316.116 or 317.115, a person claiming  
31 a tax credit for construction or installation of an alternative energy device (including a fueling

40 venue and, if applicable, shall contain:

41 “(a) The location of the alternative energy device **or solar electric system;**

43 “(c) If the device **or system** was constructed or installed by a contractor, evidence that the  
44 contractor has any license, bond, insurance and permit required to sell and construct or install the

2 by the contractor that the applicant has received:

3 “(A) A statement of the reasonably expected energy savings of the device **or system**;

5 “(C) An operating manual for the alternative energy device **or solar electric system**; and

6 “(D) A copy of the contractor’s certification certificate or alternative energy device system  
7 certificate **for the alternative energy device or solar electric system**, as appropriate;

8 “(e) If the device **or system** was not constructed or installed by a contractor, evidence that:

9 “(A) The State Department of Energy has issued an alternative energy device system certificate  
10 for the **alternative energy device or solar electric system**; and

11 “(B) The taxpayer has obtained all building permits required for construction or installation of  
12 the device **or system**;

13 “(f) A statement, signed by both the taxpayer claiming the credit and the contractor if the de-  
14 vice **or system** was constructed or installed by a contractor, that the construction or installation  
15 meets all the requirements of ORS 469.160 to 469.180 or, if the device is a fueling station and the  
16 taxpayer is the contractor, a statement signed by the contractor that the construction or installation

14 adopt rules defining standards for eligible and ineligible devices under this section.  
15 “**SECTION 10.** ORS 469.176 is amended to read:  
16 “469.176. (1) Except for alternative fuel vehicles or related equipment, in order to carry out ORS  
17 469.160 to 469.180, the State Department of Energy shall develop performance assumptions and

13 but is not limited to, the costs of labor, materials, supplies, equipment rental, property acquisition,  
14 permits, engineering, financing, reasonable program delinquencies, return on investment, required  
15 fees, insurance, administration, accounting, depreciation, amortization, operation, maintenance, re-  
16 pair or replacement and debt service, including debt service payments or payments into reserve ac-  
17 counts for debt service and payment of amounts necessary to meet debt service coverage

20 exceed the actual cost incurred by a unit of government for design, construction and financing of  
21 a local improvement.

22 “(3) ‘Bonded indebtedness’ means any formally executed written agreement representing a  
23 promise by a unit of government to pay to another a specified sum of money, at a specified date or  
24 dates at least one year in the future.

25 “(4) ‘Capital construction’:

26 “(a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any  
27 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or  
28 contractually obligated to be spent prior to June 20, 1997, means the construction, modification,  
29 replacement, repair, remodeling or renovation of a structure, or addition to a structure, that is ex-  
30 pected to have a useful life of more than one year, and includes, but is not limited to:

31 “(A) Acquisition of land, or a legal interest in land, in conjunction with the capital construction  
32 of a structure.

33 “(B) Acquisition, installation of machinery or equipment, furnishings or materials that will be-  
34 come an integral part of a structure.

35 “(C) Activities related to the capital construction, including planning, design, authorizing, issu-  
36 ing, carrying or repaying interim or permanent financing, research, land use and environmental im-  
37 pact studies, acquisition of permits or licenses or other services connected with the construction.

38 “(D) Acquisition of existing structures, or legal interests in structures, in conjunction with the  
39 capital construction.

40 “(b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of  
41 any bonded indebtedness approved by electors prior to December 5, 1996, that were spent or  
42 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-  
43 graph (a) of this subsection, except that ‘capital construction’:

44 “(A) Includes public safety and law enforcement vehicles with a projected useful life of five  
45 years or more; and

1 “(B) Does not include:  
2 “(i) Maintenance and repairs, the need for which could be reasonably anticipated;  
3 “(ii) Supplies and equipment that are not intrinsic to the structure; or  
4 “(iii) Furnishings, unless the furnishings are acquired in connection with the acquisition, con-  
5 struction, remodeling or renovation of a structure, or the repair of a structure that is required be-  
6 cause of damage or destruction of the structure.  
7 “(5) ‘Capital improvements’:  
8 “(a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any  
9 bonded indebtedness approved by electors before December 5, 1996, that were spent or contractually  
10 obligated to be spent before June 20, 1997, means land, structures, facilities, as that term is defined  
11 in ORS 288.805, machinery, equipment or furnishings having a useful life longer than one year.  
12 “(b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of  
13 any bonded indebtedness approved by electors prior to December 5, 1996, that were spent or  
14 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-  
15 graph (a) of this subsection, except that ‘capital improvements’:  
16 “(A) Includes public safety and law enforcement vehicles with a projected useful life of five  
17 years or more; and  
18 “(B) Does not include:  
19 “(i) Maintenance and repairs, the need for which could be reasonably anticipated;  
20 “(ii) Supplies and equipment that are not intrinsic to the structure; or  
21 “(iii) Furnishings, unless the furnishings are acquired in connection with the acquisition, con-  
22 struction, remodeling or renovation of a structure, or the repair of a structure that is required be-  
23 cause of damage or destruction of the structure.  
24 “(6) ‘Direct consequence of ownership’ means that the obligation of the owner of property to pay  
25 a tax arises solely because that person is the owner of the property, and the obligation to pay the  
26 tax arises as an immediate and necessary result of that ownership without respect to any other in-  
27 tervening transaction, condition or event.  
28 “(7)(a) ‘Exempt bonded indebtedness’ means:  
29 “(A) Bonded indebtedness authorized by a specific provision of the Oregon Constitution;  
30 “(B) Bonded indebtedness incurred or to be incurred for capital construction or capital im-  
31 provements that was issued as a general obligation of the issuing governmental unit on or before  
32 November 6, 1990;  
33 “(C) Bonded indebtedness incurred or to be incurred for capital construction or capital im-  
34 provements that was issued as a general obligation of the issuing governmental unit after November  
35 6, 1990, with the approval of the electors of the issuing governmental unit; or  
36 “(D) Bonded indebtedness incurred or to be incurred for capital construction or capital im-  
37 provements, if the issuance of the bonds is approved by voters on or after December 5, 1996, in an  
38 election that is in compliance with the voter participation requirements of section 11 (8), Article  
39 XI of the Oregon Constitution.  
40 “(b) ‘Exempt bonded indebtedness’ includes bonded indebtedness issued to refund or refinance  
41 any bonded indebtedness described in paragraph (a) of this subsection.  
42 “(8)(a) ‘Incurred charge’ means a charge imposed by a unit of government on property or upon  
43 a property owner that does not exceed the actual cost of providing goods or services and that can  
44 be controlled or avoided by the property owner because:  
45 “(A) The charge is based on the quantity of the goods or services used, and the owner has direct

1 control over the quantity;

2 “(B) The goods or services are provided only on the specific request of the property owner; or

3 “(C) The goods or services are provided by the government unit only after the individual prop-  
4 erty owner has failed to meet routine obligations of ownership of the affected property, and such  
5 action is deemed necessary by an appropriate government unit to enforce regulations pertaining to  
6 health or safety.

7 “(b) For purposes of this subsection, an owner of property may control or avoid an incurred  
8 charge if the owner is capable of taking action to affect the amount of a charge that is or will be  
9 imposed or to avoid imposition of a charge even if the owner must incur expense in so doing.

10 “(c) For purposes of paragraph (a)(A) of this subsection, an owner of property has direct control  
11 over the quantity of goods or services if the owner of property has the ability, whether or not that  
12 ability is exercised, to determine the quantity of goods or services provided or to be provided.

13 “(9)(a) ‘Local improvement’ means a capital construction project, or part thereof, undertaken by  
14 a local government, pursuant to ORS 223.387 to 223.399, or pursuant to a local ordinance or resol-  
15 ution prescribing the procedure to be followed in making local assessments for benefits from a local  
16 improvement upon the lots that have been benefited by all or a part of the improvement:

17 “(A) That provides a special benefit only to specific properties or rectifies a problem caused by  
18 specific properties;

19 “(B) The costs of which are assessed against those properties in a single assessment upon the  
20 completion of the project; and

21 “(C) For which the property owner may elect to make payment of the assessment plus appro-  
22 priate interest over a period of at least 10 years.

23 “(b) For purposes of paragraph (a) of this subsection, the status of a capital construction project  
24 as a local improvement is not affected by the accrual of a general benefit to property other than the  
25 property receiving the special benefit.

26 “(10) ‘Maintenance and repairs, the need for which could be reasonably anticipated’:

27 “(a) Means activities, the type of which may be deducted as an expense under the provisions  
28 of the federal Internal Revenue Code, as amended and in effect on December 31, [2002] **2004**, that  
29 keep the property in ordinarily efficient operating condition and that do not add materially to the  
30 value of the property nor appreciably prolong the life of the property;

31 “(b) Does not include maintenance and repair of property that is required by damage, de-  
32 struction or defect in design, or that was otherwise not reasonably expected at the time the property  
33 was constructed or acquired, or the addition of material that is in the nature of the replacement of  
34 property and that arrests the deterioration or appreciably prolongs the useful life of the property;  
35 and

36 “(c) Does not include street and highway construction, overlay and reconstruction.

37 “(11) ‘Projected useful life’ means the useful life, as reasonably estimated by the unit of gov-  
38 ernment undertaking the capital construction or capital improvement project, beginning with the  
39 date the property was acquired, constructed or reconstructed and based on the property’s condition  
40 at the time the property was acquired, constructed or reconstructed.

41 “(12) ‘Routine obligations of ownership’ means a standard of operation, maintenance, use or care  
42 of property established by law, or if established by custom or common law, a standard that is rea-  
43 sonable for the type of property affected.

44 “(13) ‘Single assessment’ means the complete assessment process, including preassessment, as-  
45 sessment or reassessment, for any local improvement authorized by ORS 223.387 to 223.399, or a

1 local ordinance or resolution that provides the procedure to be followed in making local assessments  
2 for benefits from a local improvement upon lots that have been benefited by all or part of the im-  
3 provement.

4 “(14) ‘Special benefit only to specific properties’ shall have the same meaning as ‘special and  
5 peculiar benefit’ as that term is used in ORS 223.389.

6 “(15) ‘Specific request’ means:

7 “(a) An affirmative act by a property owner to seek or obtain delivery of goods or services;

8 “(b) An affirmative act by a property owner, the legal consequence of which is to cause the  
9 delivery of goods or services to the property owner; or

10 “(c) Failure of an owner of property to change a request for goods or services made by a prior  
11 owner of the property.

12 “(16) ‘Structure’ means any temporary or permanent building or improvement to real property  
13 of any kind that is constructed on or attached to real property, whether above, on or beneath the  
14 surface.

15 “(17) ‘Supplies and equipment intrinsic to a structure’ means the supplies and equipment that  
16 are necessary to permit a structure to perform the functions for which the structure was con-  
17 structed, or that will, upon installation, constitute fixtures considered to be part of the real property  
18 that is comprised, in whole or part, of the structure and land supporting the structure.

19 “(18) ‘Tax on property’ means any tax, fee, charge or assessment imposed by any government  
20 unit upon property or upon a property owner as a direct consequence of ownership of that property,  
21 but does not include incurred charges or assessments for local improvements. As used in this sub-  
22 section, ‘property’ means real or tangible personal property, and intangible property that is part of  
23 a unit of real or tangible personal property to the extent that such intangible property is subject  
24 to a tax on property.

25 “**SECTION 19.** ORS 310.630 is amended to read:

26 “310.630. As used in ORS 310.630 to 310.706:

27 “(1) ‘Contract rent’ means rental paid to the landlord for the right to occupy a homestead, in-  
28 cluding the right to use the personal property located therein. ‘Contract rent’ does not include  
29 rental paid for the right to occupy a homestead that is exempt from taxation, unless payments in lieu  
30 of taxes of 10 percent or more of the rental exclusive of fuel and utilities are made on behalf of the  
31 homestead. ‘Contract rent’ does not include advanced rental payments for another period and rental  
32 deposits, whether or not expressly set out in the rental agreement, or payments made to a nonprofit  
33 home for the elderly described in ORS 307.375. If a landlord and tenant have not dealt with each  
34 other at arm’s length, and the Department of Revenue is satisfied that the contract rent charged  
35 was excessive, it may adjust the contract rent to a reasonable amount for purposes of ORS 310.630  
36 to 310.706.

37 “(2) ‘Department’ means the Department of Revenue.

38 “(3) ‘Fuel and utility payments’ includes payments for heat, lights, water, sewer and garbage  
39 made solely to secure those commodities or services for the homestead of the taxpayer. ‘Fuel and  
40 utility payments’ does not include telephone service.

41 “(4) ‘Gross rent’ means contract rent paid plus the fuel and utility payments made for the  
42 homestead in addition to the contract rent, during the calendar year for which the claim is filed.

43 “(5) ‘Homestead’ means the taxable principal dwelling located in Oregon, either real or personal  
44 property, rented by the taxpayer, and the taxable land area of the tax lot upon which it is built.

45 “(6) ‘Household’ means the taxpayer, the spouse of the taxpayer and all other persons residing

1 in the homestead during any part of the calendar year for which a claim is filed.

2 “(7) ‘Household income’ means the aggregate income of the taxpayer and the spouse of the tax-  
3 payer who reside in the household, that was received during the calendar year for which the claim  
4 is filed. ‘Household income’ includes payments received by the taxpayer or the spouse of the tax-  
5 payer under the federal Social Security Act for the benefit of a minor child or minor children who  
6 are members of the household.

7 “(8) ‘Income’ means ‘adjusted gross income’ as defined in the federal Internal Revenue Code, as  
8 amended and in effect on December 31, [2002] **2004**, even when the amendments take effect or be-  
9 come operative after that date, relating to the measurement of taxable income of individuals, estates  
10 and trusts, with the following modifications:

11 “(a) There shall be added to adjusted gross income the following items of otherwise exempt in-  
12 come:

13 “(A) The gross amount of any otherwise exempt pension less return of investment, if any.

14 “(B) Child support received by the taxpayer.

15 “(C) Inheritances.

16 “(D) Gifts and grants, the sum of which are in excess of \$500 per year.

17 “(E) Amounts received by a taxpayer or spouse of a taxpayer for support from a parent who is  
18 not a member of the taxpayer’s household.

19 “(F) Life insurance proceeds.

20 “(G) Accident and health insurance proceeds, except reimbursement of incurred medical ex-  
21 penses.

22 “(H) Personal injury damages.

23 “(I) Sick pay which is not included in federal adjusted gross income.

24 “(J) Strike benefits excluded from federal gross income.

25 “(K) Worker’s compensation, except for reimbursement of medical expense.

26 “(L) Military pay and benefits.

27 “(M) Veteran’s benefits.

28 “(N) Payments received under the federal Social Security Act which are excluded from federal  
29 gross income.

30 “(O) Welfare payments, except as follows:

31 “(i) Payments for medical care, drugs and medical supplies, if the payments are not made di-  
32 rectly to the welfare recipient;

33 “(ii) In-home services authorized and approved by the Department of Human Services; and

34 “(iii) Direct or indirect reimbursement of expenses paid or incurred for participation in work  
35 or training programs.

36 “(P) Nontaxable dividends.

37 “(Q) Nontaxable interest not included in federal adjusted gross income.

38 “(R) Rental allowance paid to a minister that is excluded from federal gross income.

39 “(S) Income from sources without the United States that is excluded from federal gross income.

40 “(b) Adjusted gross income shall be increased due to the disallowance of the following de-  
41 ductions:

42 “(A) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intan-  
43 gible properties.

44 “(B) The amount of the net loss, in excess of \$1,000, from the operation of a farm or farms.

45 “(C) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,

1 profession or other activity entered into for the production or collection of income.

2 “(D) The amount of the net loss, in excess of \$1,000, from tangible or intangible property held  
3 for the production of rents, royalties or other income.

4 “(E) The amount of any net operating loss carryovers or carrybacks included in federal adjusted  
5 gross income.

6 “(F) The amount, in excess of \$5,000, of the combined deductions or other allowances for de-  
7preciation, amortization or depletion.

8 “(G) The amount added or subtracted, as required within the context of this section, for ad-  
9justments made under ORS 316.680 (2)(d) and 316.707 to 316.737.

10 “(c) ‘Income’ does not include any of the following:

11 “(A) Any governmental grant which must be used by the taxpayer for rehabilitation of the  
12 homestead of the taxpayer.

13 “(B) The amount of any payments made pursuant to ORS 310.630 to 310.706.

14 “(C) Any refund of Oregon personal income taxes that were imposed under ORS chapter 316.

15 “(9) ‘Payments for heat’ means those payments made to secure the commodities or services to  
16 be used as the principal source of heat for the homestead of the taxpayer and includes payments for  
17 natural gas, oil, firewood, coal, sawdust, electricity, steam or other materials that are capable of use  
18 as a primary source of heat for the homestead.

19 “(10) ‘Statement of gross rent’ means a declaration by the applicant, under penalties of false  
20 swearing, that the amount of contract rent and fuel and utility payments designated is the actual  
21 amount both incurred and paid during the year for which elderly rental assistance is claimed.

22 “(11) ‘Taxpayer’ means an individual who is a resident of this state on December 31 of the year  
23 for which elderly rental assistance is claimed and whose homestead, as of the same December 31  
24 and during all or a portion of the year ending on the same December 31, is rented and while rented  
25 is the subject, directly or indirectly, of property tax levied by this state or a political subdivision  
26 or of payments made in lieu of taxes.

27 “**SECTION 20.** ORS 310.800 is amended to read:

28 “310.800. (1) As used in this section:

29 “(a) ‘Authorized representative’ means a senior citizen who is authorized by a tax-exempt entity  
30 to perform charitable or public service on behalf of a senior citizen who has entered into a contract  
31 under subsection (2) of this section.

32 “(b) ‘Homestead’ means an owner-occupied principal residence.

33 “(c) ‘Senior citizen’ means a person who is 60 years of age or older.

34 “(d) ‘Tax-exempt entity’ means an entity that is exempt from federal income taxes under section  
35 501 (c) of the Internal Revenue Code, as amended and in effect on December 31, [2002] **2004**.

36 “(e) ‘Taxing unit’ means any county, city or common or union high school district, community  
37 college service district or community college district within this state with authority to impose ad  
38 valorem property taxes.

39 “(2) A tax-exempt entity may establish a property tax work-off program pursuant to which a  
40 senior citizen may contract to perform charitable or public service in consideration of payment of  
41 property taxes extended against the homestead of the senior citizen and billed to the senior citizen.  
42 For purposes of ORS chapters 316 and 656, and notwithstanding ORS 314.013 or 670.600 or other  
43 law, a senior citizen who enters into a contract under this subsection shall be considered an inde-  
44 pendent contractor and not a worker or employee with respect to the services performed pursuant  
45 to the contract. Nothing in this section precludes a taxing unit from being considered an employer,

1 for purposes of unemployment compensation under ORS chapter 657, of a senior citizen who enters  
2 into a contract under this section.

3 “(3) A taxing unit may enter into an agreement with a tax-exempt entity that has established a  
4 property tax work-off program. Pursuant to the agreement the taxing unit may accept, as volunteer  
5 and public service, the services of a senior citizen who has entered into a contract described in  
6 subsection (2) of this section or an authorized representative.

7 “(4) A taxing unit may provide funds or make grants to any tax-exempt entity that has estab-  
8 lished a property tax work-off program for use to carry out the program.

9 “**SECTION 21.** ORS 311.689 is amended to read:

10 “311.689. (1) Notwithstanding ORS 311.668 or any other provision of ORS 311.666 to 311.701, if  
11 the individual or, in the case of two or more individuals electing to defer property taxes jointly, all  
12 of the individuals together, or the spouse who has filed a claim under ORS 311.688, has federal ad-  
13 justed gross income that exceeds \$32,000 for the tax year that began in the previous calendar year,  
14 then for the tax year next beginning, the amount of taxes for which deferral is allowed shall be re-  
15 duced by \$0.50 for each dollar of federal adjusted gross income in excess of \$32,000.

16 “(2) Prior to June 1 of each year, and notwithstanding ORS 314.835, the Department of Revenue  
17 shall review returns filed under ORS chapter 314 and 316 to determine if subsection (1) of this sec-  
18 tion is applicable for a homestead for the tax year next beginning. If subsection (1) of this section  
19 is applicable, the department shall notify by mail the taxpayer or spouse electing deferral, and the  
20 taxes otherwise to be deferred for the tax year next beginning shall be reduced as provided in sub-  
21 section (1) of this section or, if federal adjusted gross income in excess of \$32,000 exceeds the  
22 amount of property taxes by a factor of two, the property taxes shall not be deferred.

23 “(3) If the taxpayer or spouse does not file a return for purposes of ORS chapters 314 and 316  
24 and the department has reason to believe that the federal adjusted gross income of the taxpayer or  
25 spouse exceeds \$32,000 for the tax year that began in the previous calendar year, the department  
26 shall notify by mail the taxpayer or spouse electing deferral. If, within 30 days after the notice is  
27 mailed, the taxpayer or spouse does not file a return under ORS chapter 314 or 316 or otherwise  
28 satisfy the department that federal adjusted gross income does not exceed \$32,000, the department  
29 shall again notify the taxpayer or spouse, and the taxes otherwise to be deferred for the tax year  
30 next beginning shall not be deferred.

31 “(4) For tax years beginning on or after July 1, 2002, the federal adjusted gross income limit set  
32 forth in subsections (1) to (3) of this section shall be recomputed by multiplying \$32,000 by the in-  
33 dexing factor described in ORS 311.668 (7)(a)(A), and rounding the amount so computed to the  
34 nearest multiple of \$500.

35 “(5) Nothing in this section shall affect the continued deferral of taxes that have been deferred  
36 for tax years beginning prior to the tax year next beginning or the right to deferral of taxes for a  
37 tax year beginning after the tax year next beginning if subsection (1) is not applicable for that tax  
38 year for the homestead.

39 “(6) As used in this section, ‘federal adjusted gross income’ means federal adjusted gross income  
40 of the individual or, in the case of two or more individuals electing to defer property tax jointly, the  
41 combined federal adjusted gross income of the individuals, or the federal adjusted gross income of  
42 the spouse who has filed a claim under ORS 311.688, all as determined for the tax year beginning  
43 in the calendar year prior to which a determination is required under subsection (2) of this section.  
44 ‘Federal adjusted gross income’ shall be determined under the Internal Revenue Code, as amended  
45 and in effect on December 31, [2002] **2004**, without any of the additions, subtractions or other mod-

1 ifications or adjustments required under ORS chapter 314 or 316.

2 “(7)(a) If, after an initial determination under this section has been made by the department,  
3 upon audit or examination or otherwise, it is discovered that the taxpayer or spouse had federal  
4 adjusted gross income in excess of the limitation provided under subsection (1) of this section, the  
5 department shall determine the amount of taxes deferred that should not have been deferred and  
6 give notice to the taxpayer or spouse of the amount of taxes that should not have been deferred.  
7 The provisions of ORS chapters 305 and 314 shall apply to a determination of the department under  
8 this section in the same manner as those provisions are applicable to an income tax deficiency. The  
9 amount of deferred taxes that should not have been deferred shall bear interest from the date paid  
10 by the department until paid at the rate established under ORS 305.220 for deficiencies. A deficiency  
11 shall not be assessed under this section if notice required under this section is not given to the  
12 taxpayer or spouse within three years after the date that the department has paid the deferred taxes  
13 to the county. Upon payment of the amount assessed as deficiency, and interest, the department  
14 shall execute a release in the amount of the payment and the release shall be conclusive evidence  
15 of the removal and extinguishment of the lien under ORS 311.666 to 311.701 to the extent of the  
16 payment.

17 “(b) If, after an initial determination under this section has been made by the department, upon  
18 claim for refund, audit or examination or otherwise, it is discovered that the taxpayer or spouse had  
19 federal adjusted gross income in the amount of or less than the limitation provided under subsection  
20 (1) of this section, the department shall determine the amount of taxes deferred that should have  
21 been deferred and give notice to the taxpayer or spouse of the amount of taxes that should have  
22 been deferred. The provisions of ORS chapters 305 and 314 shall apply to a determination of the  
23 department under this section in the same manner as those provisions are applicable to an income  
24 tax refund. The amount of the taxes that should have been deferred shall bear interest from the  
25 date paid by the taxpayer to the county at the rate established under ORS 305.220 for refunds until  
26 paid. Claim for refund under this paragraph must be filed within three years after the earliest date  
27 that the taxpayer or spouse is notified by the department that the taxes are not deferred.

28 “(8) This section applies to all tax-deferred property, notwithstanding that election to defer taxes  
29 is made under ORS 311.666 to 311.701 before or after October 3, 1989.

30 “**SECTION 22.** ORS 314.011 is amended to read:

31 “314.011. (1) As used in this chapter, unless the context requires otherwise, ‘department’ means  
32 the Department of Revenue.

33 “(2)(a) As used in this chapter, any term has the same meaning as when used in a comparable  
34 context in the laws of the United States relating to federal income taxes, unless a different meaning  
35 is clearly required or the term is specifically defined in this chapter.

36 “(b) Except where the Legislative Assembly has provided otherwise, a reference to the laws of  
37 the United States or to the Internal Revenue Code refers to the laws of the United States or to the  
38 Internal Revenue Code as they are amended and in effect:

39 “(A) On December 31, [2002] **2004**; or

40 “[B] *If related to the definition of taxable income and attributable to a change in the laws of the*  
41 *United States or in the Internal Revenue Code that is enacted after December 31, 2005, as applicable*  
42 *to the tax year of the taxpayer.*]

43 “[c] *A reference to the laws of the United States or to the Internal Revenue Code refers to the laws*  
44 *of the United States or to the Internal Revenue Code as they are amended and in effect and applicable*  
45 *for the tax year of the taxpayer, if the reference relates to:*]

1       “(A) Pension, profit-sharing or stock bonus plans, deferred compensation plans, employee stock  
2 ownership plans, individual retirement accounts (including Roth individual retirement accounts), med-  
3 ical savings accounts, education IRAs, qualified tuition savings programs or other tax-deferred or  
4 tax-exempt savings programs benefiting individuals; or]

5       “(B) The allowance and amount of a deduction under section 167 or 168 or another provision of  
6 the Internal Revenue Code, to the allowance and amount of a deduction for expensing depreciable as-

40 **“SECTION 60.** ORS 316.502, as amended by section 55 of this 2005 Act, is amended to read:

41 “316.502. (1) The net revenue from the tax imposed by this chapter, after deducting refunds, shall  
42 be paid over to the State Treasurer and held in the General Fund as miscellaneous receipts avail-  
43 able generally to meet any expense or obligation of the State of Oregon lawfully incurred.

44 “(2) A working balance of unreceipted revenue from the tax imposed by this chapter may be  
45 retained for the payment of refunds, but such working balance shall not at the close of any fiscal

1 year exceed the sum of \$1 million.

2 “(3) Moneys are continuously appropriated to the Department of Revenue to make:

3 “(a) The refunds authorized under subsection (2) of this section; and

4 “(b) The refund payments in excess of tax liability authorized under ORS 315.262 [and 315.266].

5 **“SECTION 61. The amendments to ORS 315.266 and 316.502 by sections 59 and 60 of this**  
6 **2005 Act apply to tax years beginning on or after January 1, 2011.**

7 **“SECTION 62. (1) Section 63 of this 2005 Act is added to and made a part of ORS 316.143**  
8 **to 316.146.**

9 **“(2) ORS 316.143 to 316.146 are added to and made a part of ORS chapter 315.**

10 **“SECTION 63. (1) A resident or nonresident individual who is certified as eligible under**  
11 **ORS 442.550 to 442.570 and who is certified as an emergency medical technician under ORS**  
12 **chapter 682 shall be allowed a credit against the taxes that are otherwise due under ORS**  
13 **chapter 316 if the Office of Rural Health certifies that the individual provides volunteer**  
14 **emergency medical technician services in a rural area that comprise at least 20 percent of**  
15 **the total emergency medical technician services provided by the individual in the tax year.**

16 **“(2) The amount of the credit shall equal \$250.**

17 **“(3) A nonresident shall be allowed the credit under this section in the proportion pro-**  
18 **vided in ORS 316.117. If a change in the status of a taxpayer from resident to nonresident**  
19 **or from nonresident to resident occurs, the credit allowed by this section shall be determined**  
20 **in a manner consistent with ORS 316.117.**

21 **“(4) As used in this section, ‘rural area’ means a geographic area that is located at least**  
22 **25 miles from any city with a population of 30,000 or more.**

23 **“SECTION 64. Section 65 of this 2005 Act is added to and made a part of ORS 442.550 to**  
24 **442.570.**

25 **“SECTION 65. The Office of Rural Health shall establish criteria for certifying individuals**  
26 **who are certified as emergency medical technicians under ORS chapter 682 as eligible for the**  
27 **tax credit authorized by section 63 of this 2005 Act. Upon application for the credit and upon**  
28 **a finding that the applicant will be providing emergency medical technician services in one**  
29 **or more rural areas and otherwise meets the eligibility criteria established by the office, the**  
30 **office shall certify the individual as eligible for the tax credit authorized by section 63 of this**  
31 **2005 Act.**

32 **“SECTION 66. Section 63 of this 2005 Act applies to tax credit certifications issued by the**  
33 **Office of Rural Health on or after January 1, 2006, and before January 1, 2011.**

34 **“SECTION 67. This 2005 Act takes effect on the 91st day after the date on which the**  
35 **regular session of the Seventy-third Legislative Assembly adjourns sine die.”.**
