

# Senate Bill 90

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Theodore R. Kulongoski for Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Abolishes Capitol Planning Commission. Transfers duties to Oregon Department of Administrative Services. Abolishes Capitol Planning Commission Account. Transfers moneys in account to department for deposit in Oregon Department of Administrative Services Operating Fund.

Declares emergency, effective June 30, 2005.

## A BILL FOR AN ACT

2 Relating to planning for state real property; creating new provisions; amending ORS 244.050, 276.010,  
3 276.028, 276.033, 276.035, 276.041, 276.046, 276.090, 276.096, 276.102, 276.106, 276.594, 291.224 and  
4 461.120 and section 1, chapter 989, Oregon Laws 2001, and sections 1, 27 and 30, chapter 796,  
5 Oregon Laws 2003; repealing ORS 276.008, 276.030, 276.031, 276.037, 276.039, 276.043 and 276.045;  
6 appropriating money; and declaring an emergency.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. (1) The Capitol Planning Commission is abolished. On the operative date of**  
9 **this section, the tenure of office of the members of the commission ceases.**

10 **(2) The duties, functions and powers of the commission are imposed upon, transferred**  
11 **to and vested in the Oregon Department of Administrative Services as provided in sections**  
12 **1 to 9 of this 2005 Act and the amendments to and the repeal of statutes by sections 10 to**  
13 **26 and 30 of this 2005 Act.**

14 **SECTION 2. (1) The chair of the Capitol Planning Commission shall:**

15 **(a) Deliver to the Director of the Oregon Department of Administrative Services the re-**  
16 **ords and property within the jurisdiction of the commission; and**

17 **(b) Transfer to the Oregon Department of Administrative Services those employees en-**  
18 **gaged primarily in the exercise of the duties, functions and powers transferred by section 1**  
19 **of this 2005 Act.**

20 **(2) The Director of the Oregon Department of Administrative Services shall take pos-**  
21 **session of the records and property and shall take charge of the employees and employ them**  
22 **in the exercise of the duties, functions and powers transferred by section 1 of this 2005 Act,**  
23 **without reduction of compensation but subject to change or termination of employment or**  
24 **compensation as provided by law.**

25 **(3) The Governor shall resolve a dispute that arises between the commission and the**  
26 **department relating to transfers of records, property and employees under this section. The**  
27 **decision of the Governor is final.**

28 **SECTION 3. (1) The Capitol Planning Commission Account is abolished on the operative**  
29 **date of section 1 of this 2005 Act.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1           (2) The Capitol Planning Commission shall transfer moneys remaining in the account to  
2 the Oregon Department of Administrative Services for deposit in the Oregon Department of  
3 Administrative Services Operating Fund on or before the operative date of section 1 of this  
4 2005 Act.

5           (3) The unexpended balances of amounts authorized to be expended by the commission  
6 for the biennium beginning July 1, 2005, from revenues dedicated, continuously appropriated,  
7 appropriated or otherwise made available for the purpose of administering and enforcing the  
8 duties, functions and powers transferred by section 1 of this 2005 Act are transferred to and  
9 dedicated, continuously appropriated, appropriated or otherwise made available to the de-  
10 partment for expenditure in the biennium beginning July 1, 2005, for the purpose of admin-  
11 istering and enforcing the duties, functions and powers transferred by section 1 of this 2005  
12 Act.

13           (4) The expenditure classifications, if any, established by Acts authorizing or limiting  
14 expenditures by the commission remain applicable to expenditures by the department under  
15 this section.

16           SECTION 4. The transfer of duties, functions and powers to the Oregon Department of  
17 Administrative Services by section 1 of this 2005 Act does not affect an action, proceeding  
18 or prosecution involving or with respect to the duties, functions and powers begun before  
19 and pending at the time of the transfer, except that the department is substituted for the  
20 Capitol Planning Commission in the action, proceeding or prosecution.

21           SECTION 5. (1) Nothing in sections 1 to 9 of this 2005 Act and the amendments to and  
22 the repeal of statutes by sections 10 to 26 and 30 of this 2005 Act relieves a person of a li-  
23 ability, duty or obligation accruing under or with respect to the duties, functions and powers  
24 transferred by section 1 of this 2005 Act. The Oregon Department of Administrative Services  
25 may undertake the collection or enforcement of the liability, duty or obligation.

26           (2) The rights and obligations of the Capitol Planning Commission legally incurred under  
27 contracts, leases or business transactions executed, entered into or begun before the opera-  
28 tive date of section 1 of this 2005 Act are transferred to the Oregon Department of Admin-  
29 istrative Services. For the purpose of succession to these rights and obligations, the  
30 department is a continuation of the commission and not a new authority.

31           SECTION 6. Notwithstanding the transfer of duties, functions and powers by section 1  
32 of this 2005 Act, the rules of the Capitol Planning Commission in effect on the operative date  
33 of section 1 of this 2005 Act continue in effect until superseded or repealed by rules of the  
34 Oregon Department of Administrative Services. References in rules of the commission to  
35 the commission or an officer or employee of the commission are considered to be references  
36 to the department or an officer or employee of the department.

37           SECTION 7. When, in an uncodified law or resolution of the Legislative Assembly or in  
38 a rule, document, record or proceeding authorized by the Legislative Assembly, reference is  
39 made to the Capitol Planning Commission or an officer or employee of the commission, the  
40 reference is considered to be a reference to the Oregon Department of Administrative Ser-  
41 vices or an officer or employee of the department.

42           SECTION 8. Section 9 of this 2005 Act is added to and made a part of ORS 276.093 to  
43 276.097.

44           SECTION 9. The Oregon Department of Administrative Services shall:

45           (1) Adopt standards for the development of state buildings and grounds, including but not

1 **limited to landscaping requirements, setback requirements, lot coverage limitations, building**  
 2 **height and bulk limitations, and requirements for the protection of the community environ-**  
 3 **ment;**

4 (2) **Develop a template for area plans for use by state agencies that own real property;**  
 5 **and**

6 (3) **Require state agencies to develop area plans and periodically update the plans.**

7 **SECTION 10.** ORS 276.010 is amended to read:

8 276.010. As used in ORS 276.028 to 276.062 [*and in this section, unless the context requires oth-*  
 9 *erwise*]:

10 (1) “Capitol area” means the capitol group of buildings and the grounds owned by the state ad-  
 11 jacent to the buildings, and includes any new buildings that may be constructed on the grounds as  
 12 an addition to the capitol group of buildings.

13 (2) “Capitol group of buildings” means the state buildings in Salem in and about the Capitol  
 14 Mall.

15 [(3) “Commission” means the Capitol Planning Commission.]

16 (3) **“Capitol Mall” means the area beginning at the northwest corner of State Street and**  
 17 **12th Street in the City of Salem, Marion County, Oregon; then continuing along 12th Street**  
 18 **in a northerly direction to Court Street; then continuing along Court Street in a westerly**  
 19 **direction to Capitol Street; then continuing along Capitol Street in a northerly direction to**  
 20 **D Street; then continuing along D Street in a westerly direction to Winter Street; then**  
 21 **continuing along Winter Street in a southerly direction to Court Street; then continuing**  
 22 **along Court Street in a westerly direction to Cottage Street; then continuing along Cottage**  
 23 **Street in a southerly direction to State Street; then continuing along State Street in an**  
 24 **easterly direction to the point of beginning.**

25 (4) “State agency” has the meaning given that term in ORS 358.635.

26 **SECTION 11.** ORS 276.028 is amended to read:

27 276.028. It is declared to be the purpose and policy of the State of Oregon to establish and  
 28 effectuate a long-range plan of development of the capitol area in the City of Salem, the areas im-  
 29 mediately surrounding state buildings situated outside the capitol area within the boundaries of the  
 30 Cities of Salem and Keizer[, *and the areas that are situated outside the boundaries of any incorporated*  
 31 *city in Marion or Polk Counties and that are immediately surrounding state buildings situated outside*  
 32 *of the boundaries of the cities of Salem and Keizer within the metropolitan area of the cities of Salem*  
 33 *and Keizer; and for that purpose] **and** to coordinate the acquisition and disposition of real property  
 34 and the construction of buildings by the state, the laying out of streets and the landscaping of  
 35 grounds in [*such*] **the** areas. The purpose of the **long-range** plan [*shall be*] **is** to enhance and pre-  
 36 serve the beauty and dignity of [*such*] **the** areas and permanently to secure [*such*] **the** areas from  
 37 commercial and industrial encroachment.*

38 **SECTION 12.** ORS 276.033 is amended to read:

39 276.033. [(1) *The Capitol Planning Commission.*] **The Oregon Department of Administrative**  
 40 **Services shall:**

41 [(a) *Shall establish, adopt and implement a plan of development of the areas described by ORS*  
 42 *276.028 and shall recommend to the Legislative Assembly any legislation necessary to effectuate the*  
 43 *plan.*]

44 [(b)] (1) [*Shall conduct continuing*] **Review on a continuing basis, in cooperation with other**  
 45 **affected state agencies,** studies and analyses[, *in cooperation with affected state agencies,*] of the

1 building needs of *[all]* state agencies located within the metropolitan area of the cities of Salem and  
 2 Keizer.

3 *[(c)]* **(2)** *[Shall establish, adopt and implement]* **Establish and maintain** a master plan for the  
 4 development of the capitol group of buildings situated within the **Capitol Mall**. *[area bordered by*  
 5 *State Street on the south and D Street on the north and Winter Street on the west and 12th Street*  
 6 *(between State Street and Court Street) and Capitol Street on the east.]*

7 *[(d)]* *Shall adopt standards for the development of state buildings and grounds, including but not*  
 8 *limited to landscaping requirements, setback requirements, lot coverage limitations, building height and*  
 9 *bulk limitations and requirements for the protection of the surrounding community environment.]*

10 *[(e)]* *May coordinate the disposition of state property only if the property is within an area plan*  
 11 *established under this section.]*

12 **(3) Maintain a coordination plan for state-owned real properties identified in ORS 276.028**  
 13 **that describes the relationship between the properties and between the properties and the**  
 14 **Cities of Salem and Keizer, including the effect of development of one or more of the prop-**  
 15 **erties or of the city on other properties or on the city.**

16 *[(2)(a)]* **(4)** *[The commission shall]* Cooperate and consult with local governmental agencies that  
 17 have jurisdiction within the areas described by ORS 276.028 for the purpose of coordinating the  
 18 development of state buildings and grounds in *[the]* **those** areas with community planning and de-  
 19 velopment programs in those areas.

20 *[(b)]* *If the commission establishes, adopts or implements a plan of development in an area that is*  
 21 *located within the boundaries of the City of Salem or the City of Keizer, the commission shall recom-*  
 22 *mend to the governing body of Salem or Keizer any legislation necessary to effectuate the plan.]*

23 **(5) Inform the governing body and the planning commission for the City of Salem about**  
 24 **the development plans prepared by the state for the capitol area.**

25 **SECTION 13.** ORS 276.035 is amended to read:

26 276.035. The *[Capitol Planning Commission]* **Oregon Department of Administrative Services**  
 27 shall:

28 (1) Investigate the advisability of additions to, reductions of or other changes in buildings and  
 29 grounds in the areas described *[by]* **in** ORS 276.028; **and**

30 (2) Investigate, review and make recommendations on all proposals of state agencies to add to,  
 31 reduce or otherwise change a building and grounds in the areas described *[by]* **in** ORS 276.028.];  
 32 *and]*

33 *[(3)]* *Advise the Oregon Department of Administrative Services on:]*

34 *[(a)]* *The planning and location of buildings in the areas described by ORS 276.028;]*

35 *[(b)]* *The development of the areas described by ORS 276.028, including but not limited to general*  
 36 *design, landscaping, traffic management, monuments, statues and fountains; and]*

37 *[(c)]* *All other matters connected with a proposed construction or development to be undertaken by*  
 38 *the state within the areas described by ORS 276.028.]*

39 **SECTION 14.** ORS 276.041 is amended to read:

40 276.041. (1) As the *[Capitol Planning Commission]* **Oregon Department of Administrative**  
 41 **Services** develops *[plans]* **a master plan** under ORS 276.033, the *[commission]* **department** shall  
 42 inform the governing body **and the planning commission** of the City of Salem *[and the Salem*  
 43 *planning commission of the plans]* **of the plan.**

44 (2) The *[Capitol Planning Commission]* **department** shall make all possible efforts to obtain the  
 45 cooperation of officers and commissions of the City of Salem for the purpose of establishing the

1 zoning of that part of the city contiguous to the capitol area that will effectuate the purpose of the  
2 State of Oregon to maintain its administrative buildings in a continuous and parklike area.

3 **SECTION 15.** ORS 276.046 is amended to read:

4 276.046. (1) The Oregon Department of Administrative Services may obtain title in the name of  
5 the State of Oregon **by purchase, agreement, donation or exercise of the power of eminent**  
6 **domain, for development as a part of the capitol area** to all land lying **within the Capitol Mall.**  
7 [*in the area bordered by Capitol and Winter Streets on the east and west and from Court Street on the*  
8 *south to D Street on the north, in the City of Salem, Marion County, Oregon, by purchase, agreement,*  
9 *donation or exercise of the power of eminent domain, for development as a part of the capitol area.*]

10 (2) From time to time, when offered at proper prices and from funds available through appro-  
11 priations for such purpose or through the Emergency Board, the [*Oregon Department of Adminis-*  
12 *trative Services*] **department** may purchase or acquire by agreement or donation, for development  
13 as a part of the capitol area, land lying [*in the area of the City of Salem bordered by Capitol and*  
14 *Winter Streets on the east and west and by Court Street on the south to D Street on the north*] **within**  
15 **the Capitol Mall.**

16 (3) The department may improve and develop the land acquired in a manner to accomplish the  
17 purpose and intent of ORS 276.028.

18 **SECTION 16.** ORS 276.090, as amended by section 8, chapter 796, Oregon Laws 2003, is  
19 amended to read:

20 276.090. (1) The Arts Program of the Economic and Community Development Department[, *the*  
21 *Capitol Planning Commission*] and the Oregon Department of Administrative Services, if the con-  
22 struction project is located within the area [*defined*] **described** in ORS 276.028, and the Arts Pro-  
23 gram of the Economic and Community Development Department, the Oregon Department of  
24 Administrative Services and the contracting agency if the project is located outside the area  
25 [*defined*] **described** in ORS 276.028, in consultation with the architect for the particular building  
26 shall determine the amount available for each state building and shall commission by contract or  
27 shall purchase suitable works of art for each building. The agencies designated by this section are  
28 solely responsible for selection, review of design, execution, placement and acceptance of [*all*] works  
29 of art acquired pursuant to ORS 276.073 to 276.090. The designated agencies, to the extent reason-  
30 able, shall consult with appropriate local citizens groups and the occupants of the affected state  
31 building in determining the selection of the works of art.

32 (2) Of the amount determined to be available for a state building under subsection (1) of this  
33 section, a portion may be assessed by the Arts Program of the Economic and Community Develop-  
34 ment Department and used to reimburse the program for [*any*] costs incurred under ORS 276.073 to  
35 276.090 as administrative expenses or as expenses for maintaining the works of art acquired. No  
36 more than 10 percent of the amount available for a state building may be assessed under this sub-  
37 section.

38 (3) Title to [*all*] works of art acquired pursuant to ORS 276.073 to 276.090 vests with the con-  
39 tracting agency in the name of the state. The agencies designated by this section may [*loan*] **lend**  
40 works of art between public buildings whenever in their judgment the loan will be to the benefit of  
41 the citizens of this state. However, [*all such*] **the works of art** shall be returned to the contracting  
42 agency at its request.

43 **SECTION 17.** ORS 276.096, as amended by section 10, chapter 796, Oregon Laws 2003, is  
44 amended to read:

45 276.096. (1) In carrying out the duties of the Director of the Oregon Department of Administra-

1 tive Services under ORS 276.095, the director shall consult with [*the Capitol Planning Commission,*]  
 2 the designated State Historic Preservation Officer, the Oregon Historical Society, the Arts Program  
 3 of the Economic and Community Development Department, local landmark commissions and historic  
 4 societies and the chief executive officers of those units of local government in each area served by  
 5 existing or proposed state offices and shall solicit the comments of [*any*] other community leaders  
 6 and members of the general public that the director considers appropriate.

7 (2) Whenever the director undertakes a review of state building needs within a geographical  
 8 area, the director shall request the cooperation of the state historic preservation officer to identify

13 276.102. (1) **The Executive Residence Account is established separate and distinct from**  
 14 **the General Fund. Interest earned on moneys in the account shall be credited to the account.**  
 15 **Moneys in the account are continuously appropriated to the Oregon Department of Admin-**  
 16 **istrative Services for the purpose of acquiring or constructing, remodeling, decorating,**  
 17 **landscaping, furnishing, equipping and maintaining a state executive residence.**

18 (2) The [*Capitol Planning Commission*] **department**, on behalf of the State of Oregon, may ac-  
 19 cept gifts, grants [*and*] **or** donations from public [*and*] **or** private sources, including gifts of real  
 20 [*and*] **or** personal property, for the purpose [*of the acquisition, construction, remodeling, decoration,*  
 21 *landscaping, furnishing, equipping and maintenance of a state executive residence. All*] **specified in**  
 22 **subsection (1) of this section. The department shall deposit** moneys received under this section  
 23 [*shall be placed in the Executive Residence Account, which account is hereby created, and continuously*  
 24 *appropriated to the Oregon Department of Administrative Services, to be used by the department on*  
 25 *behalf of the commission only for the purposes for which the moneys were given*] **in the account es-**  
 26 **tablished in subsection (1) of this section.**

27 **SECTION 19.** ORS 276.102, as amended by section 12, chapter 796, Oregon Laws 2003, is  
 28 amended to read:

29 276.102. (1) **The Executive Residence Account is established separate and distinct from**  
 30 **the General Fund. Interest earned on moneys in the account shall be credited to the account.**  
 31 **Moneys in the account are continuously appropriated to the Oregon Department of Admin-**  
 32 **istrative Services for the purpose of acquiring or constructing, remodeling, decorating,**  
 33 **landscaping, furnishing, equipping and maintaining a state executive residence.**

34 (2) The [*Capitol Planning Commission*] **department**, on behalf of the State of Oregon, may ac-  
 35 cept gifts, grants [*and*] **or** donations from public [*and*] **or** private sources, including gifts of real  
 36 [*and*] **or** personal property, for the purpose [*of the acquisition, construction, remodeling, decoration,*  
 37 *landscaping, furnishing, equipping and maintenance of a state executive residence. All*] **specified in**

43 276.106. [*If the Oregon Department of Administrative Services determines that architects are re-*  
 44 *quired to design, plan and oversee the construction of the state executive residence, the department shall*  
 45 *select the architects in a competition that is sanctioned by the American Institute of Architects, open*

1 to all architects registered in this state and based upon specifications prepared by the department. In-  
 2 sofar as practicable, Oregon products shall be used] **To the degree practicable, the Oregon De-**  
 3 **partment of Administrative Services shall use or ensure the use of Oregon products** in  
 4 constructing, remodeling, equipping, furnishing and decorating the state executive residence.

5 **SECTION 21.** ORS 276.106, as amended by section 14, chapter 796, Oregon Laws 2003, is  
 6 amended to read:

7 276.106. [*If the Capitol Planning Commission determines that architects are required to design,*  
 8 *plan and oversee the construction of the state executive residence, the commission shall select the ar-*  
 9 *chitects in a competition that is sanctioned by the American Institute of Architects, open to all archi-*  
 10 *tecs registered in this state and based upon specifications prepared by the Oregon Department of*  
 11 *Administrative Services. Insofar as practicable, Oregon products shall be used] **To the degree prac-***

12 **ticable, the Oregon Department of Administrative Services shall use or ensure the use of**  
 13 **Oregon products** in constructing, remodeling, equipping, furnishing and decorating the state exec-  
 14 utive residence.

15 **SECTION 22.** ORS 276.594 is amended to read:

16 276.594. (1) Except for parking facilities located in the garage of the State Capitol and in the  
 17 area immediately in front of the State Capitol, but south of Court Street, the Oregon Department  
 18 of Administrative Services shall also manage and determine under what conditions the grounds and  
 19 parking structures owned, leased, or being acquired through lease purchase or installment purchase  
 20 agreement by any state agency, which are located in the capitol area in the City of Salem, shall be  
 21 used. Such grounds and structures include those located either adjacent, on or in close proximity  
 22 to, though not necessarily contiguous to, leased office quarters defined in ORS 276.420, the Supreme  
 23 Court Building, the buildings or facilities defined in ORS 276.004 and those grounds owned by the  
 24 state by and through its Oregon Department of Administrative Services adjacent to the installations  
 25 and facilities located in the area [*defined*] **described** in ORS 276.028 except the State Capitol.  
 26 However, the department shall not exercise such authority over grounds or facilities that are owned,  
 27 directly leased, or being acquired through lease purchase or installment purchase by another state  
 28 agency which are outside of the capitol area in the City of Salem.

29 (2) Based upon its findings, the department shall adopt rules for parking of motor vehicles or  
 30 other transportation uses of such grounds and facilities for which it is responsible under subsection  
 31 (1) of this section. Notice of the rules shall be given by appropriate signs posted on the grounds and  
 32 in the facilities. In adopting the rules, the department shall consider the state policy stated in ORS  
 33 276.591.

34 (3) The department may lease portions of the facilities and grounds described in subsection (1)  
 35 of this section for the parking of motor vehicles and other transportation uses as it determines are  
 36 appropriate. However, in such leasing, priority shall first be given to the needs of state officers and  
 37 employees.

38 (4) The department shall furnish a space without charge to each statewide elective officer, ex-  
 39 cept those with offices in the State Capitol, and shall designate certain spaces, either free or me-  
 40 tered, for use by persons transacting business in state offices. The department may also provide free  
 41 parking for disabled employees who have been issued a disabled person parking permit by the De-  
 42 partment of Transportation and who require the use of their vehicle in traveling to and from work.  
 43 Any spaces not required for leasing to state officers and employees, or for other authorized pur-  
 44 poses, may be leased to other persons.

45 (5) Receipts obtained under this section shall be retained by the Oregon Department of Admin-

1 istrative Services, except that the net receipts from any parking facilities which are located in the  
 2 capitol area in the City of Salem and which are owned, directly leased, or being acquired through  
 3 lease purchase or installment purchase agreement by any agency other than the Oregon Department  
 4 of Administrative Services may be returned to the agency by the department.

5 **SECTION 23.** ORS 244.050 is amended to read:

6 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon  
 7 Government Standards and Practices Commission a verified statement of economic interest as re-  
 8 quired under this chapter:

9 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the  
 10 Bureau of Labor and Industries, Superintendent of Public Instruction, district attorneys and mem-  
 11 bers of the Legislative Assembly.

12 (b) Any judicial officer, including justices of the peace and municipal judges, except municipal  
 13 judges in those cities where a majority of the votes cast in the subject city in the 1974 general  
 14 election was in opposition to the ballot measure provided for in section 10, chapter 68, Oregon Laws  
 15 1974 (special session), and except any pro tem judicial officer who does not otherwise serve as a  
 16 judicial officer.

17 (c) Any candidate for an office designated in paragraph (a) or (b) of this subsection.

18 (d) The Deputy Attorney General.

19 (e) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the

 17        statement of economic interest as required under ORS 244.060, 244.070 and 244.090.
- 18        (3) By April 15 next after the filing date for the primary election, each candidate for elective  
 19        public office described in subsection (1) of this section shall file with the commission a statement  
 20        of economic interest as required under ORS 244.060, 244.070 and 244.090.
