

Senate Bill 213

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Attorney General Hardy Myers for Department of Justice)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Makes unlawful trade practice activities by unlicensed landscape and construction contractors.

2 Relating to unlawful trade practices by unlicensed building professionals; amending ORS 646.608.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 646.608 is amended to read:

5 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-
6 ness, vocation or occupation the person does any of the following:

7 (a) Passes off real estate, goods or services as those of another.

8 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
9 proval, or certification of real estate, goods or services.

10 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
11 ciation with, or certification by, another.

12 (d) Uses deceptive representations or designations of geographic origin in connection with real
13 estate, goods or services.

14 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
15 ingredients, uses, benefits, quantities or qualities that they do not have or that a person has a
16 sponsorship, approval, status, qualification, affiliation, or connection that the person does not have.

17 (f) Represents that real estate or goods are original or new if they are deteriorated, altered,
18 reconditioned, reclaimed, used or secondhand.

19 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
20 or that real estate or goods are of a particular style or model, if they are of another.

21 (h) Disparages the real estate, goods, services, property or business of a customer or another
22 by false or misleading representations of fact.

23 (i) Advertises real estate, goods or services with intent not to provide them as advertised, or
24 with intent not to supply reasonably expectable public demand, unless the advertisement discloses
25 a limitation of quantity.

26 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
27 or amounts of price reductions.

28 (k) Makes false or misleading representations concerning credit availability or the nature of the
29 transaction or obligation incurred.

30 (L) Makes false or misleading representations relating to commissions or other compensation to
31 be paid in exchange for permitting real estate, goods or services to be used for model or demon-

2 (m) Performs service on or dismantles any goods or real estate when not authorized by the
3 owner or apparent owner thereof.

4 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
5 vides the information required under ORS 646.611.

6 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
7 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
8 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
9 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
10 discount or other value is contingent upon occurrence of an event subsequent to the time the cus-
11 tomer enters into the transaction.

12 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
13 cize a product, business or service.

14 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
15 not to deliver them as promised.

16 (r) Organizes or induces or attempts to induce membership in a pyramid club.

17 (s) Makes false or misleading representations of fact concerning the offering price of, or the
18 person's cost for real estate, goods or services.

19 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
20 known material defect or material nonconformity.

21 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

22 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
23 ORS 698.640, whether in a commercial or noncommercial situation.

24 (w) Manufactures mercury fever thermometers.

25 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
26 law, or is:

27 (A) Prescribed by a person licensed under ORS chapter 677; and

28 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
29 on the proper cleanup of mercury should breakage occur.

30 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to
31 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be
32 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the
33 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-
