SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Increases number of members on Board of Radiologic Technology. **Requires at least one member to be limited permit holder.** Requires annual election of vice chairperson of board. Increases number of affirmative votes for board to take action.

A BILL FOR AN ACT

2 Relating to radiologic technology; creating new provisions; and amending ORS 688.545 and 688.595.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 688.545 is amended to read:

5 688.545. (1)(a) There is created in the Department of Human Services a Board of Radiologic
6 Technology consisting of [*seven*] **nine** members who shall be appointed by the Governor. Each
7 member of the board shall be a citizen of the United States and a resident of the State of Oregon.
8 [*One member shall be a radiologist. One member shall be a lay person. Five members shall be licensed*
9 *practicing radiologic technologists, one of whom shall be a radiation therapist. Each appointed member*
10 *shall be entitled to vote.*] **Each appointed member is entitled to vote.**

11 **(b) Of the members of the board:**

12 **(A) One shall be a radiologist;**

13 **(B) At least one shall be a lay person;**

14 **(C) At least one shall be a limited permit holder; and**

15 **(D) At least five shall be licensed practicing radiologic technologists, one of whom shall**
16 **be a radiation therapist.**

17 (2) The [*Director*] **section manager** of the Radiation [*Control*] **Protection Services** Section of
18 the Department of Human Services, or a person appointed by the [*director*] **section manager**, shall
19 be an advisory member of the board for the purpose of providing counsel and shall not be entitled
20 to vote.

21 (3) The term of office of the members of the board shall be three years and a member may be
22 reappointed to serve not more than two full terms.

23 (4) Members of the board shall be entitled to compensation and expenses as provided in ORS
24 292.495.

25 (5) The board shall annually elect [*the*] **a board chairperson and a vice chairperson** from the
26 members of the board.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (6) For the purpose of transacting its business, the board shall meet at least once every three
2 months at times and places designated by resolution. Special meetings may also be held at such
3 times as the board may elect or at the call of the chairperson. [A *written notice*] **Notification** of the
4 time, place and purpose of any special meeting shall be [*mailed*] **sent** to all members of the board
5 at least 15 days before the date of the meeting. All meetings are subject to ORS 192.610 to 192.690.

6 (7) [*Four*] **Five** members of the board shall constitute a quorum for the transaction of business
7 at any meeting. [*Four*] **Five** affirmative votes shall be required to take action.

8 **SECTION 2. Notwithstanding the term of office specified in ORS 688.545, of the two**
9 **members added to the Board of Radiologic Technology by the amendments to ORS 688.545**
10 **by section 1 of this 2005 Act:**

11 (1) **One shall serve for a term ending December 31, 2006.**

12 (2) **One shall serve for a term ending December 31, 2007.**

13 **SECTION 3.** ORS 688.595 is amended to read:

14 688.595. The [*Director*] **section manager** of the Radiation [*Control*] **Protection Services** Section
15 of the Department of Human Services shall enforce the provisions of ORS 688.405 to 688.605 and
16 shall conduct, under the direction of the Board of Radiologic Technology, inspections in furtherance
17 of the purposes of ORS 688.405 to 688.605.
