

SENATE AMENDMENTS TO SENATE BILL 230

1 On page 2 of the printed bill, line 16, after “attorney” insert “and make any other inquiries as
2 are appropriate to assist the guardian ad litem in making decisions in the juvenile court
3 proceeding”.

4 Delete line 17 and insert:

5 “(b) Make legal decisions that the parent would ordinarily make concerning the juvenile court
6 proceeding including, but not limited to, whether to:

7 “(A) Admit or deny the allegations of any petition;

8 “(B) Agree to or contest jurisdiction, wardship, temporary commitment, guardianship or perma-
9 nent commitment;

10 “(C) Accept or decline a conditional postponement; or

11 “(D) Agree to or contest specific services or placement.

12 “(c) Make”.

13 In line 21, delete “(c)” and insert “(d)”.

14 In line 23, delete “(d)” and insert “(e)”.

15 Delete lines 29 through 31 and insert:

16 “(5) The parent’s attorney shall follow directions provided by the guardian ad litem on decisions
17 that are ordinarily made by the parent. The parent’s attorney shall in-”.

18 On page 3, line 3, delete “case” and insert “juvenile court proceeding”.
