

SENATE AMENDMENTS TO SENATE BILL 328

By COMMITTEE ON BUSINESS AND ECONOMIC DEVELOPMENT

1 On page 1 of the printed bill, line 6, after “a” insert “residential”.

2 Delete line 15 and insert “selling, exchanging, installing or offering for rent, lease, sale, ex-
3 change or installation a residential prefabricated structure”.

4 In line 20, delete “who”.

5 Delete lines 21 and 22 and insert “to perform prefabricated structure plan approvals or in-
6 spections unless the person providing the plan approvals or inspections is certified or approved un-
7 der subsection (2) of this section or is providing plan approvals or inspections for a residential
8 prefabricated structure that is intended for delivery in another state.”.

9 In line 25, after “a” insert “residential”.

10 On page 2, delete lines 32 through 38.

11 On page 3, line 8, after “exchange” insert “, install” and after “sale” insert a comma.

12 In line 9, delete the first “or” and after “exchange” insert “or installation”.

13 In line 12, after the period insert “The prohibition in this subsection does not apply to a resi-
14 dential prefabricated structure intended for delivery in another state unless the residential prefab-
15 ricated structure is installed or offered for installation in this state.”.

16 On page 7, line 25, after “is” insert “designed for residential use and”.

17 On page 8, line 12, after “is” insert “designed for residential use and”.

18 After line 27, insert:

19 **“SECTION 6. (1) The Department of Consumer and Business Services shall collect the**
20 **information, if any, supplied by industry sources in this state regarding the manufacture of**
21 **prefabricated structures intended for delivery in other states. The types of information to**
22 **be collected by the department shall include:**

23 **“(a) The applied and potential capacity of manufacturers to produce residential prefabri-**
24 **cated structures in this state;**

25 **“(b) The number of persons the manufacturer employs in this state to produce residential**
26 **prefabricated structures intended for delivery in other states;**

27 **“(c) The number of residential prefabricated structures produced in this state intended**
28 **for delivery in other states; and**

29 **“(d) Any information the department determines to be useful for assessing the effect or**
30 **potential effect of section 2 of this 2005 Act on employment levels in this state.**

31 **“(2) The department shall biennially report any information collected by the department**
32 **under this section to the Legislative Assembly. The department shall submit the report to**
33 **the Legislative Assembly as provided in ORS 192.245 no later than October 1 of each even-**
34 **numbered year.”.**

35 In line 28, delete “6” and insert “7”.

1 After line 30, insert:
2 "**SECTION 8. Section 6 of this 2005 Act is repealed January 2, 2012.**"
