

SENATE AMENDMENTS TO SENATE BILL 755

1 On page 1 of the printed bill, delete lines 5 through 14 and insert:

2 **“SECTION 1. (1) As used in this section:**

3 **“(a) ‘Disciplinary records’ means the public records related to a personnel discipline**
4 **action or materials or documents supporting that action.**

5 **“(b) ‘School district’ means:**

6 **“(A) A school district as defined in ORS 332.002.**

7 **“(B) The Oregon State School for the Blind.**

8 **“(C) The Oregon State School for the Deaf.**

9 **“(D) An educational program under the Youth Corrections Education Program.**

10 **“(E) A public charter school as defined in ORS 338.005.**

11 **“(F) An education service district as defined in ORS 334.003.**

12 **“(G) Any state-operated program that provides educational services to kindergarten**
13 **through grade 12 students.**

14 **“(2) The disciplinary records of a school district employee convicted of a crime listed in**
15 **ORS 342.143 are not exempt from disclosure under ORS 192.501 or 192.502. When a school**
16 **district employee is convicted of a crime listed in ORS 342.143, the district that is the em-**
17 **ployer of the employee shall disclose the disciplinary records of the employee to any person**
18 **upon request.**

19 **“(3) Prior to disclosure of a disciplinary record under subsection (2) of this section, a**
20 **school district shall remove any personally identifiable information from the record that**
21 **would disclose the identity of a child, a crime victim or a school district employee who is not**
22 **the subject of the disciplinary record.**

23 **“SECTION 2. (1) As used in this section:**

24 **“(a) ‘Disciplinary records’ means the records related to a personnel discipline action or**
25 **materials or documents supporting that action.**

26 **“(b) ‘Private school’ means a school that provides educational services as defined in ORS**
27 **345.505 to kindergarten through grade 12 students.**

28 **“(2) When a private school employee is convicted of a crime listed in ORS 342.143, the**
29 **private school that is the employer of the employee shall disclose the disciplinary records**
30 **of the employee to any person upon request.**

31 **“(3) Prior to disclosure of a disciplinary record under subsection (2) of this section, a**
32 **private school shall remove any personally identifiable information from the record that**
33 **would disclose the identity of a child, a crime victim or a private school employee who is not**
34 **the subject of the disciplinary record.”.**

35 In line 15, delete “2” and insert “3”.

1 On page 3, line 1, delete “3” and insert “4”.

2 In line 10, delete “4” and insert “5”.
