SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Expands crimes of criminal mistreatment in first degree and child neglect in first degree.

Expands definition of "abuse" for purposes of child abuse reporting laws.

[Requires health care providers to provide protected health information to law enforcement agencies and Department of Human Services under certain circumstances.]

Permits court to suspend or terminate parent's parenting time if court finds that parent has abused controlled substances and parenting time is not in best interests of child.

[Directs Attorney General to hire three persons to investigate and prosecute crimes involving methamphetamine. Appropriates moneys to Department of Justice from General Fund. Increases other fund expenditure limitation for department.]

Creates separate crimes for manufacture, delivery and possession of methamphetamine, cocaine, heroin, marijuana and 3,4 methylenedioxymethamphetamine.

Modifies sentencing provisions relating to unlawful manufacture, delivery or possession of controlled substances.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 163.205 is amended to read:

8 163.205. (1) A person commits the crime of criminal mistreatment in the first degree if:

9 (a) The person, in violation of a legal duty to provide care for another person, or having as-
10 sumed the permanent or temporary care, custody or responsibility for the supervision of another
11 person, intentionally or knowingly withholds necessary and adequate food, physical care or medical
12 attention from that other person; or

13 (b) The person, in violation of a legal duty to provide care for a dependent person or elderly
14 person, or having assumed the permanent or temporary care, custody or responsibility for the
15 supervision of a dependent person or elderly person, intentionally or knowingly:

16 (A) Causes physical injury or injuries to the dependent person or elderly person;

17 (B) Deserts the dependent person or elderly person in a place with the intent to abandon that
18 person;

19 (C) Leaves the dependent person or elderly person unattended at a place for such a period of
20 time as may be likely to endanger the health or welfare of that person;

New sections are in **boldfaced** type.

1 (D) Hides the dependent person's or elderly person's money or property or takes the money or
2 property for, or appropriates the money or property to, any use or purpose not in the due and lawful
3 execution of the person's responsibility; [or]

4 (E) Takes charge of a dependent or elderly person for the purpose of fraud; or

5 **(F) Leaves the dependent person or elderly person, or causes the dependent person or**
6 **elderly person to enter or remain, in or upon premises where a chemical reaction involving**
7 **one or more precursor substances:**

8 (i) **Is occurring as part of unlawfully manufacturing a controlled substance or grinding,**
9 **soaking or otherwise breaking down a precursor substance for the unlawful manufacture of**
10 **a controlled substance; or**

11 (ii) **Has occurred as part of unlawfully manufacturing a controlled substance or grinding,**
12 **soaking or otherwise breaking down a precursor substance for the unlawful manufacture of**
13 **a controlled substance and the premises have not been certified as fit for use under ORS**
14 **453.885.**

15 (2) As used in this section:

16 (a) **"Controlled substance" has the meaning given that term in ORS 475.005.**

17 [(a)] (b) "Dependent person" means a person who because of either age or a physical or mental
18 disability is dependent upon another to provide for the person's physical needs.

19 [(b)] (c) "Elderly person" means a person 65 years of age or older.

20 [(c)] (d) "Legal duty" includes but is not limited to a duty created by familial relationship, court
21 order, contractual agreement or statutory or case law.

22 (e) **"Precursor substance" has the meaning given that term in ORS 475.940.**

23 (3) Criminal mistreatment in the first degree is a Class C felony.

24 **SECTION 2.** ORS 163.547 is amended to read:

25 163.547. (1)(a) A person having custody or control of a child under 16 years of age commits the
26 crime of child neglect in the first degree if the person knowingly leaves the child, or allows the child
27 to stay:

28 (A) In a vehicle where controlled substances are being criminally delivered or manufactured;

29 (B) [On] **In or upon** premises and in the immediate proximity where controlled substances are
30 criminally delivered or manufactured for consideration or profit **or where a chemical reaction**
31 **involving one or more precursor substances:**

32 (i) **Is occurring as part of unlawfully manufacturing a controlled substance or grinding,**
33 **soaking or otherwise breaking down a precursor substance for the unlawful manufacture of**
34 **a controlled substance; or**

35 (ii) **Has occurred as part of unlawfully manufacturing a controlled substance or grinding,**
36 **soaking or otherwise breaking down a precursor substance for the unlawful manufacture of**
37 **a controlled substance and the premises have not been certified as fit for use under ORS**
38 **453.885; or**

39 (C) In or upon premises that have been determined to be not fit for use under ORS 453.855 to
40 453.912.

41 (b) As used in this subsection, "vehicle" and "premises" do not include public places, as defined
42 in ORS 161.015.

43 (2) Child neglect in the first degree is a Class B felony.

44 (3) Subsection (1) of this section does not apply if the controlled substance is marijuana and is
45 delivered for no consideration.

1 **(4) The Oregon Criminal Justice Commission shall classify child neglect in the first de-**
2 **gree as crime category 6 of the sentencing guidelines grid of the commission if the controlled**
3 **substance being delivered or manufactured is methamphetamine.**

5 163.505. As used in ORS 163.505 to 163.575, unless the context requires otherwise:

6 **(1) “Controlled substance” has the meaning given that term in ORS 475.005.**

7 ~~[(1)]~~ **(2)** “Descendant” includes persons related by descending lineal consanguinity, step-children
8 and lawfully adopted children.

9 **(3) “Precursor substance” has the meaning given that term in ORS 475.940.**

10 ~~[(2)]~~ **(4)** “Support” includes, but is not limited to, necessary and proper shelter, food, clothing,
11 medical attention and education.

12 **SECTION 4.** ORS 419B.005 is amended to read:

13 419B.005. As used in ORS 418.747, 418.748, 418.749 and 419B.005 to 419B.050, unless the context
14 requires otherwise:

15 (1)(a) “Abuse” means:

16 (A) Any assault, as defined in ORS chapter 163, of a child and any physical injury to a child
17 which has been caused by other than accidental means, including any injury which appears to be
18 at variance with the explanation given of the injury.

19 (B) Any mental injury to a child, which shall include only observable and substantial impairment
20 of the child’s mental or psychological ability to function caused by cruelty to the child, with due
21 regard to the culture of the child.

22 (C) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-
23 tration and incest, as those acts are defined in ORS chapter 163.

24 (D) Sexual abuse, as defined in ORS chapter 163.

25 (E) Sexual exploitation, including but not limited to:

26 (i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any
27 other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage
28 in the performing for people to observe or the photographing, filming, tape recording or other ex-
29 hibition which, in whole or in part, depicts sexual conduct or contact, as defined in ORS 167.002 or
30 described in ORS 163.665 and 163.670, sexual abuse involving a child or rape of a child, but not in-
31 cluding any conduct which is part of any investigation conducted pursuant to ORS 419B.020 or
32 which is designed to serve educational or other legitimate purposes; and

33 (ii) Allowing, permitting, encouraging or hiring a child to engage in prostitution, as defined in
34 ORS chapter 167.

35 (F) Negligent treatment or maltreatment of a child, including but not limited to the failure to
36 provide adequate food, clothing, shelter or medical care that is likely to endanger the health or
37 welfare of the child.

38 (G) Threatened harm to a child, which means subjecting a child to a substantial risk of harm
39 to the child’s health or welfare.

40 (H) Buying or selling a person under 18 years of age as described in ORS 163.537.

41 (I) Permitting a person under 18 years of age to enter or remain in *[a place]* **or upon premises**
42 where methamphetamines are being manufactured.

43 **(J) Unlawful exposure to a controlled substance, as defined in ORS 475.005, that subjects**
44 **a child to a substantial risk of harm to the child’s health or safety.**

45 (b) “Abuse” does not include reasonable discipline unless the discipline results in one of the

1 conditions described in paragraph (a) of this subsection.

2 (2) "Child" means an unmarried person who is under 18 years of age.

3 (3) "Public or private official" means:

4 (a) Physician, including any intern or resident.

5 (b) Dentist.

6 (c) School employee.

7 (d) Licensed practical nurse or registered nurse.

8 (e) Employee of the Department of Human Services, State Commission on Children and Families,
9 Child Care Division of the Employment Department, the Oregon Youth Authority, a county health
10 department, a community mental health and developmental disabilities program, a county juvenile
11 department, a licensed child-caring agency or an alcohol and drug treatment program.

12 (f) Peace officer.

13 (g) Psychologist.

14 (h) Member of the clergy.

15 (i) Licensed clinical social worker.

16 (j) Optometrist.

17 (k) Chiropractor.

18 (L) Certified provider of foster care, or an employee thereof.

19 (m) Attorney.

20 (n) Naturopathic physician.

21 (o) Licensed professional counselor.

22 (p) Licensed marriage and family therapist.

33 **SECTION 6.** ORS 107.135 is amended to read:

34 107.135. (1) The court may at any time after a judgment of annulment or dissolution of marriage
35 or of separation is granted, upon the motion of either party and after service of notice on the other
36 party in the manner provided by ORCP 7, and after notice to the Division of Child Support when
37 required under subsection (9) of this section:

38 (a) Set aside, alter or modify any portion of the judgment that provides for the appointment and
39 duties of trustees, for the custody, parenting time, visitation, support and welfare of the minor
40 children and the children attending school, as defined in ORS 107.108, including any health or life
41 insurance provisions, for the support of a party or for life insurance under ORS 107.820 or 107.830;

42 (b) Make an order, after service of notice to the other party, providing for the future custody,
43 support and welfare of minor children residing in the state, who, at the time the judgment was given,
44 were not residents of the state, or were unknown to the court or were erroneously omitted from the
45 judgment;

1 (c) Terminate a duty of support toward any minor child who has become self-supporting,
2 emancipated or married;

3 (d) After service of notice on the child in the manner provided by law for service of a summons,
4 suspend future support for any child who has ceased to be a child attending school as defined in
5 ORS 107.108; and

6 (e) Set aside, alter or modify any portion of the judgment that provides for a property award
7 based on the enhanced earning capacity of a party that was awarded before October 23, 1999. A
8 property award may be set aside, altered or modified under this paragraph:

9 (A) When the person with the enhanced earning capacity makes a good faith career change that
10 results in less income;

11 (B) When the income of the person with the enhanced earning capacity decreases due to cir-
12 cumstances beyond the person's control; or

13 (C) Under such other circumstances as the court deems just and proper.

14 (2) When a party moves to set aside, alter or modify the child support provisions of the judg-
15 ment:

16 (a) The party shall state in the motion, to the extent known:

17 (A) Whether there is pending in this state or any other jurisdiction any type of support pro-
18 ceeding involving children of the marriage, including one brought under ORS 25.287, 107.431,
19 109.100, 125.025, 416.400 to 416.470, 419B.400 or 419C.590 or ORS chapter 110; and

20 (B) Whether there exists in this state or any other jurisdiction a support order, as defined in
21 ORS 110.303, involving children of the marriage, other than the judgment the party is moving to set
22 aside, alter or modify.

23 (b) The party shall include with the motion a certificate regarding any pending support pro-
24 ceeding and any existing support order other than the judgment the party is moving to set aside,
25 alter or modify. The party shall use a certificate that is in a form established by court rule and in-
26 clude information required by court rule and paragraph (a) of this subsection.

27 (3) In a proceeding under this section to reconsider the spousal or child support provisions of
28 the judgment, the following provisions apply:

29 (a) A substantial change in economic circumstances of a party, which may include, but is not
30 limited to, a substantial change in the cost of reasonable and necessary expenses to either party, is
31 sufficient for the court to reconsider its order of support, except that an order of compensatory
32 spousal support may only be modified upon a showing of an involuntary, extraordinary and unan-
33 ticipated change in circumstances that reduces the earning capacity of the paying spouse.

34 (b) If the judgment provided for a termination or reduction of spousal support at a designated
35 age in anticipation of the commencement of pension, Social Security or other entitlement payments,
36 and if the obligee is unable to obtain the anticipated entitlement payments, that inability is suffi-
37 cient change in circumstances for the court to reconsider its order of support.

38 (c) If Social Security is considered in lieu of spousal support or partial spousal support, the
39 court shall determine the amount of Social Security the party is eligible to collect. The court shall
40 take into consideration any pension, retirement or other funds available to either party to effect an
41 equitable distribution between the parties and shall also take into consideration any reduction of
42 entitlement caused by taking early retirement.

43 (4) In considering under this section whether a change in circumstances exists sufficient for the
44 court to reconsider spousal or child support provisions of a judgment, the following provisions apply:

45 (a) The court or administrator, as defined in ORS 25.010, shall consider income opportunities and

1 benefits of the respective parties from all sources, including but not limited to:

2 (A) The reasonable opportunity of each party, the obligor and obligee respectively, to acquire
3 future income and assets.

4 (B) Retirement benefits available to the obligor and to the obligee.

5 (C) Other benefits to which the obligor is entitled, such as travel benefits, recreational benefits
6 and medical benefits, contrasted with benefits to which the obligee is similarly entitled.

7 (D) Social Security benefits paid to a child, or to a representative payee administering the funds
8 for the child's use and benefit, as a result of the obligor's disability or retirement if the benefits:

9 (i) Were not previously considered in the child support order; or

10 (ii) Were considered in an action initiated before May 12, 2003.

11 (E) Apportioned Veterans' benefits or Survivors' and Dependents' Educational Assistance under
12 38 U.S.C. chapter 35 paid to a child, or to a representative payee administering the funds for the
13 child's use and benefit, as a result of the obligor's disability or retirement if the benefits:

14 (i) Were not previously considered in the child support order; or

15 (ii) Were considered in an action initiated before May 12, 2003.

16 (b) If the motion for modification is one made by the obligor to reduce or terminate support, and
17 if the obligee opposes the motion, the court shall not find a change in circumstances sufficient for
18 reconsideration of support provisions, if the motion is based upon a reduction of the obligor's fi-
19 nancial status resulting from the obligor's taking voluntary retirement, partial voluntary retirement
20 or any other voluntary reduction of income or self-imposed curtailment of earning capacity, if it is
21 shown that such action of the obligor was not taken in good faith but was for the primary purpose
22 of avoiding the support obligation. In any subsequent motion for modification, the court shall deny
23 the motion if the sole basis of the motion for modification is the termination of voluntarily taken
24 retirement benefits and the obligor previously has been found not to have acted in good faith.

25 (c) The court shall consider the following factors in deciding whether the actions of the obligor
26 were not in "good faith":

27 (A) Timing of the voluntary retirement or other reduction in financial status to coincide with
28 court action in which the obligee seeks or is granted an increase in spousal support.

29 (B) Whether all or most of the income producing assets and property were awarded to the
30 obligor, and spousal support in lieu of such property was awarded to the obligee.

31 (C) Extent of the obligor's dissipation of funds and assets prior to the voluntary retirement or
32 soon after filing for the change of circumstances based on retirement.

33 (D) If earned income is reduced and absent dissipation of funds or large gifts, whether the
34 obligor has funds and assets from which the spousal support could have been paid.

35 (E) Whether the obligor has given gifts of substantial value to others, including a current
36 spouse, to the detriment of the obligor's ability to meet the preexisting obligation of spousal support.

37 (5) Upon terminating a duty of spousal support, a court shall make specific findings of the basis
38 for the termination and shall include the findings in the judgment order.

39 (6) Any modification of child or spousal support granted because of a change of circumstances
40 may be ordered effective retroactive to the date the motion for modification was served or to any
41 date thereafter.

42 (7) The judgment is final as to any installment or payment of money that has accrued up to the
43 time the nonmoving party, other than the state, is served with a motion to set aside, alter or modify
44 the judgment. The court may not set aside, alter or modify any portion of the judgment that provides
45 for any payment of money, either for minor children or for the support of a party, that has accrued

1 before the motion is served. However:

2 (a) The court may allow a credit against child support arrearages for periods of time, excluding
3 reasonable parenting time unless otherwise provided by order or judgment, during which the obligor,
4 with the knowledge and consent of the obligee or pursuant to court order, has physical custody of
5 the child; and

6 (b) The court may allow, as provided in the rules of the Child Support Program, a dollar-for-
7 dollar credit against child support arrearages for any lump sum Social Security or Veterans' benefits
8 paid retroactively to the child, or to a representative payee administering the funds for the child's
9 use and benefit, as a result of an obligor's disability or retirement.

10 (8) In a proceeding under subsection (1) of this section, the court may assess against either party
11 a reasonable attorney fee and costs for the benefit of the other party. If a party is found to have
12 acted in bad faith, the court shall order that party to pay a reasonable attorney fee and costs of the
13 defending party.

14 (9) Whenever a motion to establish, modify or terminate child support or satisfy or alter support
15 arrearages is filed and the child support rights of one of the parties or of a child of both of the
16 parties have been assigned to the state, a true copy of the motion shall be served by mail or per-
17 sonal delivery on the Administrator of the Division of Child Support of the Department of Justice
18 or on the branch office providing support services to the county in which the motion is filed.

19 (10)(a) Except as provided in ORS 109.701 to 109.834, the courts of Oregon, having once acquired
20 personal and subject matter jurisdiction in a domestic relations action, retain such jurisdiction re-
21 gardless of any change of domicile.

22 (b) The courts of Oregon, in a proceeding to establish, enforce or modify a child support order,
23 shall recognize the provisions of the federal Full Faith and Credit for Child Support Orders Act (28
24 U.S.C. 1738B).

25 (11) In a proceeding under this section to reconsider provisions in a judgment relating to cus-
26 tody or parenting time, the court may consider repeated and unreasonable denial of, or interference
27 with, parenting time to be a substantial change of circumstances.

28 **(12) In a proceeding under this section to reconsider provisions in a judgment relating**
29 **to parenting time, the court may suspend or terminate a parent's parenting time with a child**
30 **if the court finds that the parent has abused a controlled substance and that the parenting**
31 **time is not in the best interests of the child. If a court has suspended or terminated a**
32 **parent's parenting time with a child for reasons described in this subsection, the court may**
33 **not grant the parent future parenting time until the parent has shown that the reasons for**
34 **the suspension or termination are resolved and that reinstated parenting time is in the best**
35 **interests of the child. Nothing in this subsection limits the court's authority under sub-**
36 **section (1)(a) of this section.**

37 [(12)] (13) Within 30 days after service of notice under subsection (1) of this section, the party
38 served shall file a written response with the court.

39 [(13)(a)] (14)(a) It is the policy of this state:

40 (A) To encourage the settlement of cases brought under this section; and

41 (B) For courts to enforce the terms of settlements described in paragraph (b) of this subsection
42 to the fullest extent possible, except when to do so would violate the law or would clearly
43 contravene public policy.

44 (b) In a proceeding under subsection (1) of this section, the court may enforce the terms set
45 forth in a stipulated order or judgment signed by the parties, an order or judgment resulting from

1 a settlement on the record or an order or judgment incorporating a settlement agreement:

2 (A) As contract terms using contract remedies;

3 (B) By imposing any remedy available to enforce an order or judgment, including but not limited
4 to contempt; or

5 (C) By any combination of the provisions of subparagraphs (A) and (B) of this paragraph.

6 (c) A party may seek to enforce an agreement and obtain remedies described in paragraph (b)
7 of this subsection by filing a motion, serving notice on the other party in the manner provided by
8 ORCP 7 and, if a remedy under paragraph (b)(B) of this subsection is sought, complying with the
9 statutory requirements for that remedy. All claims for relief arising out of the same acts or omis-
10 sions must be joined in the same proceeding.

11 (d) Nothing in paragraph (b) or (c) of this subsection limits a party's ability, in a separate pro-
12 ceeding, to file a motion to modify an order or judgment under subsection (1) of this section or to
13 seek enforcement of an ancillary agreement to the order or judgment.

14 **SECTION 7.** ORS 475.996 is amended to read:

15 475.996. (1) A violation of ORS 475.992 **or sections 14 to 38 of this 2005 Act** shall be classified
16 as crime category 8 of the sentencing guidelines grid of the Oregon Criminal Justice Commission if:

17 (a) The violation constitutes delivery or manufacture of a controlled substance and involves
18 substantial quantities of a controlled substance. For purposes of this paragraph, the following
19 amounts constitute substantial quantities of the following controlled substances:

20 (A) Five grams or more of a mixture or substance containing a detectable amount of heroin;

21 (B) Ten grams or more of a mixture or substance containing a detectable amount of cocaine;

22 (C) Ten grams or more of a mixture or substance containing a detectable amount of metham-
23 phetamine, its salts, isomers or salts of its isomers;

24 (D) One hundred grams or more of a mixture or substance containing a detectable amount of
25 hashish;

26 (E) One hundred and fifty grams or more of a mixture or substance containing a detectable
27 amount of marijuana;

28 (F) Two hundred or more user units of a mixture or substance containing a detectable amount
29 of lysergic acid diethylamide;

30 (G) Sixty grams or more of a mixture or substance containing a detectable amount of psilocybin
31 or psilocin; or

32 (H) Five grams or more or 25 or more pills, tablets or capsules of a mixture or substance con-
33 taining a detectable amount of:

34 (i) 3,4-methylenedioxyamphetamine;

35 (ii) 3,4-methylenedioxymethamphetamine; or

36 (iii) 3,4-methylenedioxy-N-ethylamphetamine.

37 (b) The violation constitutes possession, delivery or manufacture of a controlled substance and
38 the possession, delivery or manufacture is a commercial drug offense. A possession, delivery or
39 manufacture is a commercial drug offense for purposes of this subsection if it is accompanied by at
40 least three of the following factors:

41 (A) The delivery was of heroin, cocaine, hashish, marijuana, methamphetamine, lysergic acid
42 diethylamide, psilocybin or psilocin and was for consideration;

43 (B) The offender was in possession of \$300 or more in cash;

44 (C) The offender was unlawfully in possession of a firearm or other weapon as described in ORS
45 166.270 (2), or the offender used, attempted to use or threatened to use a deadly or dangerous

1 weapon as defined in ORS 161.015, or the offender was in possession of a firearm or other deadly
2 or dangerous weapon as defined in ORS 161.015 for the purpose of using it in connection with a
3 controlled substance offense;

4 (D) The offender was in possession of materials being used for the packaging of controlled sub-
5 stances such as scales, wrapping or foil, other than the material being used to contain the substance
6 that is the subject of the offense;

7 (E) The offender was in possession of drug transaction records or customer lists;

8 (F) The offender was in possession of stolen property;

9 (G) Modification of structures by painting, wiring, plumbing or lighting to facilitate a controlled
10 substance offense;

11 (H) The offender was in possession of manufacturing paraphernalia, including recipes, precursor
12 chemicals, laboratory equipment, lighting, ventilating or power generating equipment;

13 (I) The offender was using public lands for the manufacture of controlled substances;

14 (J) The offender had constructed fortifications or had taken security measures with the potential
15 of injuring persons; or

16 (K) The offender was in possession of controlled substances in an amount greater than:

18 (ii) Eight grams or more of a mixture or substance containing a detectable amount of cocaine;

19 (iii) Eight grams or more of a mixture or substance containing a detectable amount of metham-
20 phetamine;

21 (iv) Eight grams or more of a mixture or substance containing a detectable amount of hashish;

22 (v) One hundred ten grams or more of a mixture or substance containing a detectable amount
23 of marijuana;

24 (vi) Twenty or more user units of a mixture or substance containing a detectable amount of
25 lysergic acid diethylamide;

26 (vii) Ten grams or more of a mixture or substance containing a detectable amount of psilocybin
27 or psilocin; or

28 (viii) Four grams or more or 20 or more pills, tablets or capsules of a mixture or substance
29 containing a detectable amount of:

30 (I) 3,4-methylenedioxyamphetamine;

31 (II) 3,4-methylenedioxymethamphetamine; or

32 (III) 3,4-methylenedioxy-N-ethylamphetamine.

33 (c) The violation constitutes a violation of ORS 475.999 **or section 15, 17, 20, 22, 25, 27, 30, 31,**
34 **32, 35 or 37 of this 2005 Act.**

35 **(d) The violation constitutes manufacturing methamphetamine and the manufacturing**
36 **consists of:**

37 **(A) A chemical reaction involving one or more precursor substances for the purpose of**
38 **manufacturing methamphetamine; or**

39 **(B) Grinding, soaking or otherwise breaking down a precursor substance for the purpose**
40 **of manufacturing methamphetamine.**

41 (2) A violation of ORS 475.992 **or sections 14 to 38 of this 2005 Act** shall be classified as crime

45 **(A) The delivery involved a substantial quantity of methamphetamine as described in ORS**

1 475.996; and

2 (B) The person has a previous conviction for:

3 (i) Delivery or manufacture of methamphetamine under ORS 475.992 or section 14 or 16
4 of this 2005 Act;

5 (ii) Delivery or manufacture of methamphetamine within 1,000 feet of a school under ORS
6 475.999 or section 15 or 17 of this 2005 Act; or

7 (iii) Possession of a precursor substance with intent to manufacture a controlled sub-
8 stance under ORS 475.967.

9 (c) Delivery of methamphetamine under section 16 or 17 of this 2005 Act, the presumptive
10 sentence is 19 months of incarceration, unless the rules of the Oregon Criminal Justice
11 Commission prescribe a longer presumptive sentence, if the person has two or more previous
12 convictions for any combination of the following crimes:

13 *plant Cannabis family Moraceae in a public place that is within 1,000 feet of a school is a Class C*
14 *misdemeanor.*]

15 **SECTION 42.** ORS 90.400 is amended to read:

16 90.400. (1)(a) Except as provided in this chapter, if there is a material noncompliance by the
17 tenant with the rental agreement, a noncompliance with ORS 90.325 materially affecting health and
18 safety, a material noncompliance with a rental agreement regarding a program of recovery in drug
19 and alcohol free housing or a failure to pay a late charge pursuant to ORS 90.260 or a utility or
20 service charge pursuant to ORS 90.315 (4), the landlord may deliver a written notice to the tenant
21 terminating the tenancy for cause as provided in this subsection. The notice shall specify the acts
22 and omissions constituting the breach and shall state that the rental agreement will terminate upon
23 a date not less than 30 days after delivery of the notice. If the breach is remediable by repairs,
24 payment of damages, payment of a late charge or utility or service charge, change in conduct or
25 otherwise, the notice shall also state that the tenant can avoid termination by remedying the breach
26 within 14 days.

29 (c) If the tenant adequately remedies the breach before the date for remedying the breach as

31 (d) If substantially the same act or omission that constituted a prior noncompliance of which

33 date specified in that notice as the date for remedying the prior noncompliance, the landlord may

38 noncompliance given pursuant to paragraph (a) of this subsection. A landlord may not terminate a
39 rental agreement pursuant to this paragraph if the only breach is a failure to pay the current

9 (b) In the case of all other tenancies, by delivering to the tenant:

10 (A) At least 72 hours' written notice of nonpayment and the landlord's intention to terminate
11 the rental agreement if the rent is not paid within that period. The landlord shall give this notice
12 no sooner than on the eighth day of the rental period, including the first day the rent is due; or

13 (B) At least 144 hours' written notice of nonpayment and the landlord's intention to terminate
14 the rental agreement if the rent is not paid within that period. The landlord shall give this notice
15 no sooner than on the fifth day of the rental period, including the first day the rent is due.

16 (c) The notices described in this subsection shall also specify the date and time by which the

3 (f) The tenant has vacated the premises, the person in possession is holding contrary to a writ-
4 ten rental agreement that prohibits subleasing the premises to another or allowing another person
5 to occupy the premises without the written permission of the landlord, and the landlord has not
6 knowingly accepted rent from the person in possession; or

7 (g) The tenant, someone in the tenant's control or the tenant's pet commits any act that is
8 outrageous in the extreme, on the premises or in the immediate vicinity of the premises. An act that
9 is "outrageous in the extreme" is an act not described in paragraphs (a) to (e) of this subsection,
10 but is similar in degree and is one that a reasonable person in that community would consider to

24 (4) If the cause for a termination notice given pursuant to subsection (3)(a), (c), (d) or (g) of this
25 section is based upon the acts of the tenant's pet, the tenant may cure the cause and avoid termi-
26 nation of the tenancy by removing the pet from the premises prior to the end of the notice period.
27 The notice shall describe the right of the tenant to cure the cause. If the tenant returns the pet to

22 **SECTION 43.** ORS 105.555 is amended to read:

23 105.555. (1) The following are declared to be nuisances and shall be enjoined and abated as
 24 provided in ORS 105.550 to 105.600:

25 (a) Any place that, as a regular course of business, is used for the purpose of prostitution and
 26 any place where acts of prostitution occur;

27 (b) Any place which is used and maintained for profit and for the purpose of gambling or a lot-
 28 tery, as defined in ORS 167.117, by any person, partnership or corporation organized for profit and
 29 wherein take place any of the acts or wherein are kept, stored or located any of the games, devices
 30 or things which are forbidden by or made punishable by ORS 167.108 to 167.164; and

31 (c) Any place where activity involving the unauthorized delivery, manufacture or possession of
 32 a controlled substance, as defined in ORS 475.005, occurs or any place wherein are kept, stored or
 33 located any of the devices, equipment, things or substances used for unauthorized delivery, manu-
 34 facture or possession of a controlled substance. As used in this subsection "devices, equipment and
 35 things" does not include hypodermic syringes or needles. This subsection shall not apply to acts

17 this subsection.

18 **SECTION 45.** ORS 133.724 is amended to read:

19 133.724. (1) An ex parte order for the interception of wire, electronic or oral communications
20 may be issued by any circuit court judge upon written application made upon oath or affirmation
21 of the individual who is the district attorney or a deputy district attorney authorized by the district
22 attorney for the county in which the order is sought. The application shall include:

23 (a) The name of the district attorney or the deputy district attorney making the application and
24 the authority of the district attorney or the deputy district attorney to make the application;

25 (b) The identity of the investigative or law enforcement officer making the application and the

45 ically terminate when the described type of wire, electronic or oral communication has been first

1 obtained, a description of facts establishing probable cause to believe that additional communi-
2 cations of the same type will occur thereafter;

3 (j) A statement as to whether any prior application has been made to intercept wire, electronic
4 or oral communications from the same person and, if such prior application exists, a statement of
5 the current status of that application; and

9 (2) The judge may require the applicant to furnish further testimony or documentary evidence

13 munications within the state if the judge determines on the basis of the facts submitted by the ap-

16 to commit a particular crime described in subsection (1)(c) of this section;

20 unlikely to succeed if tried or are likely to be too dangerous; and

23 connection with the commission of that crime are leased to, listed in the name of, or commonly used
24 by the individual suspected.

25 (4) Each order authorizing or approving the interception of any wire, electronic or oral com-
26 munication shall specify:

27 (a) The identity of the person, if known, whose communications are to be intercepted;

28 (b) The nature and location of the communications facilities as to which, or the place where,

30 (c) A particular description of the type of communication sought to be intercepted, and a state-
