

SENATE AMENDMENTS TO SENATE BILL 929

- 1 On page 1 of the printed bill, line 2, delete the first “and” and delete “462.055,”.
- 2 In line 3, after “462.710” insert “; and declaring an emergency”.
- 3 Delete lines 5 through 25.
- 4 On page 2, line 1, delete “2” and insert “1”.
- 5 In line 43, delete “as” and insert “for”.
- 6 Delete line 44 and insert “expenses and other benefits for horsemen.”.
- 7 In line 45, delete “3” and insert “2”.
- 8 On page 3, line 5, after the period delete the rest of the line and lines 6 and 7.
- 9 In line 9, after the bracketed material insert “A licensee shall conduct at least 720 live races
- 10 under the license during each fiscal year race meets are held under the license. The commission
- 11 may reduce the number of races required under this section upon application by a horsemen’s as-
- 12 sociation that negotiates with the race meet licensee.”.
- 13 In line 10, after “licensee” insert “under ORS 462.062 or 462.067”.
- 14 In line 16, after “section” insert a period and delete the rest of the line and line 17.
- 15 In line 18, delete “commission may grant dates for greyhound racing.”.
- 16 On page 4, line 13, delete “4” and insert “3”.
- 17 In line 15, delete the boldfaced material and insert “a race meet licensee may conduct”.
- 18 In line 18, delete “5” and insert “4”.
- 19 In line 19, restore the bracketed material and delete the boldfaced material.
- 20 On page 5, lines 10 and 11, delete the boldfaced material.
- 21 In line 14, delete “such” and restore the bracketed material.
- 22 In line 15, restore the bracketed material.
- 23 In line 21, delete the period and insert “, except that:
- 24 “(A) A horse race meet licensee may conduct off-race course mutuel wagering on greyhound
- 25 races only if there is no active greyhound race meet licensee; and
- 26 “(B) A greyhound race meet licensee may conduct off-race course mutuel wagering on horse
- 27 races only if there is no active horse race meet licensee.”.
- 28 Delete lines 26 and 27 and insert:
- 29 “**SECTION 5.** (1) The requirement in ORS 462.125 that a licensee conduct at least 720 live races
- 30 during a fiscal year applies to fiscal years beginning on or after the effective date of this 2005
- 31 Act.”.
- 32 In line 28, delete “section 2” and insert “section 1”.
- 33 In line 30, delete “4 and 5” and insert “3 and 4”.
- 34 After line 32, insert:
- 35 “**SECTION 6.** This 2005 Act being necessary for the immediate preservation of the public

1 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**
2 **on its passage.”**
