

# Senate Bill 983

Sponsored by COMMITTEE ON RULES

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Public Utility Commission to adopt rules relating to termination of local exchange residential telephone service that would significantly endanger certain persons. Specifies court orders establishing that termination of service would endanger person.

Declares emergency, effective September 1, 2005.

## A BILL FOR AN ACT

2 Relating to communication services; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2005 Act is added to and made a part of sections 2 to 6,**  
5 **chapter 290, Oregon Laws 1987.**

6 **SECTION 2. (1) In carrying out the provisions of section 2, chapter 290, Oregon Laws**  
7 **1987, the Public Utility Commission shall adopt rules to prohibit the termination of local ex-**  
8 **change residential service if the termination would significantly endanger a customer, or a**  
9 **person in the household of the customer, who is:**

10 (a) **At risk of domestic violence, as defined in ORS 135.230;**

11 (b) **At risk of unwanted sexual contact, as defined in ORS 163.305;**

12 (c) **A person with disabilities, as defined in ORS 124.005, who is at risk of abuse, as de-**  
13 **finied in ORS 124.005 (1)(a), (d) or (e);**

14 (d) **An elderly person, as defined in ORS 124.005, who is at risk of abuse, as defined in**  
15 **ORS 124.005 (1)(a), (d) or (e); or**

16 (e) **A victim of stalking, as described in ORS 163.732.**

17 (2) **A customer may establish that termination of local exchange residential service would**  
18 **significantly endanger the customer, or a person in the household of the customer, by pro-**  
19 **viding a telecommunications public utility with an affidavit signed by the customer stating**  
20 **that termination would place the customer, or a person in the household of the customer,**  
21 **at significant risk of domestic violence, as defined in ORS 135.230, or of unwanted sexual**  
22 **contact, as defined in ORS 163.305. The customer must attach to the affidavit a copy of an**  
23 **order issued under ORS 30.866, 107.700 to 107.732, 124.005 to 124.040 or 163.738 that restrains**  
24 **another person from contact with the customer, or a person in the household of the cus-**  
25 **tomer, or a copy of any other court order that restrains another person from contact with**  
26 **the customer, or a person in the household of the customer, by reason of a risk described**  
27 **in subsection (1) of this section or by reason of stalking.**

28 (3) **The commission shall require that each telecommunications public utility establish**  
29 **procedures for submitting and receiving affidavits under subsection (2) of this section.**

30 (4) **This section does not apply to termination of any telecommunication service other**

1 **than local exchange residential service.**

2 **(5) A customer submitting an affidavit as provided by subsection (2) of this section is not**  
3 **excused from paying for telecommunication service. Customers are required to enter into a**  
4 **reasonable payment agreement with the telecommunications public utility if an overdue bal-**  
5 **ance exists. Local exchange residential service may be terminated if a customer refuses to**  
6 **enter into or fails to abide by the terms of a reasonable payment agreement.**

7 **(6) Nothing in this section prevents the termination of local exchange residential service**  
8 **if the telecommunications public utility providing the service does not have the technical**  
9 **ability to terminate toll telecommunication service without also terminating local exchange**  
10 **residential service.**

11 **SECTION 3. This 2005 Act being necessary for the immediate preservation of the public**  
12 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**  
13 **September 1, 2005.**
