SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Department of Consumer and Business Services to study [*effectiveness of State Accident Insurance Fund Corporation in meeting its function of handling and processing workers' compensation claims of employees of employers insured by corporation*] **impact that denial in workers' compensation claims has on services and benefits provided by other public programs and private insurance carriers. Directs department to contract for study with disinterested entity.** Requires department to report results of study to Legislative Assembly.

Sunsets January 2, 2008.

Declares emergency, effective on passage.

A BILL FOR AN ACT

1
2 Relating to workers' compensation; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1)(a) The Department of Consumer and Business Services shall study the**
5 **impact that the denial in workers' compensation claims has on services and benefits provided**
6 **by other public programs and private insurance carriers.**

7 **(b) The department shall contract for the study required by this section with an entity**
8 **that has no interest in the outcome of the study.**

9 **(2) The study shall include, but need not be limited to, consideration of:**

10 **(a) Initial denials of workers' compensation claims;**

11 **(b) Services and benefits received by injured workers as a result of conditions denied in**
12 **workers' compensation claims;**

13 **(c) Costs incurred by public programs and private insurance carriers as a result of pro-**
14 **viding services and benefits to injured workers whose workers' compensation claims have**
15 **been denied; and**

16 **(d) Costs borne directly by injured workers whose claims have been denied.**

17 **(3) The results of the study shall be reported to the Legislative Assembly in the manner**
18 **prescribed by ORS 192.245 by September 30, 2006.**

19 **SECTION 2. Notwithstanding ORS 656.605, moneys in the Workers' Benefit Fund may be**
20 **expended to reimburse the Department of Consumer and Business Services for expenses re-**
21 **lated to the study required under section 1 of this 2005 Act.**

22 **SECTION 3. This 2005 Act is repealed on January 2, 2008.**

23 **SECTION 4. This 2005 Act being necessary for the immediate preservation of the public**
24 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**
25 **on its passage.**
