

SENATE AMENDMENTS TO SENATE BILL 1047

- 1 On page 1 of the printed bill, delete lines 8 through 12 and insert:
2 “(2) The deceased was the victim of a suicide and there is evidence that the suicide is related
3 to previous domestic violence;”.
- 4 In line 13, delete “(4)” and insert “(3)”.
- 5 In line 14, after “perpetrator” delete the rest of the line and delete line 15 and insert “also died
6 in the course of the domestic violence incident;”.
- 7 Delete lines 16 and 17 and insert:
8 “(4) The deceased was a child who died in the course of a domestic violence incident in which
9 either a parent of the child or the perpetrator also died;”.
- 10 In line 18, delete “(6)” and insert “(5)”.
- 11 In line 19, after the semicolon insert “or”.
- 12 Delete lines 20 through 26.
- 13 In line 27, delete “(10)” and insert “(6)” and after “person” insert “18 years of age or older”.
- 14 In line 29, delete “this state” and insert “the local public safety coordinating council or by the
15 governing body of the”.
- 16 In line 30, delete “or by a”.
- 17 In line 31, delete “, investigating”.
- 18 On page 2, line 3, delete “investigate and” and insert “review domestic violence fatalities and
19 make recommendations to”.
- 20 In line 13, before the colon insert “the following members, if available”.
- 21 In line 14, delete “battered women’s advocates” and insert “advocates for battered women”.
- 22 In line 17, delete “Prosecuting attorneys” and insert “The local district attorney or the district
23 attorney’s designees”.
- 24 Delete line 18.
- 25 In line 19, delete “(f)” and insert “(e)”.
- 26 In line 20, delete “(g)” and insert “(f)”.
- 27 In line 21, delete “(h)” and insert “(g)” and delete “Child”.
- 28 In line 22, delete “(i)” and insert “(h)”.
- 29 In line 23, delete “(j)” and insert “(i)”.
- 30 In line 24, delete “(k)” and insert “(j)”.
- 31 Delete line 25 and insert:
32 “(k) A survivor of domestic violence; and”.
- 33 In line 26, delete “(m) Coroners,” and insert “(L)” and delete “, if” and insert a period.
- 34 Delete lines 27 and 28 and insert:
35 “(4) Other individuals may, with the unanimous consent of the team,”.

1 In line 29, after “basis” delete the rest of the line and delete lines 30 through 33 and insert “.
2 The team, by unanimous consent, may decide the extent to which the individual may participate as
3 a full member of the team for a particular review.”.

4 In line 34, delete “Before conducting an investigation” and insert “Upon formation and before
5 reviewing its first case”.

6 On page 3, line 15, delete “a majority” and insert “two-thirds”.

7 After line 15, insert:

8 “(11) Information, documents and records otherwise available from other sources are not im-
9 mune from discovery or introduction into evidence solely because the information, documents or
10 records were presented to or reviewed by a fatality review team.”.

11 In line 16, delete “(11)” and insert “(12)”.

12 In line 17, delete “(12)” and insert “(13)”.
