**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides that person under 18 years of age who is found guilty except for insanity of crime may be committed to secure intensive community inpatient facility. Provides that when person under 18 years of age lacks fitness to proceed with criminal case, person may be committed to secure intensive community inpatient facility.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 161.327 is amended to read:

7 161.327. (1)(a) Following the entry of a judgment pursuant to ORS 161.319 and the dispositional  
8 determination under ORS 161.325, [*if the court finds that the person would have been guilty of a fel-*  
9 *ony, or of a misdemeanor during a criminal episode in the course of which the person caused physical*  
10 *injury or risk of physical injury to another, and if the court finds by a preponderance of the evidence*  
11 *that the person is affected by mental disease or defect and presents a substantial danger to others re-*  
12 *quiring commitment to a state mental hospital designated by the Department of Human Services or*  
13 *conditional release,*] the court shall order the person placed under the jurisdiction of the Psychiatric  
14 Security Review Board for care and treatment **if the court:**

15 **(A) Finds that the person would have been guilty of a felony or guilty of a misdemeanor**  
16 **during a criminal episode in the course of which the person caused physical injury or risk**  
17 **of physical injury to another; and**

18 **(B) Finds by a preponderance of the evidence that the person is affected by a mental**  
19 **disease or defect and presents a substantial danger to others requiring conditional release**  
20 **or commitment to:**

21 **(i) A state hospital designated by the Department of Human Services if the person is at**  
22 **least 18 years of age; or**

23 **(ii) A secure intensive community inpatient facility designated by the Department of**

2 (2) The court shall determine whether the person should be committed to a state hospital, **or**  
3 **to a secure intensive community inpatient facility**, designated by the Department of Human  
4 Services or conditionally released pending any hearing before the board as follows:

5 (a) If the court finds that the person presents a substantial danger to others and is not a proper  
6 subject for conditional release, the court shall order the person committed to a state hospital des-  
7 ignated by the Department of Human Services **if the person is at least 18 years of age, or to a**  
8 **secure intensive community inpatient facility designated by the Department of Human Ser-**  
9 **vices if the person is under 18 years of age**, for custody, care and treatment pending hearing

29 evaluations, examinations and compliance as provided in ORS 161.336 (4) and 161.346 (2).

30 (5) In determining whether a person should be committed to a state hospital **or to a secure**  
31 **intensive community inpatient facility** or conditionally released, the court shall have as its pri-  
32 mary concern the protection of society.

33 (6) Upon placing a person on conditional release, the court shall notify the board in writing of  
34 the court's conditional release order, the supervisor appointed, and all other conditions of release,  
35 and the person shall be on conditional release pending hearing before the board in accordance with  
36 ORS 161.336 to 161.351. Upon compliance with this subsection and subsections (1) and (2) of this  
37 section, the court's jurisdiction over the person is terminated and the board assumes jurisdiction

39 **SECTION 2.** ORS 161.336 is amended to read:

40 161.336. (1) If the **Psychiatric Security Review** Board determines that the person presents a  
 41 substantial danger to others but can be adequately controlled with supervision and treatment if  
 42 conditionally released and that necessary supervision and treatment are available, the board may  
 43 order the person conditionally released, subject to those supervisory orders of the board as are in  
 44 the best interests of justice, the protection of society and the welfare of the person. The board may  
 45 designate any person or state, county or local agency the board considers capable of supervising the

1 person upon release, subject to those conditions as the board directs in the order for conditional  
2 release. Prior to the designation, the board shall notify the person or agency to whom conditional  
3 release is contemplated and provide the person or agency an opportunity to be heard before the  
4 board. After receiving an order entered under this section, the person or agency designated shall  
5 assume supervision of the person pursuant to the direction of the board.

6 (2) Conditions of release contained in orders entered under this section may be modified from  
7 time to time and conditional releases may be terminated by order of the board as provided in ORS  
8 161.351.

9 (3) For purposes of this section, a person affected by a mental disease or defect in a state of  
10 remission is considered to have a mental disease or defect requiring supervision when the disease  
11 may, with reasonable medical probability, occasionally become active and, when active, render the  
12 person a danger to others. The person may be continued on conditional release by the board as  
13 provided in this section.

14 (4)(a) As a condition of release, the board may require the person to report to any state or local  
15 mental health facility for evaluation. Whenever medical, psychiatric or psychological treatment is  
16 recommended, the board may order the person, as a condition of release, to cooperate with and ac-  
17 cept the treatment from the facility.

18 (b) The facility to which the person has been referred for evaluation shall perform the evalu-  
19 ation and submit a written report of its findings to the board. If the facility finds that treatment of  
20 the person is appropriate, it shall include its recommendations for treatment in the report to the  
21 board.

22 (c) Whenever treatment is provided by the facility, it shall furnish reports to the board on a  
23 regular basis concerning the progress of the person.

24 (d) Copies of all reports submitted to the board pursuant to this section shall be furnished to the  
25 person and the person's counsel. The confidentiality of these reports [*shall be*] is determined pursu-  
26 ant to ORS 192.501 to 192.505.

27 (e) The facility shall comply with any other conditions of release prescribed by order of the  
28 board.

29 (5) If at any time while the person is under the jurisdiction of the board it appears to the board  
30 or its chairperson that the person has violated the terms of the conditional release or that the  
31 mental health of the individual has changed, the board or its chairperson may order the person re-  
32 turned **for evaluation or treatment** to a state hospital designated by the Department of Human  
33 Services **if the person is at least 18 years of age, or to a secure intensive community inpatient**  
34 **facility designated by the Department of Human Services if the person is under 18 years of**  
35 **age** [*for evaluation or treatment*]. A written order of the board, or its chairperson on behalf of the  
36 board, is sufficient warrant for any law enforcement officer to take into custody such person and  
37 transport the person accordingly. A sheriff, municipal police officer, constable, parole or probation  
38 officer, prison official or other peace officer shall execute the order, and the person shall be re-  
39 turned as soon as practicable to the custody of the Department of Human Services. Within 20 days  
40 following the return of the person to the custody of the Department of Human Services, the board  
41 shall conduct a hearing. Notice of the time and place of the hearing shall be given to the person,  
42 the attorney representing the person and the Attorney General. The board may continue the person  
43 on conditional release or, if it finds by a preponderance of the evidence that the person is affected  
44 by mental disease or defect and presents a substantial danger to others and cannot be adequately  
45 controlled if conditional release is continued, it may order the person committed to a state hospital

1 designated by the Department of Human Services **if the person is at least 18 years of age, or to**  
2 **a secure intensive community inpatient facility designated by the Department of Human**  
3 **Services if the person is under 18 years of age.** The state must prove by a preponderance of the  
4 evidence the person's unfitness for conditional release. A person in custody pursuant to this sub-  
5 section [*shall have*] **has** the same rights as any person appearing before the board pursuant to ORS  
6 161.346.

7 (6) The community mental health and developmental disabilities program director, the director  
8 of the facility providing treatment to a person on conditional release, any peace officer or any per-  
9 son responsible for the supervision of a person on conditional release may take a person on condi-  
10 tional release into custody or request that the person be taken into custody if there is reasonable  
11 cause to believe the person is a substantial danger to others because of mental disease or defect and  
12 that the person is in need of immediate care, custody or treatment. Any person taken into custody  
13 pursuant to this subsection shall be transported as soon as practicable to a state hospital designated  
14 by the Department of Human Services **if the person is at least 18 years of age, or to a secure**  
15 **intensive community inpatient facility designated by the Department of Human Services if**  
16 **the person is under 18 years of age.** A person taken into custody under this subsection [*shall*  
17 *have*] **has** the same rights as any person appearing before the board pursuant to ORS 161.346.

18 (7)(a) Any person conditionally released under this section may apply to the board for discharge  
19 from or modification of an order of conditional release on the ground that the person is no longer  
20 affected by mental disease or defect or, if still so affected, no longer presents a substantial danger  
21 to others and no longer requires supervision, medication, care or treatment. Notice of the hearing  
22 on an application for discharge or modification of an order of conditional release shall be made to  
23 the Attorney General. The applicant, at the hearing pursuant to this subsection, must prove by a  
24 preponderance of the evidence the applicant's fitness for discharge or modification of the order of  
25 conditional release. Applications by the person for discharge or modification of conditional release  
26 shall not be filed more often than once every six months.

27 (b) Upon application by any person or agency responsible for supervision or treatment pursuant  
28 to an order of conditional release, the board shall conduct a hearing to determine if the conditions  
29 of release shall be continued, modified or terminated. The application shall be accompanied by a  
30 report setting forth the facts supporting the application.

31 (8) The total period of commitment and conditional release ordered pursuant to this section  
32 [*shall*] **may** not exceed the maximum sentence provided by statute for the crime for which the per-  
33 son was found guilty except for insanity.

34 (9) The board shall maintain and keep current the medical, social and criminal history of all  
35 persons committed to its jurisdiction. The confidentiality of records maintained by the board shall  
36 be determined pursuant to ORS 192.501 to 192.505.

37 (10) In determining whether a person should be committed to a state hospital **or to a secure**  
38 **intensive community inpatient facility**, conditionally released or discharged, the board shall have  
39 as its primary concern the protection of society.

40 **SECTION 3.** ORS 161.341 is amended to read:

41 161.341. (1) If the **Psychiatric Security Review** Board finds, upon its initial hearing, that the  
42 person presents a substantial danger to others and is not a proper subject for conditional release,  
43 the board shall order the person committed to, or retained in, a state hospital designated by the  
44 Department of Human Services **if the person is at least 18 years of age, or to a secure intensive**  
45 **community inpatient facility designated by the Department of Human Services if the person**

1 **is under 18 years of age**, for custody, care and treatment. The period of commitment ordered by  
2 the board *[shall]* **may** not exceed the maximum sentence provided by statute for the crime for which  
3 the person was found guilty except for insanity.

4 (2) If at any time after the commitment of a person to a state hospital, **or to a secure intensive**  
5 **community inpatient facility**, designated by the Department of Human Services under this section,  
6 the superintendent of the hospital **or the director of the secure intensive community inpatient**  
7 **facility** is of the opinion that the person is no longer affected by mental disease or defect, or, if so  
8 affected, no longer presents a substantial danger to others or that the person continues to be af-  
9 fected by mental disease or defect and continues to be a danger to others, but that the person can  
10 be controlled with proper care, medication, supervision and treatment if conditionally released, the  
11 superintendent **or director** shall apply to the board for an order of discharge or conditional release.  
12 The application shall be accompanied by a report setting forth the facts supporting the opinion of  
13 the superintendent **or director**. If the application is for conditional release, the application must  
14 also be accompanied by a verified conditional release plan. The board shall hold a hearing on the  
15 application within 60 days of its receipt. Not less than 20 days prior to the hearing before the board,  
16 copies of the report shall be sent to the Attorney General.

17 (3) The attorney representing the state may choose a psychiatrist or licensed psychologist to  
18 examine the person prior to the initial or any later decision by the board on discharge or condi-  
19 tional release. The results of the examination shall be in writing and filed with the board, and shall  
20 include, but need not be limited to, an opinion as to the mental condition of the person, whether the  
21 person presents a substantial danger to others and whether the person could be adequately con-  
22 trolled with treatment as a condition of release.

23 (4) Any person who has been committed to a state hospital, **or to a secure intensive com-**  
24 **munity inpatient facility**, designated by the Department of Human Services for custody, care and  
25 treatment or another person acting on the person's behalf may apply to the board for an order of  
26 discharge or conditional release upon the grounds:

27 (a) That the person is no longer affected by mental disease or defect;

28 (b) If so affected, that the person no longer presents a substantial danger to others; or

29 (c) That the person continues to be affected by a mental disease or defect and would continue  
30 to be a danger to others without treatment, but that the person can be adequately controlled and  
31 given proper care and treatment if placed on conditional release.

32 (5) When application is made under subsection (4) of this section, the board shall require **that**  
33 a report from the superintendent of the hospital **or the director of the secure intensive com-**  
34 **munity inpatient facility** *[which shall]* be prepared and transmitted as provided in subsection (2)  
35 of this section. The applicant must prove by a preponderance of the evidence the applicant's fitness  
36 for discharge or conditional release under the standards of subsection (4) of this section, unless more  
37 than two years has passed since the state had the burden of proof on that issue, in which case the  
38 state shall have the burden of proving by a preponderance of the evidence the applicant's lack of  
39 fitness for discharge or conditional release. Applications for discharge or conditional release under  
40 subsection (4) of this section shall not be filed more often than once every six months commencing  
41 with the date of the initial board hearing.

42 (6) The board is not required to hold a hearing on a first application under subsection (4) of this  
43 section any sooner than 90 days after the initial hearing. However, hearings resulting from any  
44 subsequent requests shall be held within 60 days of the filing of the application.

45 (7)(a) In no case shall any person committed by the court under ORS 161.327 to a state

1 hospital, **or to a secure intensive community inpatient facility**, designated by the Department  
2 of Human Services be held in the hospital **or facility** for more than 90 days from the date of the  
3 court's commitment order without an initial hearing before the board to determine whether the  
4 person should be conditionally released or discharged.

5 (b) In no case shall a person be held pursuant to this section for a period of time exceeding two  
6 years without a hearing before the board to determine whether the person should be conditionally  
7 released or discharged.

8 **SECTION 4.** ORS 161.346 is amended to read:

9 161.346. (1) The Psychiatric Security Review Board shall conduct hearings upon any application  
10 for discharge, conditional release, commitment or modification filed pursuant to ORS 161.336, 161.341  
11 or 161.351 and as otherwise required by ORS 161.336 to 161.351 and shall make findings on the is-  
12 sues before it which may include:

13 (a) If the board finds that the person is no longer affected by mental disease or defect, or, if so  
14 affected, no longer presents a substantial danger to others, the board shall order the person dis-  
15 charged from commitment or from conditional release.

16 (b) If the board finds that the person is still affected by a mental disease or defect and is a  
17 substantial danger to others, but can be controlled adequately if conditionally released with treat-  
18 ment as a condition of release, the board shall order the person conditionally released as provided  
19 in ORS 161.336.

20 (c) If the board finds that the person has not recovered from the mental disease or defect and  
21 is a substantial danger to others and cannot adequately be controlled if conditionally released on  
22 supervision, the board shall order the person committed to, or retained in, a state hospital desig-  
23 nated by the Department of Human Services **if the person is at least 18 years of age, or a secure**  
24 **intensive community inpatient facility designated by the Department of Human Services if**  
25 **the person is under 18 years of age**, for care, custody and treatment.

26 (2) At any time, the board may appoint a psychiatrist or licensed psychologist to examine the  
27 person and to submit a report to the board. Reports filed with the board pursuant to the examination  
28 shall include, but need not be limited to, an opinion as to the mental condition of the person and  
29 whether the person presents a substantial danger to others, and whether the person could be ade-  
30 quately controlled with treatment as a condition of release. To facilitate the examination of the  
31 person, the board may order the person placed in the temporary custody of any state hospital or  
32 other suitable facility.

33 (3) The board may make the determination regarding discharge or conditional release based  
34 upon the written reports submitted pursuant to this section. If any member of the board desires  
35 further information from the examining psychiatrist or licensed psychologist who submitted the re-  
36 port, these persons shall be summoned by the board to give testimony. The board shall consider all  
37 evidence available to it which is material, relevant and reliable regarding the issues before the  
38 board. Such evidence may include but is not limited to the record of trial, the information supplied  
39 by the attorney representing the state or by any other interested party, including the person, and  
40 information concerning the person's mental condition and the entire psychiatric and criminal history  
41 of the person. All evidence of a type commonly relied upon by reasonably prudent persons in the  
42 conduct of their serious affairs shall be admissible at hearings. Testimony shall be taken upon oath  
43 or affirmation of the witness from whom received. The officer presiding at the hearing shall admin-  
44 ister oaths or affirmations to witnesses.

45 (4) The board shall furnish to the person about whom the hearing is being conducted, the at-

1 torney representing the person, the Attorney General, the district attorney and the court or de-  
2 partment of the county from which the person was committed written notice of any hearing pending  
3 under this section within a reasonable time prior to the hearing. The notice shall include:

4 (a) The time, place and location of the hearing.

5 (b) The nature of the hearing and the specific action for which a hearing has been requested,  
6 the issues to be considered at the hearing and a reference to the particular sections of the statutes  
7 and rules involved.

8 (c) A statement of the authority and jurisdiction under which the hearing is to be held.

9 (d) A statement of all rights under subsection (6) of this section.

10 (5) Prior to the commencement of a hearing, the board or presiding officer shall inform each  
11 party as provided in ORS 183.413 (2).

12 (6) At the hearing, the person about whom the hearing is being held shall have the right:

13 (a) To appear at all proceedings held pursuant to this section, except board deliberations.

14 (b) To cross-examine all witnesses appearing to testify at the hearing.

15 (c) To subpoena witnesses and documents as provided in ORS 161.395.

16 (d) To be represented by suitable legal counsel possessing skills and experience commensurate  
17 with the nature and complexity of the case, to consult with counsel prior to the hearing and, if fi-  
18 nancially eligible, to have suitable counsel appointed at state expense.

19 (e) To examine all information, documents and reports which the board considers. If then avail-  
20 able to the board, the information, documents and reports shall be disclosed to the person so as to  
21 allow examination prior to the hearing.

22 (7) A record shall be kept of all hearings before the board, except board deliberations.

23 (8) Upon request of any party before the board, or on its own motion, the board may continue  
24 a hearing for a reasonable period not to exceed 60 days to obtain additional information or testi-  
25 mony or for other good cause shown.

26 (9) Within 15 days following the conclusion of the hearing, the board shall provide to the person,

38 expenses so allowed shall be paid by the public defense services executive director from funds  
39 available for the purpose.

40 (12) The Attorney General may represent the state at contested hearings before the board unless  
41 the district attorney of the county from which the person was committed elects to represent the  
42 state. The district attorney of the county from which the person was committed shall cooperate with  
43 the Attorney General in securing the material necessary for presenting a contested hearing before

18 (3) Except [*where*] **when** the defendant and the court both request to the contrary, the report  
19 [*shall*] **may** not contain any findings or conclusions as to whether the defendant as a result of  
20 mental disease or defect was subject to the provisions of ORS 161.295 or 161.300 at the time of the  
21 criminal act charged.

22 (4) If the examination by the psychiatrist or psychologist cannot be conducted by reason of the  
23 unwillingness of the defendant to participate therein, the report shall so state and shall include, if  
24 possible, an opinion as to whether such unwillingness of the defendant was the result of mental

26 (5) The report of the examination shall be filed in triplicate with the clerk of the court, who
