

SENATE AMENDMENTS TO SENATE BILL 5606

14 “**Sec. 7.** Notwithstanding any other law **limiting expenditures**, the amount of [*\$171,721,178*]
15 **\$155,138,215** is established for [*the biennium*] **a six-year period** beginning July 1, 1999, as the max-
16 imum limit for the payment of expenses from fees, proceeds from the issuance of certificates of
17 participation or other financing agreements, moneys or other revenues, including Miscellaneous
18 Receipts, but excluding lottery funds and federal funds, collected or received by the Department of
19 Corrections for the acquisition of land and the planning, construction, alteration, repair, furnishing
20 and equipping of buildings and facilities for a women’s correctional facility and intake center com-
21 plex at any site in this state other than the real property known as the F. H. Dammasch State
22 Hospital.

23 “**SECTION 3.** Section 2, chapter 864, Oregon Laws 2001, is amended to read:

24 “**Sec. 2.** Notwithstanding any other law **limiting expenditures**, the following amounts are es-
25 tablished for [*the biennium*] **a six-year period** beginning July 1, 2001, as the maximum limits for the
26 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but
27 excluding lottery funds and federal funds, collected or received by various state agencies for the
28 acquisition of land and the acquisition, planning, constructing, altering, repairing, furnishing and
29 equipping of buildings and facilities:
