

A-Engrossed Senate Bill 5614

Ordered by the Senate June 30

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to [_____] **Oregon Military Department** for **certain** biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts **and federal service agreement reimbursements**, but excluding lottery funds and **other** federal funds, collected or received by [_____] **department**.

Limits biennial expenditures by [_____] **department** from federal funds.

Declares emergency, effective July 1, 2005.

A BILL FOR AN ACT

2 Relating to state financial administration; appropriating money; limiting expenditures; and declaring
3 an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Oregon Military Department, for the biennium**
6 **beginning July 1, 2005, out of the General Fund, the following amounts for the following**
7 **purposes:**

- 8 (1) **Administration..... \$ 3,742,095**
- 9 (2) **Operations..... \$ 10,412,484**
- 10 (3) **Community Support..... \$ 552,656**
- 11 (4) **Debt Service..... \$ 921,911**

12 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
13 **are established for the biennium beginning July 1, 2005, as the maximum limits for payment**
14 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and re-**
15 **imbursements from federal service agreements, but excluding lottery funds and federal funds**
16 **not described in this section, collected or received by the Oregon Military Department for**
17 **the following purposes:**

- 18 (1) **Administration..... \$ 1,229,537**
- 19 (2) **Operations..... \$ 3,157,997**
- 20 (3) **Community Support..... \$ 1,670,351**
- 21 (4) **Debt Service..... \$ 109,260**

22 **SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts**
23 **are established for the biennium beginning July 1, 2005, as the maximum limits for payment**
24 **of expenses from federal funds, other than those described in section 2 of this 2005 Act,**
25 **collected or received by the Oregon Military Department for the following purposes:**

1 **(1) Operations..... \$ 57,856,550**

2 **(2) Community Support..... \$ 4,469,915**

3 **SECTION 4. This 2005 Act being necessary for the immediate preservation of the public**
4 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**
5 **on July 1, 2005.**
