

A-Engrossed Senate Bill 5616

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to [_____] **State Department of Fish and Wildlife** for **certain** biennial expenses.

Limits **certain** biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by [_____] **department**.

Limits biennial expenditures by department of lottery moneys from Parks and Natural Resources Fund.

Limits biennial expenditures by [_____] **department** from federal funds.
Declares emergency, effective July 1, 2005.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the State Department of Fish and Wildlife, for the**
6 **biennium beginning July 1, 2005, out of the General Fund, the following amounts for the fol-**
7 **lowing purposes:**

- 10 (b) **Fish natural production** \$ **726,342**
- 11 (c) **Fish marine resources** \$ **1,653,050**
- 12 (d) **Fish interjurisdictional**

- 14 (2) **Wildlife Division:**
- 15 (a) **Wildlife game** \$ **265,283**
- 16 (b) **Wildlife habitat** \$ **317,021**
- 17 (c) **Wildlife diversity.....** \$ **875,007**
- 18 (3) **Administrative Division** \$ **933,520**
- 19 (4) **Capital improvement.....** \$ **208,751**

20 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
21 **are established for the biennium beginning July 1, 2005, as the maximum limits for payment**
22 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
23 **cluding lottery funds and federal funds, collected or received by the State Department of Fish**
24 **and Wildlife, for the following purposes:**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
 16 **\$7,035,026 is established for the biennium beginning July 1, 2005, as the maximum limit for**
 17 **payment of expenses from lottery moneys allocated from the Parks and Natural Resources**
 18 **Fund to the State Department of Fish and Wildlife, for activities and projects to implement**
 19 **section 4 (10), Article XV of the Oregon Constitution.**

20 **SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts**
 21 **are established for the biennium beginning July 1, 2005, as the maximum limits for payment**
 22 **of expenses from federal funds collected or received by the State Department of Fish and**
 23 **Wildlife, for the following purposes:**

35 **SECTION 5. This 2005 Act being necessary for the immediate preservation of the public**
 36 **peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect**
 37 **July 1, 2005.**
