SUMMARY

Approves certain new or increased fees adopted by Occupational Therapy Licensing Board, State Mortuary and Cemetery Board and State Board of Pharmacy.
Declares emergency, effective July 1, 2005.

2 Relating to state financial administration; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the**
5 **following new or increased fees, adopted by the Occupational Therapy Licensing Board and**
6 **approved by the Oregon Department of Administrative Services, are approved:**

- 7 (1) **Initial occupational**
- 8 **therapist license..... \$85/year**
- 9 (2) **Renewal of occupational**
- 10 **therapist license..... \$100/year**
- 11 (3) **Initial occupational**
- 12 **therapist, out of state..... \$120**
- 13 (4) **Initial occupational therapy**
- 14 **assistant, out of state..... \$80**

15 **SECTION 2. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the**
16 **following new or increased fees, adopted by the State Mortuary and Cemetery Board and**
17 **approved by the Oregon Department of Administrative Services, are approved:**

- 18 (1) **Funeral establishment**
- 19 **license renewal..... \$350/year**
- 20 (2) **Immediate disposition**
- 21 **company license renewal \$350/year**
- 22 (3) **Crematory license renewal ... \$100/year**
- 23 **plus \$2/cremation**
- 24 (4) **Cemetery license renewal \$4/interment**
- 25 (5) **Licensed facility location**

21 **SECTION 4.** This 2005 Act being necessary for the immediate preservation of the public
22 peace, health and safety, an emergency is declared to exist, and this 2005 Act takes effect
23 July 1, 2005.
